## **Manager's Minutes**

## A BREAKDOWN OF COSTS AND HOW YOUR ANNUAL ASSESSMENT IS SPENT

The Recreation District Tax, also known as a special assessment, is a fee that every homeowner located within the Bayshore Gardens District pays for the operation of the District per the Charter, which is the governing document of Bayshore Gardens. This assessment is paid annually with your real estate taxes and is currently \$367. The total annual income to the District from this fee is \$535,262 less \$15,590 which is a 3% fee payable to the County for their fee collection services leaves \$519,672. The payroll for 5 year-round employees and seasonal pool employees is \$305,000 which includes \$55,000 payroll taxes and worker's compensation fees. This leaves \$214,672.00 from the assessment to operate the District. In addition to the above noted costs, the District pays an annual insurance premium of \$41,313. Utility costs (electric, water, garbage, dumpsters) are roughly \$21,000 and chlorine yearround for the pool is approximately \$18,000. Deducting the insurance/utility costs -\$80,313 from \$214,672 now leaves \$134,359 for operational expenses for a year. Out of the remaining funds, equipment must be maintained along with cleaning and office supplies purchased.

The published 2019-2020 budget carried over reserve funds in the amount of \$1,313,393.43 which funded the ramp repair, marina and hall renovation projects. The marina renovation, slated to be completed in January 2020, has been one of the largest and most expensive projects undertaken. The majority of money for the marina came from a reserve account which has been built up over the years. The fees collected for usage of the marina and hall are being appropriated to make these areas self-funding and build reserves for future repairs/renovations.

The rental fees for residents are discounted due to the annual assessment paid by all residents. Bayshore Gardens has a very low annual fee in comparison to other Special District in the vicinity.

#### **Special Districts Annual Assessments:**

The other Special Taxing Districts charge their residents for use of amenities as well.

Bayshore Gardens will spend approximately 1.5 million dollars on renovations and has managed to do so without raising the assessment, and with an assessment 1/3 of other Special Districts. From inception of the Special Taxing District in 1979 when the annual assessment was approximately \$25.00, the fee has not risen with inflation, currently 2.1% per the U.S. Labor Department, nor the cost of living. Likewise, in comparison to other Districts in our area, our annual fee is 1/3 of what they charge their residents.

Those who use the marina and hall pay nominal fees to offset significant increases in the annual assessment that affect all residents. The fairness in this system is that those who utilize the marina and recreation hall, pay a nominal fee which keeps the annual assessment low for all residents. Those who do not use the hall or marina are not penalized with large assessment increases to cover these areas. Rather, the hall and marina self-fund themselves from the fees generated for use and are assisting in establishing reserve funds for maintenance of these areas and build future funds for repairs and/or improvements.

Ultimately, we all win in terms of higher property values when the District is properly maintained and improved. Homes listed for sale in Bayshore Gardens, highlight the pool, marina, recreation hall and the park that offers Sarasota Bayfront views. These amenities add contributory value to the market value of a home, as it is an inherent right of ownership in the community. Other area communities who offer anything close to the Bayshore amenities, are typically condominiums who pay a monthly fee comparable to our annual fee.

## **Manager's Minutes Continued**

Although there's been a recent increase in access to the boat ramp from \$40 to \$80 for annual use, the rate remains very reasonable for a new and improved boat ramp with a cost of \$296,869.20. The county is currently reviewing daily parking rates for public ramps at a cost of \$6 per day. Bayshore Gardens rate of \$80 would get you access to a public ramp 13 times a year if this proposed fee is passed. County access for 365 days a year would be \$2,190! Unlimited annual access 24/7 in comparison is a great deal.

Unfortunately, rising costs seem to be a part of life. From a gallon of gas to a loaf of bread, what has not increased over the past decade? The volunteers on the Board of Trustees have managed the funds of the District well.

Once you are certified in the Stop the Bleeding class, you will be qualified to teach the class.

#### **CERT VOLUNTEERS NEEDED**

Our CERT program in Bayshore is new to us and growing and we welcome new CERT members that have been certified by taking the Manatee County FEMA training. You are trained to keep yourself safe while you complete search and rescue, light firefighting, first aid/CPR and damage assessment.

Hurricane Irma has taught all of us a lot about being prepared. We will be working much closer with Cedar Hammock Fire and Rescue and Manatee County Sheriff's Dept. to insure the safety of our CERT members and our community. Manatee County is the sponsor of the County-wide CERT program and is charged by FEMA with training our CERT members. Emergency Management and the Fire Departments have realized the importance of those extra trained hands in an emergency and the CERT training classes are filling up within 24 hours of posting notice of the class, leaving our new volunteers out of the classes.

Your CERT members are kept informed of the progress of setting class schedules and the registration process and can assist you in registration and acceptance into the class. Email originaltr@cs.com or call 941-752-7421 for more information.

The time commitment to CERT is minimal once you are trained. We meet once a month, with a short training FEMA film and a business meeting. Drills are held for training purposes. We also offer First Aid and CPR classes for our members. These classes are optional.

Our CERT program is working with the County to establish the CERT Coalition of Manatee County. This effort will put the Teams, Sheriff's Dept, and Fire Depts. together to serve the total community where and when needed. This is a real win for those of us who live close to the water.

# Manatee Matters with Commissioner Misty Servia

#### Reflecting on 2019

The year 2019 is coming to an end as I write, and as a goalsetter, I like to look back and think about the things I am most proud of and what I could have handled better. Every year it is hard to take time to give these things the proper reflection, as my life moves at a pace that sometimes feels like the speed of light, but each year I silently remind myself of the importance of finding some quiet time to reflect. Because, while we move forward each day with the best intentions, life can only be understood when we think about it in hindsight. As I reflect on my first year as a County Commissioner, I realize I have learned a lot, and there are two things that stand out: 1. Listening is more important than talking, and 2. keeping emotions in check is easy if you don't take things personally. Being an elected official allows me to interact with many people, and some come to me with a problem or complaint. Sometimes their problem makes them angry and difficult, which can naturally place me on the defense. But each time I am reminded to take a breath, refocus my perspective, and to try and understand what they are feeling. I have come to realize this past year more than ever before, the importance of understanding other perspectives. I've found that when you try to understand each other, it is easier to bring compassion to the discussion rather than judgment. And if you didn't already guess, being on the commission can sometimes feel like a crazy roller coaster, but I've learned that being open to other ideas is how we build paths to walk together instead of putting up walls that stop us dead in our tracks. I am proud of what I, along with your help, accomplished as a commissioner in 2019. Here are some highlights: 1. The creation of the District 4 Citizens Coalition on Growth, to add more voices to the discussion of how our community should grow. This was a campaign promise that was my first priority. 2. Adoption of the public safety ordinance was a big win, which will not only reduce panhandling, but hopefully reduce the number of pedestrian fatalities on our roadways. 3. Our Board unanimously supported the adoption of a massage parlor ordinance in an effort to eliminate nuisance businesses that are straining our resources and contributing to human trafficking in our community. 4. Many residents in Pride Park will soon receive surveillance doorbells thanks to Ring.com in an effort to increase safety, and our Sheriff's Office has taken a lead role in this effort.



Looking ahead, I am excited to work with our Code Enforcement Department and our major landlords in 2020 in an effort to develop a program together to foster community pride in our neighborhoods.I believe that one of the keys to making sense of all of our relationships is to continue to expand our perspective from "how I feel" to "how others feel." This shift removes the narrow blinders of our comfortable view, and widens our vision, sometimes to an uncomfortable place. Whether my role is a county commissioner, a mother, and even a spouse or friend, this shift has helped me when seeking to understand others. As we begin the year 2020, I pray we can all take some time to savor the joys and sorrows of the past year and open our minds to the opinions of others as we build our future. And while we think about what is important, let us also broaden those thoughts to consider what is important not only to ourselves, but to our family, coworkers, and our community. Let's make 2020 the best year yet!
