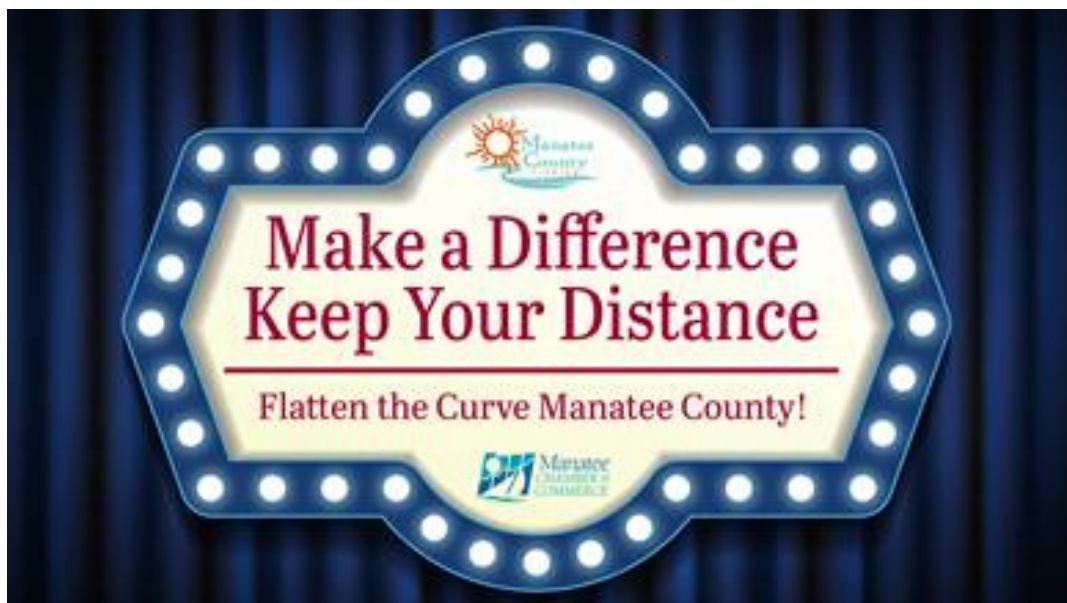

Note from the Chair:

With all the activity around the COVID-19, there is a lot of fear and uncertainty, so I wanted to share some positive information for our community. There is a lot of excitement in the district with the improvements happening. Property values are going up, homes are selling for more than listing price, and county leaders are taking notice and have expressed positive feedback regarding the improvements.

Marina Project: As the marina improvements come to completion, there has been an overwhelmingly positive response from residents and boat owners. Boats are back in the marina, dredging has been completed, fencing is up and electrical is being installed. Many residents and non-residents have stated that they are very impressed with the look and the quality of work that has been done.

Hall Renovations: The work on the hall is not complete, however, again, we've had an overwhelmingly positive response from residents and others on the improvements so far. The doors have been installed and the windows along the back facing the bay have been installed. The windows in the front facing the parking area will be installed soon. The restrooms will be updated next. There is still work to be done. When we have the funds, we would like to update the kitchen and bring it up to code.

Screen Room: The referendum for the screen room extension passed. Since the roof needs to be replaced, the intent is to extend the room to make it larger, raise the roof enough to enhance the view of the bay, while still maintaining a slight incline for water runoff. When the time comes, an RFP will go out to obtain bids for the concrete floor extension (twice as wide as current floor space), screen structure/screen replacement for expanded space, and roof replacement. The screen room is for residents to enjoy for district and/or club events as well as private parties. Non-residents cannot rent the screen room for private parties.

Pool: We definitely have the restrooms/shower upgrades on our radar. We will be working on how to get these improvements done as soon as possible. Other suggestions from residents was to heat the pool so that it can be open all year round. We intend to explore options and cost. We are also exploring options for pool inflatables, such as a pool obstacle course for kids to enjoy. We had hoped to open the pool soon if the weather permitted, however, due to the COVID-19 precautions, the pool will be closed until we can assess the safety of our residents and their families. We will follow the CDC's recommendations.

Beach/Playground/Picnic Area: As many of you know, the gate has been locked due to drug activity, sexual activity and property damage issues. No one has been denied access to the playground/picnic area or the beach, there is a sidewalk leading to that area and handicap access is still available.

There are many other projects to tackle, as well as district business. Other project ideas (not yet approved) include: resurface basketball court, picnic area improvements, screen over playground area, walking path around the park, as well as other ideas that have come from residents. Unfortunately, we cannot do everything at once. All of these projects require money, time for notifications/RFPs, bids, board review and approval. This all takes time. We value your input. Please feel free to email any board member with your ideas and/or concerns.

We hope this pandemic can be resolved sooner than later. We want everyone to be safe and stay healthy. We look forward to the time when we can gather together again for community activities. Bayshore Gardens is a great place to live. Working together as a community only makes it better. Thank you for all your support.

CERT - (Community Emergency Response Team)

Hurricane season is almost here. The Hurricane Expo sponsored by Manatee County Emergency Management was a great success and well attended by the public. Information was presented in the form of speakers as well as booths offering a wide variety of goods and services. We hope you were able to take attend the Expo and gather the information that could save your life and your property. Many great gifts were awarded those attending.

CERT is currently in its first session of the HAM radio licensing classes. Another session will be scheduled possibly in June, if you have an interest, please contact CERT for your reservation to become a licensed HAM radio operator. In an emergency, HAM radios maybe the only source you have to get help from fire, police or other agencies. You do not have to be a certified CERT member to become a HAM radio operator in an emergency. HAM licensing classes are free.

The county is planning its next CERT training class and Bayshore Gardens needs volunteers to assist in a disaster. If you have an interest in serving your community with the other first responders, please contact a CERT member or use the contact information at the end of this article. The classes take about twenty four hours of your time and are broken down into about three hour increments. Once certified, your certification is recognized nationwide and the commitment monthly is minimal, usually one meeting a month where we view a short training FEMA film followed by a brief business meeting. It is not mandatory that you attend every meeting. We offer additional training to our members in the form of CPR and First Aid classes.

CERT works with the Emergency Management and the Manatee County Sheriff's Dept to bring programs to the communities such as Stop the Bleed, Active Shooter and more.

If you are interested in one of these programs, let a CERT member know or use contact information at the end of this article.

Our CERT program is working with the County to establish the CERT Coalition of Manatee County. This effort will put the Teams, Sheriff's Dept, and Fire Departments together to serve the total community where and when needed. This is a real win for those of us who live close to the water.

Manatee Matters with Commissioner Misty Servia

The Best Way Through This Pandemic is Together

How quickly life can change. This time last month I was in Tallahassee with other Manatee commissioners to share our county's priorities with our legislators. We crammed into small offices and brushed shoulders with others in the crowded Capitol hallways as we rushed between meetings. And yes, we all knew about COVID-19 last month, but most Americans viewed it as just another virus that was attacking other parts of the world. Why did we feel exempt from the threat? I'm not sure, but it should come as no surprise that we soon found we were not cocooned in our entitlement.

Today I write this blog from my one-bedroom apartment that I share with my husband, my brother, and our 4 cats while we wait to close on a house. Life is good. After all, I used to fantasize about staying home from work, sitting in the A/C and watching movies all day. And now I can, but like most fantasies, it's not as great as I imagined.

While washing clothes in the community laundry today, I asked my neighbors how they are doing. Most replied with, "I'm good", but the weight of the corona virus is evident. I spoke with an older gentleman who was waiting to use a washer that was .25 cheaper than one that was available. I felt the stress of the single-mom who told me she struggled to support her kids with a job and is now unemployed and scared. And there was the guy who didn't speak English, but I could tell that he too was plagued with worry.

One thing is for sure; the numbers don't lie and it looks like we are on a trajectory that will get worse before it gets better. So what can we do while practicing social distancing? There are many things.

Start by checking on your neighbors and ask if they are okay. Reach out to elderly friends and ask if you can do a load of laundry or pick-up their prescriptions. Order take-out food from your favorite local restaurants, as these employees and businesses are

really hurting and need our support to make it through this time. The owner of one of my favorite restaurants told me that he has 30 employees out of work. Take a long walk every day and clear your head - now this is therapeutic! Get some culture. Did you know the Metropolitan Opera is streaming nightly and many museums are offering virtual tours? Pray. And stay home, but for essential trips. It doesn't matter how strong and healthy you are, as you could be spreading the virus to our most vulnerable citizens and not even know it.

I am proud to tell you that Manatee County has a tremendous leadership team and our Emergency Operations Center is partially activated and staffed with our best personnel. There are people working around the clock to reflect on where we have been and predict where we are going in order to forge a path for everyone to remain safe during this crisis. It's business as usual at Port Manatee where ships and trucks are delivering supplies, and there is daily coordination with our state and national leaders too.

But most of all during this time, let's vow to set venomous political arguments aside until we are on the other side of this pandemic. Better yet, let them die altogether. This is not a time to assign blame or to continue petty and childish exchanges. Now is the time that we can all work to be the opposite of self-righteous and open our hearts to those who are struggling. This pandemic is undoubtedly the greatest global crisis of our lifetime, and I believe the power of the human spirit is our only sure way through this nightmare. We must cooperate, share, and learn together.

Where will we find ourselves next month? I don't know, but one thing I do know is that this too shall pass, and the only way we can overcome this extraordinary challenge is by working together.
