
Channel 7 Let the Bayshore Gardens Secret Out April 4 on 6:00 pm News!!

Roll: Dan Rawlinson, Holly Clouse, Kathy Lokos, Debbie Korell, Maynard Boyce, Richard Nelson, Terry Zimmerly and Vickie Ford.

A quorum was established.

Present: Joanne Manse, Steve Watkins, Suzanna Young, Adam Hange, John Woodruff, Ross Mathis and Howard Taylor.

Holly made a motion to approve the March minutes. Debbie seconded. Motion passed.

Holly made a motion to approve the March financials. Terry seconded. Motion Passed.

BGNA: **Steve Watkins for Dan Rawlinson**

Steve stated the meeting on April 14th was a good turn out with one new member signing up. A suggestion was made that homeowners put a little sign up in the front yard suggesting drivers to slow down. One of the homeowners on 26th Street has done this and it seems to be helping. Joanne reported the district made \$39.00 from goods sold at the attic sale. Crime Watch bought

\$30.00 worth of office supplies and one of the manufacturer dated March 16, 2016. Holly made The regular meeting of the Board of Trustees of large filing cabinets. Notice was sent to the owner of the delinquent boar that the boat will be auctioned off on May 31st if payment in full is not received by that day. We still have 10 unpaid boat slip spaces and three unpaid trailer spaces. Late fees have now been added on. All the pool repairs have been done. The cost for the water to refill the pool is \$255.00.

Kathy suggested we have wrist bands for the budget meeting. If there is a second vote the wrist band will have a hole punch indicating this is a second vote. MARINA: Richard Nelson/Debbie Korell

Richard has information on Coastal Engineers who is the engineer for our marina. Debbie stated Coastal Engineers has begun analyzing the center pier. When this is complete a meeting will be set up between the board and Coastal to go over their findings, then the next task will be performed. Richard stated we have 36 stands at the boat work area. There are only one or two heads that are missing and four that need repaired.

Maynard stated Superior has started the paving on 26th street. Maynard presented a quote from Superior to resurface our parking lot. The cost is \$37,035.00 to do the parking lot and the beach access road. This is a savings of over \$20,000.00 because all the equipment to do the work is already here. Debbie made a motion to approve the contract from Superior Asphalt to resurface our parking lot and to include the cost of permits. Terry seconded. Motion passed. Seven to one. Maynard asked for a motion to install the Aqua Deluxe Slide. The motion will read The Aqua Deluxe Slide shall be installed per the manufacture's recommendation of a 4" exit overhang of the pool wall as described in the letter from the

the motion. Richard seconded. Motion passed. Vicky asked that we contact our insurance company for liability issues by having volunteers put the slide together. Maynard presented another motion to be made for swim lessons.

A handful of board members denied his request. Steve made a motion to give Maynard the \$200 to show solidarity to him, the swim team and the community. Restore Bayshore Reports

Speeding In Our Community, A Serious Issue

"Speeding on a residential street is a sign of disrespect for the residents of that street".

April 11, at 6:30 pm, Restore Bayshore meeting convened. 21 people were in attendance; 17 were residents and 2 were guests from Parkway Villas. Also present were our two guest consultants, Robin DiSabatino, County Commissioner, District 4, and Ogden Clark of Neighborhood Services.

After introducing everyone around, Suzanna turned the meeting over to Maynard Boyce, Infrastructure Chairman.

Ogden Clark reported on County activity in Bayshore Gardens: They are identifying the areas flooded after a storm; condition of storm drains in areas where sidewalks will be and what pipework will need to be done. Wed., April 13, at 2:00 pm, he would be meeting with Public Works.

Update was given on pending 53rd Avenue roadwork from US 41 out to 75th St. W. Road widening of 53rd may well be a positive impact on our streets. Ogden advised us that in the meantime, roadwork could cause traffic problems before the project is finished. Afterwards, flow will be much

better. There was much heated discussion of speeding issues. Richard Nelson suggested a speed sign be placed so people leaving the Rec. Center would be reminded there is speed limit of 20 mph. (he said even 30 mph would be acceptable!)

Jeannette Taylor said that when electronic speed monitors are set up, before the next day only one in 6 lights are working. She called the Sheriff's Dept. to notify them of the problem. She also saw that the speed monitors had little effect on speeding after a few days. (This too she told the Sheriff's Dept.)

Maynard thought that 26th Street W., as well as Florida Blvd. are "minor collectors", which would make them through traffic routes.

A number of suggestions came up such as signage in yards to speeders that "speed on your own street" or, "Pretend this is your street", "children playing" ...etc., etc.; that resident participation would indicate to speeders residents here are watchful of speeding infractions. It would remind them, this is a community, not right-of-way on a thoroughfare.

Holly Clouse suggested thermal paint in cross walks will stand out. This can remind people these aren't high speed throughways, but a street in a community. Discussion ensued on the possibility of petitioning for stop signs in areas that presented dangerous situations.

Ogden said all the problems and dangerous situations our group has identified at the last 2 meetings are being looked at by the County Traffic Management Division. They will be assessing this over the summer.

He reminded us, the Neighborhood Plan adopted in 2001 by our Commissioners at our Rec. Center, helps with planning in our area.

Bayshore Gardens is considered a pilot project by the County. There are 13 infrastructure projects under consideration in our area. He will give us a more complete report on what will be taking place next meeting. (a report was submitted in time for this issue).

Next meeting will be Monday, May 9, 6:30 pm.

Meeting was adjourned at 7:35 pm

A REPORT FROM THE COUNTY

I want to follow up with you all on some of the updates and information I was trying to hunt down this week for Bayshore Gardens.

1. 26th Street West Bike Lanes (South of Florida Blvd to the Rec Center): The project manager believes that the bike lanes cannot be extended south of Florida Blvd. to Bayshore Gardens Rec Center as there was not enough roadway to provide enough space for bike lanes to be striped. The portion from Florida Blvd north to Bayshore Gardens Pkwy will still be getting bike lanes added.

2. 26th Street West Resurfacing Start Date: Monday, April 18. I confirmed with the project manager that the milling and resurfacing will begin on Monday April 18th. He estimates the project will last about 8 days.

3. 53rd Ave West road widening between 43rd

Street West and 75th Street West. Road closures begin approximately June 13, 2016. This is the project that may relieve some of the traffic on Bayshore Gardens Pkwy once complete. There will be a period of time in the summer that the length of the road widening project will be closed to non-emergency vehicle traffic. The tentative start date for that road closure is June 13th, 2016. It is expected to last for up to 3 weeks. This COULD result in more traffic along the Parkway for that time period.

4. FDOT funding for Florida Blvd Sidewalks It was discussed at the meeting on Monday that there might be potential money from FDOT for sidewalks because Florida Blvd is now a through street that can be taken south all the way to Venice. I found additional data that suggested Florida Blvd was mistaken for Bayshore Gardens

Old Business: Steve said that the spaghetti dinner was cancelled and will not take place until the rec hall kitchen is upgraded to the correct configuration to allow food to be cooked on the stove tops. Steve suggested an alternative plan.

New Business: The alternative plan is to have another Attic Sale before October. Steve said many of the sellers want to have another sale and

that we have a large donation for the rec center's HD Smart TV coming soon. Dan stated that he would like to try and have the spaghetti

dinner. Other events were discussed but a consensus could not be made. Dan elaborated on how much work was involved to prepare for the sale, the lack of volunteers to help and that hosting the event two times a year was doable. We will discuss this issue again at the May meeting.

• Steve said that the Attic Sale was a great success. With 57 tables inside and 31 spaces outside there was something for everyone. Items left by the vendors inside after the sale were donated to the Congregational UCC (Church) Thrift Store and to Goodwill. Steve produced the donation receipts at the meeting. The Hold Harmless Agreements signed by the vendors will be stored in the crime watch room until year's end when they will expire. PLEASE JOIN US -VERTICAL GARDENING

Hopefully some year-round Garden Club members can attend one of the tours to get ideas for the planting vegetables project planned for September at Bayshore Gardens.

The April meeting was another entertaining presentation by Gary Adams from The Plant Place, 6611 14th St. West, Bradenton. Gary started with the difference between dirt and soil, dirt is dead and soil is alive with organic matter. Plants consume organic matter. Sod fertilized with chemicals will last 7 years but fertilized with organic matter will last forever. There are microbes, bacteria, and fungus. Microbes eat sugar and plants trade sugar for nutrients. The top 5 inches of soil are the most important. For a healthy lawn, spread compost and water it in, then spray worm castings tea and water it in. Also spray worm castings tea on plants to combat any infestations and leave on the plants. An acre rich in microbes can produce 3000 lbs of soil in one year. One caution is that worm castings tea can be fatal to cats if consumed or sprayed.

Elaine Ingram is considered the mastermind of microbes and is the source for the book "Teaming with Microbes" by Jeff Lowenfels and Wayne Lewis.

After microbes have been introduced then they must be fed. The natural nitrogen and phosphorus in high quality chicken poo from chickens fed a high quality diet with calcium is the best for feeding grass and plants that feed the microbes. Vegetable taste and flower color are due to minerals. Tomatoes, which are perennials, must build up sugar when ripe. So feed the microbes by feeding the grass/plants with chicken poo that has been sprinkled and watered in. Or better yet, start out with watering in chicken poo, then spread compost, and spray with worm tea.

BAYSHORE GARDENS MARINA COMMITTEE MANAGEMENT OF THE NEW MARINA PROJECTS

The Bayshore Gardens Marina has accumulated, over the years, some serious maintenance issues that are now to the point that the marina is going to require some major maintenance corrections.

A. There are about 32 finger piers that are in serious disrepair and in need of replacement; - this is a serious safety issue.

B. The marina basin has accumulated about 2 to 3 feet of heavy sludge, which is not only a safety issue, but also provides impediments for the free movement of boats. - Removal of this sludge is going to require some form of dredging.

C. The Boat Launching Ramp has some damage below the water line and is showing damage near the apex of the ramp. This is going to require some form of repair and/or replacement.

The B.G Marina Committee headed by Richard Nelson has recommended that the Board of Trustees approve funds to hire a competent Engineering firm to assess the marina issues and to make recommendations and suggest options to correct these issues.

The Engineering firm chosen is Coastal Engineering Consultants Inc. out of Naples, Florida. - A very competent and successful company - This recommendation was approved by the Board of Trustees

In the past, many of the marina projects were ill conceived and poorly managed at an extremely high financial burden on the district.

EXAMPLES:

- o Moving the really solid center pier 12 feet south to one that is ready to float away;
- o Approving a breaking wave seawall cap for the entire Marina at great expense.
- o Forgetting that we needed electrical outlets, water outlets, and tie-down cleats for each slip; then spending huge sums of cash to correct these oversights.

Each one of these blunders was the result of the folks in B.G. convincing the Board that these projects could be accomplished by management and decisions within the Bayshore Gardens area of expertise. - Big Mistake

These poor decisions by the Board of Trustees are examples of what NOT to do, and a lesson on how NOT to spend taxpayer funds for extravagant and unnecessary projects. - We are now paying the price for these oversights.

One of the more ill-conceived issues going around for this new project, is to widen the slip finger piers, and to widen the slips.

There are some serious consequences by doing this: -

- First of all it would reduce the number of available slins
- More importantly, it would mis-align the new

slips with the existing electric and water kiosks, (One could argue that they are already misaligned)

- This would also require a complete removal and replacement of all of the 125+ tie- down cleats on the seawall cap.
- This would also require removal and re-location of each slip's outer pilings.

I want us to be in a position to avoid these kind of blunders with these new projects.

The new marina improvement project can be accomplished with sound information, good communication, and sound decisions, based on choosing the best cost effective options.

To insure that the new projects are going to be affordable and successful, we need to have someone with a sound knowledge of marina issues; (i.e. what works and what doesn't work) to be in constant contact with Coastal Engineering on a daily basis to discuss options and costs.

This is going to involve a constant dialog on an Engineering level of suggestions, options and costs. Therefore this spokesperson should have a sound knowledge of our marina issues and how to fix them.

As a response to this requirement the Marina committee chairman has chosen a spokesperson who has absolutely no boating experience, does not understand marina issues, and has no engineering background.

When I asked this spokesperson what her duties were, this was her response:

(Quote) "I am the liaison between Coastal and the Board. Who is the 'spokesperson'... We do not have a person with that title. As the liaison, I do not make decisions. Coastal asked if anyone had any documents relating to the center pier. I forwarded the message to Joanne and her forward the request to the board My job as liaison is simply to bring Coastal's questions and answers to the board and vice versa. "I do not need to be a expert to ferry messages". "There was never an agreement made that every time Coastal was onsite it would be instantly reported to the board and committee. I don't even know when they are coming before they come. I might have a general range...we plan to be onsite early next week for field work...

We have had no discussions to begin the conversation as to what we want our 'new' marina to look like. We have not yet received any reports back from Coastal detailing what they have found in their fieldwork". "Are you implying I do not have the proper qualifications because I am not wealthy enough to own a boat?" (End of Quote)

MY RESPONSE TO THIS:

If all we need is someone to ferry messages, we can hire carrier pigeons; that is not what is required for this job to be successful

AND this has absolutely nothing to do with wealth or boats; - it has everything to do with engineering, knowledge, and experience and intellegent dialog with the Engineers.

The appointed "Liaison" representing the Marina Committee has none of these attributes.

NOTE: This is absolutely not meant to be a personal put-down; - it is a requirement for this job to be successful.

Coastal Engineering is doing preliminary fieldwork, evaluating the current status of the marina, yet we have not yet had our first meeting with Coastal folks.

Richard Nelson has openly stated that anyone that attends the Marina committee meetings is automatically a member of the committee, (This a very strange way to maintain an effective committee), however this membership requirement does not seem to apply in my case; - I have been attending nearly all marina committee meetings, and my membership has been nixed.

I have contributed more effort with successful results to the BG Marina improvements than anyone else on the Board of Trustees, yet I am being shunned from my offer for help by the absentee Marina Committee Chairman.

This seems to be a personal vendetta by Mr. Nelson at the expense of assuring a successful conclusion of the marina projects.

IN CONCLUSION:

The most important and expensive B.G. marina improvement project in decades is being mis-managed by a Marina Committee Chairman, who has no dog in the fight, and has chosen to manage by avoidance. (NOTE: This is the easiest and most popular management technique, requiring very little effort and no commitments)

This lack of involvement is evidenced by Nelson appointing a complete novice to be the major liaison "to ferry messages" between the Bayshore Gardens Marina Committee and a very expensive Engineering Consultant. -This kind of project mismanagement is headed toward a train wreck.

I have made it known to all, that I am available to help put this project into a direction where success is the major objective. I am very concerned that this objective is not clear.

I know of no one more qualified to do this "Liaison" work than myself. - I have had sail boats in this marina continuously since 1976, and I am a graduate Electrical and Mechanical Engineer and have been managing a leading industrial water treatment design and manufacturing company in Sarasota/Bradenton since 1985.

This kinda sums up where our taxes and excessive slip rent is being spent.

So here we are, locked into a contented state of apathy, while hoping that somehow, this project will turn out better than our past record of blunders.

OH WELL!, It ain't my job, so who cares? Respectfully, Howard Taylor.

Is My Lawn Looking Grubby? By Joy Derksen, Master Gardener 2004

Summer is fast coming upon us, and this being Florida, we have another bug -in-the-lawn problem to worry about. Grubs are larvae of Beetles all kinds of scarab beetles (masked chafer, sugarcane beetles, May/June beetles, green June beetles, and flower beetles). You've probably been buzzed by these beetles at night under the lights.

The beetles lay their eggs in wet soil and tiny grubs hatch out. The tiny grubs eat the roots of lawn grass and grow bigger. This damage to the roots makes the grass unable to take up nutrients or water. As a result the grass will look underfed and eventually dried out. The grass slowly thins, yellows and dies. With few roots to anchor it, the grass can easily be pulled out of the ground.

You can also observe natural predators of the grubs. Moles will be tunneling in your lawn, armadillos will be rooting up the grass, and flocks of ibis will be poking their curved beaks into the soil. In summer and fall, parasitic wasps can be seen circling at grass level seeking grub prey.

To be sure if your lawn has grubs, you need to dig down about three inches where the grass roots and the grubs live. You are looking for creamy white, C-shaped beetle larvae from ¼ inch to 2 inches in length. To find an occasional grub is normal. A lawn is considered infested when there are more than five grubs in a square foot of lawn area.

Now that you know there are grubs, what can you

do? There are a variety of methods for treating grubs. One method for controlling grubs is the introduction of parasitic nematodes *Heterorhabditis* spp. and Steinernema carpocapsae. Because nematodes are living creatures, you must carefully follow directions if you use them.

Chemical controls include the imidacloprids (Merit, for example), which are best used in July and August. If you had grubs in your lawn last year, you might want to use a preventative program this year. Professional applications combine a pyrethrin with imidacloprid for control of both adults and larvae.

Gotta Love Luffa!!

Unlike what you may have been told as a child, luffa sponges (also spelled "loofah") do NOT come from the ocean. This popular fixture of bath and spa is actually a gourd from the same family as squash and cucumbers. And we Floridians, with our long growing season and warm temperatures have the perfect environment for growing them.

Smooth luffas (Luffa aegyptica Mill syn L. cylindrical) are very vigorous annual vines reaching lengths of 15-30 feet; its gourds can grow as long as 2 feet and weigh as much as 3 pounds! They are grown mainly for their fibrous tissue used as a sponge (they make great 'homemade' gifts). They are biodegradable, renewable, and can be tossed in your washing machine. When less than 7 inches, they are also used like squash and cucumbers in cooking.

After danger of frost, sow seeds 8-12 inches apart in full sun, along a fence or strong trellis where the vines will attach with tendrils. Seeds may be started in small pots, but seedlings do not transplant well, so great care must be taken with roots. A single plant may also be grown in a 5-gallon container where sturdy support for the vine is provided. Seeds may be scraped or soaked overnight to hasten germination. Be patient,


seeds can take up to two weeks to sprout.

Follow similar moisture and fertilizer recommendations as for squash and cucumbers, and like squash and cukes, it's best to keep the vines and fruit off the ground to protect from rotting. You can expect to start harvesting gourds for sponges in about 4 months.

If growing for sponges, allow the gourds to ripen on the vines, and harvest only when they have turned yellow or brown, feel lighter, and are dried. There are a couple methods for making sponges. Cut the gourd from the vine, allow to dry for a few days, and when the skin is hardened, cut open the larger end, and shake out and save the dried seeds. Soak the luffa overnight in warm water, peel off the skin, and allow to dry. Another method is to soak the ripe gourd in water a few days until the skin easily comes off. Rinse out the inside and dry.

Evaluate Your Irrigation System

Although the MILs originally targeted agricultural water use, they also assist residential and commercial water users. Landscapes, nurseries, and golf courses have benefited greatly from the advice and education provided by the MILs. In addition to providing recommendations on irrigation system improvements, some MILs assist farmers by identifying water quality improvement opportunities available through Best Management


Practices (BMPs).

Since 2004, Agricultural MILs have conducted more than 8,400 evaluations on more than 335,000 acres of land, resulting in water savings of more than 13 billion gallons of water a year, with the potential to save more than 31 billion gallons a year if all their evaluation recommendations were implemented. The cost to conserve water through MIL services is very competitive when compared to the costs to develop new sources of water.



One Pot / One Skillet Meals

Mexican Beef and Rice Skillet

- 1 lb lean (at least 80%) ground beef
- 1 cup diced onion; 1 1/4 cups water
- 1 package taco seasoning mix
- 1 can fire roasted diced tomatoes, undrained
- 1 can (4.5 oz) chopped green chiles
- 1 1/2 cups uncooked instant white rice
- 2 cups shredded Mexican cheese blend
- 1/3 cup diced avocado;
- 2 tbsp chopped cilantro

In 12-inch skillet, cook beef and onion over med-hi heat, stirring occasionally, until brown. Stir in water and taco seasoning mix; heat to simmering. Add tomatoes and chiles. Heat to boiling; stir in rice. Boil 1 minute; remove from heat. Cover; let stand 8 minutes. Stir in 1 cup of the cheese. Sprinkle with remaining 1 cup cheese. Cover; let stand 3-5 minutes or until cheese is melted. Top with avocado and cilantro.

Lazy Chicken

- 1 lb chicken breasts, cut into one-inch cubes 2 red potatoes, sliced thinly
- 1 small white onion, thinly sliced
- 1 small zucchini, thinly sliced into disks
- 1-2 tsps steak seasoning; 1 tsp dried oregano 1/2 cup chicken broth
- 1 can fire roasted crushed or diced tomatoes
- 10 basil leaves, coarsely chopped 1/2 cup shredded mozzarella

In an oven safe skillet, season chicken and brown on medium high heat for a couple of minutes. Remove chicken from pan and set aside. Add olive oil to pan. Layer the sliced potatoes and onions in pan and sprinkle with half of steak seasoning. Cook potatoes and onions in a thin layer until brown, turning as little as possible to get a nice sear. Add chicken broth to pan. Spread zucchini in a thin layer on top. Sprinkle with remaining steak seasoning. Place chicken in even layer over zucchini. Pour tomatoes evenly over that. Sprinkle tomatoes with oregano and basil. Cover and cook until veggies and chicken are completely done. Sprinkle with cheese; place under the broiler until cheese melts or starts to brown. Serve right away.

Skillet Rice with Shrimp and Chicken

- 1 cup uncooked long-grain white rice
- 2 cups reduced-sodium chicken broth
- 1 lb boneless, skinless chicken, cut 1" pieces
- 2 1/2 tsps kosher salt, divided
- 1 tsp freshly ground black pepper, divided
- 2 tbsp olive oil; 1/4 tsp ground red pepper 1 small yellow onion, chopped
- 1 green pepper, chopped; 3 thyme sprigs
- 2 garlic cloves, chopped
- 1 cup frozen sliced okra, thawed
- 1/2 lb medium raw shrimp, peeled, deveined
- 3 plum tomatoes, chopped

2 green onions (green parts only), sliced Cook rice according to pkg directions, substituting chicken broth for water and adding thyme sprigs to broth. Spread cooked rice in a thin layer on baking sheet; discard sprigs. Cool completely. Meanwhile, toss together chicken pieces, 2 tsp. kosher salt, and 1/2 tsp. black pepper. Cook chicken in hot oil in a large skillet over medium heatuntil lightly browned. Add yellow onion, green pepper, and garlic, and cook, stirring often, until onion is tender. Increase heat to high. Stir in okra, rice, shrimp, red pepper, salt and black pepper, and cook, stirring constantly, until shrimp are pink and rice is thoroughly heated. Stir in tomatoes, and cook until tomatoes are heated. Remove from heat, sprinkle with sliced green onions. Serve immediately.

One-Pot Pasta with Tomato-Basil Sauce

12 oz casarecce or fusilli pasta

1 can diced tomatoes; 2 cups chicken broth 1/2 medium-size yellow onion, sliced 4 garlic cloves, sliced; 1 tsp dried oregano 1/3 cup firmly packed fresh basil leaves

- 2 tsps kosher salt; 1 tbsp olive oil
- 1 pkg baby spinach

Freshly grated Parmesan cheese

Place all ingredients in a Dutch oven in order of list. Cover, bring to a boil over med-hi heat. Reduce heat to med-low, and cook, covered, until pasta is slightly al dente. Remove from heat, and stir in spinach. Cover, let stand 10 minutes. Stir just before serving. Serve with Parmesan.

Skillet Pork Chops w/ Apples and Onions

- 4 6-8-oz bone-in pork rib chops
- 1 tsp kosher salt
- 2 tbsp olive oil
- 1/2 tsp freshly ground black pepper
- 2 Granny Smith apples, cut in 1/2" wedges 1 medium-sized. yellow onion, thinly sliced (root end intact)
- 1/3 cup chicken broth; 2 tbsp bourbon
- 1 cup whipping cream
- 8 small fresh thyme sprigs
- 1/4 cup Dijon mustard


Preheat oven to 450°. Sprinkle pork with salt and pepper. Cook in hot oil in a 12-inch cast-iron skillet over medium heat 5 to 6 minutes on each side or until golden brown. Remove from skillet. Add apples and onion to skillet; cook, stirring occasionally, 4 to 5 minutes or until browned. Remove from skillet. Add broth to skillet, and cook 1 to 2 minutes, stirring to loosen browned bits from bottom of skillet. Whisk together cream and mustard; add to skillet, and cook, stirring constantly, 1 to 2 minutes or until bubbly. Remove skillet from heat, and stir in bourbon. Add pork, turning to coat, and top with apples, onions, and thyme. Bake at 450 degrees for 10 minutes or until liquid is just beginning to bubble. Let stand in skillet 5 minutes.

Cheesy Potato Nugget Skillet

1 lb lean (at least 80%) ground beef 1 cup nacho cheese sauce (from 15-oz jar) 3/4 cup Green GiantTM frozen sweet peas 1 cup shredded Monterey Jack cheese (4 oz) 1 bag (16 oz) frozen organic crispy golden potatoes

Heat oven to 425°F.

In 10-inch ovenproof skillet, cook beef over medium heat 5 to 7 minutes, stirring occasionally, until no longer pink; drain. Stir in cheese sauce. Layer frozen peas and cheese on top of beef mixture. Top with even layer frozen potatoes. Bake about 25 minutes or until potatoes are crispy and golden brown and mixture is bubbling.





