MINUTES OF MEETING April 17, 2018

The regular meeting of the Board of Trustees of Bayshore Gardens Park and Recreation District was called to order by acting Chairperson Debbie Korell at 7:00 pm and was followed by the Pledge of Allegiance. Notice of the meeting was posted in the March Bayshore Banner.

Roll Call: Steve Watkins, Sharon Denson, Dan Rawlinson, Debbie Korell, Terry Zimmerly, Jim Couey. Barbara Susdorf arrived at 28 minutes into the meeting.

A quorum was established.

Present: Jodie Lawman, Don Gassie, Maynard Boyce, Laurie Boyce, Lenny Cichewicz, Mary Cichewicz, Vic Kasperian, Gwen Norris, Suzanna Young, Richard Nelson, Mike Sheets, Allan Riga, Barbara Greenburg.

As the first order of business, Debbie read the resignation letter of Thom Williams.

After discussion of filling either one or both vacant seats on the board, Terry made a motion to accept 2 people to fill both vacant seats on the Board at tonight's meeting. Dan seconded, **MOTION PASSED, 3 for and 2 against.** Debbie then asked for anyone who is running for Trustee to stand up. Suzanna then expressed interest and was asked to approach the podium. Motion was made by Debbie to elect Suzanna Young to the Board of Trustees. **MOTION PASSED, 4 for and 2 against.**

Debbie asked for election of officers. She then asked if anyone would like for her to resign as Chairperson? Dan said yes. She then resigned as Chairman. Steve nominated Sharon Denson as Chairman. Dan seconded, **MOTION PASSED, 4 for and 2 against.** Sharon asked for nominations for; 1st Vice Chair and Steve nominated Dan Rawlinson. Jim seconded, **MOTION PASSED;** 2nd Vice Chair, Dan nominated Steve and Terry nominated Debbie. Steve was elected 2nd Vice Chair, **4 for and 2 against. Secretary;** Dan nominated Steve. Since Steve is already chair of 2 other committees, Terry made a motion that Steve remain as Secretary until such time as the other 2 trustee seats are filled. Dan seconded, **MOTION PASSED.** Treasurer; Sharon nominated Terry, Dan seconded, **MOTION PASSED.** Upon completion of the election of the officers, Debbie resigned from the Board of Trustees effective immediately. This action left the Marina Committee Chair vacant. Terry said that she would fill the position for one month. Chairman Denson appointed Terry as Marina Chairman.

Sharon then began discussion on the revised bylaws. Steve made a motion to approve the Bayshore Gardens Board of Trustees Bylaws and Jim seconded. After a few comments during a discussion, Sharon called on each Trustee for an up or down vote. All voted in the affirmative, **MOTION PASSED.** Then Barbara made a motion to forward the revised bylaws to the attorney for review. Steve seconded, **MOTION PASSED.** Jodie will forward to the attorney for legal review and opinion.

At this time, Sharon reviewed a portion of the Policies and Procedures that have been worked on in several previous committee meetings. Steve made a motion to approve ID Card Policy 1001P and the ID Card Form 1001F. Jim seconded, **MOTION PASSED.** Sharon called for a motion to approve the Agenda Policy 1002P to include the Agenda Procedure 1002PR and Agenda Form 1002F. Jim made the motion, Terry seconded, **MOTION PASSED** unanimous. Steve made a motion to approve the Meeting Notice Policy 1003P and Meeting Notice Procedure 1003PR, Barbara seconded. **MOTION PASSED, 5 for and 1 against.** Terry made a motion to approve the Hall/Screen Room Contract 1004F, Inspection 1004FI and Procedure 1004PR, Barbara seconded, **MOTION PASSED.** Pool Event Policy 1010P; Jim made a motion to approve the policy, Dan seconded, **MOTION PASSED, 5 for and 1 against.** Steve made a motion to approve the Concession Stand Policy 1015P, Job Description 1015JD and Cash Report 1015F, Jim seconded, **MOTION PASSED.** Hiring Policy 1007P; Jim made a motion to approve, Steve seconded, **MOTION PASSED.**

Sharon then began discussion on joining the Florida Association of Special Districts and reviewed all of the advantages of our District becoming a member. Steve made a motion to join the Florida Association of Special Districts, Barbara seconded. **MOTION PASSED, 5 for and 1 against.**

Terry gave the financial report. Dan made a motion to approve, Steve seconded, **MOTION PASSED.**

Terry made a motion to approve the minutes of the last Board meeting, Steve seconded, **MOTION PASSED.**

Terry made a motion to approve a \$2,500 expenditure for replenishing the playground mulch, Dan seconded, **MOTION PASSED.**

Terry then made a motion based on attorney James Dye's "verbal" opinion to approve all of the exist-

ing policies and procedures in the District office. Chairman Denson then read an attorney's opinion from Blaylock & Walters P.A. reference approving ANY policy in violation with the Florida in the Sunshine Laws. **MOTION FAILED.**

Terry made a motion to move the workshop meeting to the week BEFORE the Board meeting and to have the two committee meetings be held on the first and the fourth week. Steve seconded, **MOTION PASSED.**

MANAGER'S REPORT: Jodie Lawman
Jodie passed out her report at the meeting but did not get to discuss it due to the length of the meeting. She will bring the issues to the next Board meeting.

PERSONNEL & SALARY: Dan Rawlinson
Dan made a motion to terminate Vic Kasperian from his position as Dock Master and hire a replacement to be approved by the Board. Jim seconded the motion, **MOTION PASSED, 4 for and 2 against.** Dan Rawlinson will take over the Dock Master responsibilities until a new dock master is hired and becomes familiar with the job.

HOUSE & GROUNDS: Steve Watkins
The check to pay the design challenge students has been mailed out. On May 17th, the State College of Florida will host a historical review of the Bayshore Gardens subdivision from conception to present day. The material will be displayed on the second floor of the new campus library across from the McNeal Auditorium. The displays will include an original property abstract and several poster boards depicting the early design architecture of the Bayshore Gardens subdivision. The display is expected to last for two weeks.

OLD BUSINESS: No old business.

NEW BUSINESS:

Jodie said that she has found a new lifeguard, Steven Grandolf who has all of the current certifications to work at our pool. Steve Watkins made a motion to hire the new lifeguard, Dan seconded, **MOTION PASSED.**

Terry made a motion to contract the trailer spaces for a 6 month term at \$90 for residents and \$180 for non-residents. Steve seconded, **MOTION PASSED.**

Jim made a motion to adjourn, Terry seconded. Meeting adjourned at 9:37 pm.

Please join us for the meeting on Monday, May 7th at 1 pm. The program is "Fairie Gardening with friends" brought to us by Rosemarie Woodruff. We will meet in the Board Room of the Bayshore Gardens Recreation Center to learn about this unique program title. The hostess for the meeting is Judy Drake.

The program for April, proposed by Marie Young, was a tour of Detweilers Farm Market on University at Lockwood Ridge Road. Thanks to Rosemarie Woodruff for stepping in and requesting a tour guide when we arrived. Our tour guide Aaron did a great job of giving us an excellent tour. Aaron's specialty is produce but he is well versed in all departments at Detweilers.

We started in the produce department and quickly learned that whenever possible the produce is local. One of the most interesting items was Jackfruit. This is the largest fruit that grows on a tree that can get as tall as an oak tree and weigh up to 100 pounds. The jackfruit tree will grow in Florida but it is advisable to keep the tree trimmed so that the heavy fruit can be harvested at lower levels. The fruit around the seeds is the most edible. The jackfruit available at Detweilers weighed about 50 pounds with slices also available for purchase. We got to taste this interesting fruit which has a pineapple coconut flavor and is the inspiration for Juicy Fruit gum.

From produce we moved to the seafood and meat departments where there was a wonderful selection. Next was the bakery with the heavenly smells of fresh bread and cookies and pastries. We got to sample excellent chocolate chip cookies. Then we moved on to the dairy section where raw milk is available along with milk, eggs, and cheese from local farms. There we got to sample local white cheddar cheese. And there are the marvelous rolls and sticks of butter.

Finally we were treated to a complimentary serving of ice cream. Many of us did some grocery shopping during the tour and were very pleased with our purchases. Many thanks to Aaron for a pleasant afternoon tour of Detweilers.

Meeting deferred to speaker. We had Deputy Ralston from Crime Prevention Office. Deputy was present to discuss trending law enforcement issues for our community and surrounding areas. Deputy Ralston has been a deputy with Manatee County for 24 years.

Goal is to get information to the masses. Remove valuables from vehicles and lock car doors. Always.

Get an alarm. Consider cameras. Be the extra eyes and ears for the deputies.

Identity theft is greatest risk of crime. Watch out for these scams:

-Grandparents scam---if they call you something

that you don't use (granny).

-IRS scams---they won't call you.

-Tech support---they claim you have a virus--- don't click the link!!!

-You won! scam---don't fall for it.

Don't answer phone if you don't recognize the phone number. However, don't call that number back, look up the company's phone and call that instead. The scammers are using phone routers, so the number may look legitimate, but it may not be.

Gas pump skimmers---never use your debit card!!! Use only a credit card. These skimmers are now on Bluetooth---it downloads wirelessly for several days' worth of usage at the pump.

Password usage: Keeper-----password vault---- use a different password for each item you need a PW for. There may be a cost for it. Scammers can get your username and use that to decode passwords based on your personal information.

Concern about Equifax breach and Dark Web scam.

Never mail any letters from your home mailbox!!!! Don't use the red flag!!!

Ransomware---western digital passport ----put

everything on that, plug into a computer, download everything and store it in case of a virus.

Craigslist scams too----watch for scammers there. They send you a check, ask for the balance of the check after you cash it, then the check is insufficient funds, and they have the surplus money.

Consider adding a fraud alert to each of your credit cards---they can alert you if used ever based on certain costs that you have set.

Some criminals have written gift card numbers, including scratching the pass code, and they use a system that lets them know when the card is activated. Then, they use the gift card so the gift card recipient receives a gift card with NO money on the card.

TEXT 911 is activated now in Manatee County. If you cannot speak, text address!!!

Safety First – Some common sense marina rules:

Per marina Rule #9, boat slip lessees are to keep premises neat and orderly, maintain good mooring lines and moor boat in a safe manner... All boats must have at least four (4) lines, two (2) bow and two (2) stern. Boats under twenty six (26) feet must have at least 3/8 inch line. Boats above 26 feet must have at least 1/2 inch lines. Boats 33 feet and above must use at least 5/8" lines.

For the safety of all Marina users, please keep all personal belongings off the Marina dock after usage. These items include but limited to cleaning materials, water hoses, electrical extension cords, ... Any items left behind on the docks will be removed by Bayshore Gardens personnel.

Marina Occupancy

A couple of large sail boat slips will be vacating in the month of April making room to two new sail boats. There continues to be a waiting list for larger boats (30+ feet). We still smaller boat slips available if needed. Exact dock slip inventory will be determined in by end of April once all boat slip leases are renewed.

Sunday, May 13 is Mother's Day!

Mother's Day is a holiday honoring motherhood that is observed in different forms throughout the world. The American incarnation of Mother's Day was created by Anna Jarvis in 1908 and became an

official U.S. holiday in 1914. Jarvis would later denounce the holiday's commercialization and spent the latter part of her life trying to remove it from the calendar.

The clearest modern precedent for Mother's Day is the early Christian festival known as

"Mothering Sunday." Over time the Mothering Sunday tradition shifted into a more secular holiday, and children would present their mothers with flowers and other tokens of appreciation. This custom eventually faded in popularity before merging with the American Mother's Day in the 1930s and 1940s.

Pet Ownership and the Law (Excerpts from the Manatee County Animal Services information booklet)

We all love our pets and think...no, we know, they are the most special little critters on earth, otherwise we wouldn't have them. However, not everyone shares our perception. The following are some tips and some hard facts given in County Ordinances that need to be shared so that we can all live in peace and harmony with each other and each other's pets.

Laws Pet Owners Need to Know:

Don't let your dogs or cats roam or run loose. No dog or cat shall be "at large" upon any public property, street or sidewalk, or on private property of another person without the consent of the property owner. Dog parks are the exception.

Any dog or cat that is "at large" or without the consent of another property owner can be captured in a humane trap or confined humanely.

Any cat that is outdoors while not under direct control must be sterilized in order to be exempt from the requirements of Sec.2-4-11(d) of the Ordinances. (working Police dogs are exempt as well as trained--sport or working--dogs actually performing their duties under supervision).

"At Large" means any dog or cat on the owner's premises and not in the control of the owner or custodian; or any dog or cat off the premises and not under the physical control of the owner or custodian. Sec.2-4-11

There are fines for animals at large: 1st Offense: \$200, 2nd Offense: \$350., 3rd Offense: \$500

License Tags are a Must! Animals must have a collar with a rabies Vaccine tag. Dogs and cats must have a current rabies vaccination certificate and wear a tag to evidence this.

All dogs must wear a tag when outside. Other types of ID, such as a microchip or tattoo, are encouraged in case of tag loss or pet is not wearing its tag.

All cats must wear a tag or be micro-shipped. To identify trapped, neutered, and released cats, one ear is slightly nipped.

Of importance is a vaccine for Leptoporosis. This is a highly toxic bacteria from the urine or feces of wild animals. Humans can contract it from their pets.

Nuisance Dogs And Cats, You Have Recourse

Any feces deposited by a dog or cat on public property, public walks, recreation areas, or the private property of others, MUST be immediately removed by the person who has custody or control of the animal unless otherwise authorized by the property owner.

No dog or cat shall materially disturb the peace and quiet or interfere with the enjoyment of life or property by persistent or repetitive barking, yelping, whining, howling, meowing, squealing, screaming, or causing other objectionable noise for a persistent period of time exceeding 10 min-

utes or for a repetitive period of time which cumulatively exceeds 10 minutes within a two hour (120 minute) period of time.

"Causing objectionable noise for a persistent period of time exceeding 10 minutes": A dog that does not want to be outdoors barks, or it barks because it sees a cat or dog next door, or it barks at any movement. This persistent barking may be a violation of this Ordinance.

"Excessive noise for a repetitive period of time which cumulatively exceeds 10 minutes within two hours (120 minutes), period of time." Example: A dog barks for 5 minutes at someone walking nearby, 4 minutes at someone riding their bicycle, 3 minutes at the mailman and 2 minutes at some birds—all within a 120 minute time period—adds up to a total of 14 minutes of barking within the two hour time period. This may be a violation of this Ordinance.

"Nuisance"; means no dog or cat shall disturb the peace and quiet or interfere with the enjoyment of life or property. Sec.2-4-12

Fines for dog or cat disturbing the peace and quiet enjoyment of life and property of another is: 1st Offense, 2nd Offense \$300. And 3rd Offense if \$300.

Mother's Day Brunch Recipes

Egg White Frittata with Lox and Arugula

8 egg whites, at room temperature
 1/2 cup whipping cream
 6 oz lox, chopped into 1/2-inch pieces
 1 lemon, zested; 1/2 tsp kosher salt
 1/2 tsp freshly ground black pepper
 2 tbsp olive oil; 2 packed cups arugula
 1 clove garlic, minced
 Put an oven rack in the center of the oven. Preheat oven to 350F. In a medium bowl, whisk egg whites until fluffy. Add cream, lox, lemon zest, salt, and pepper. In a 10-inch, ovenproof, nonstick skillet, heat oil over medium heat. Add arugula and garlic. Cook, stirring frequently, until arugula has wilted. Pour egg mixture into pan and stir to combine ingredients. Cook, without stirring for 4 minutes. Transfer skillet to oven and bake until set, about 10-12 minutes. Slide frittata onto a platter. Using a serrated knife, cut frittata into wedges and serve warm or at room temperature.

Lemon Tiramisu Trifle

1/4 cup fresh lemon juice
 1/4 cup granulated sugar
 12 oz cream cheese, softened
 8 oz jar prepared lemon curd
 2 cups heavy cream;
 22 hard ladyfinger cookies
 3 cups raspberries, sliced strawberries
 Powdered sugar; whipped cream
 In a small measuring cup, mix lemon juice with sugar and 1/4 cup water until sugar is dissolved. Set aside. Place cream cheese, lemon curd and heavy cream in processor and process until smooth and a bit fluffy. To assemble, place half the ladyfingers in bottom of an 8" square baking dish, breaking a few to fit; drizzle with half of lemon syrup. Top with half lemon cream and 1 cup berries. Repeat layers. Cover with plastic wrap and chill at least 8 hours. Before serving, top with remaining cups of berries, dust with powdered sugar, add whipped cream.

The Eggbert's Sunriser

32 oz pkg frozen shredded hash browns
 20 whole frozen mini potato wedges
 4 tbsp unsalted butter; 8 large eggs
 1 medium onion, diced;
 1 green bell pepper, diced
 1/2 red bell pepper, diced
 1 jalapeno pepper, seeded, diced (optional)
 1 1/2 cups diced ham
 1 1/2 cups grated sharp cheddar cheese
 Preheat oven to 300F. Fry hash browns and wedges in oil in separate skillets until golden brown and crisp. Season to taste. Drain on paper towels, keep warm. Heat 2 tbsp butter in a large skillet over medium heat. Throw in veggies and ham; toss around until onions are just softened. Turn off heat and keep in pan. In a large ovenproof skillet, layer hash browns, veggie-ham mixture and cheese. Place in oven until cheese melts. Remove. Melt remaining 2 tbsp butter in a nonstick skillet and fry eggs. Place potato wedges over top of melted cheese, then top with eggs. Spoon salsa or pico de gallo over the top and serve immediately.

Lemon Blueberry Pancakes

1 heaping tablespoon baking powder
 1/4 tsp salt; 2 tbsp butter, melted
 1 1/2 cups evaporated milk
 1 lemon, zested and juiced
 1 1/2 tsp vanilla extract
 1 large egg; 1 cup blueberries
 Heat a heavy skillet over medium-low heat. In a medium bowl, mix flour, sugar, baking powder and salt. Set aside. In a separate bowl, mix evaporated milk, lemon zest and juice. Allow to sit for 5 minutes, then add egg and vanilla. Mix to combine. Pour wet mixture into dry ingredients. Stir gently to combine. Stir in melted butter. Stir in blueberries. Melt a little softened butter in heated skillet. Drop batter by 1/3 cup measures and fry on both sides until golden. Serve with more softened butter and warm syrup.

Strawberry Corn Cakes

1 8.5-ounce package corn muffin mix
 1/4 cup all-purpose flour
 2 tsp finely grated lemon zest
 1 tsp vanilla extract; 3/4 cup heavy cream
 1 cup chopped strawberries
 2 tbsp strawberry preserves
 2 tbsp confectioners' sugar
 Preheat oven to 375F. Lightly coat a 6-cup muffin pan with cooking spray. Prepare corn muffin batter as label directs, then stir in flour, lemon zest and vanilla. Divide evenly among muffin cups. Bake until edges are set and centers are soft but not wet, about 10-12 minutes. Meanwhile, toss strawberries and strawberry preserves in a bowl and set aside. Remove corn cakes from oven. Gently press back of a teaspoon into center of each to make an indentation about one-third of the way into cake. Spoon about 2 tsp of strawberry mixture into indentation, pressing to tightly fill. (Reserve remaining berry mixture for topping.) Return cakes to oven and continue baking until just golden, about 5 more minutes. Let cakes cool in pan on a rack, 5 minutes, then remove from pan and let cool 10 more minutes. Meanwhile, beat cream and confectioners' sugar with a mixer until soft peaks form. Top cakes with remaining berry mixture, serve with whipped cream.

Lazy Sunday Mimosa

1/2 cup pink sanding sugar
 1 (750-ml) bottle brut Champagne
 4 tbsp pineapple juice
 4 tbsp blood orange juice
 2 tbsp orange liqueur (recommended: Grand Marnier)
 Dip the rims of the champagne flutes in water. Dip again in the sanding sugar. Divide Champagne between 2 glasses. Add half of both juices to each glass and top with orange liqueur.
