MINUTES OF MEETING: August 16, 2016

The regular meeting of the Board of Trustees of Bayshore Gardens Park and Recreation District was called to order by Chairman Maynard Boyce at 7:00 pm and was followed by the Pledge of Allegiance. Notice of the meeting was posted in the August Bayshore Banner.

Roll: Dan Rawlinson, Kathy Lokos, Holly Clouse, Debbie Korell, Maynard Boyce, Richard Nelson, Jonna Koellhoffer and Vickie Ford.

A quorum was established.

Present: Joanne Manse, Suzanna Young, Don Gassie, Rose Woodruff, John Woodruff and Steve Watkins.

Holly made a motion to approve the July minutes. Debbie seconded. **Motion passed.**

Debbie made a motion to approve the July financials. Jonna seconded. **Motion Passed.**

BGNA: Dan Rawlinson
Dan reported they had their pizza pool party. Regular meetings will start again in September. Manatee County Emergency Management to talk about weather, food and hurricanes. In November there will be an open forum Town Hall meeting with Robin DiSabatino. **Next meeting will be September 8th at 7:00 pm.** Rose Woodruff is going to try to have a card night and dominoes.

CRIME WATCH: Steve Watkins
Steve reported they have been concentrating most of their time at the recreation hall after 10:00 pm. There has been a lot of activity in the parking lot. The Crime Watch Attic Sale will be October 29th from 8:00 am to 2:00 pm, with early set up on the 28th from 5:00 pm to 8:00 pm. Steve stated they have established a new set of rules when locking the beach gate. A courtesy note will be placed on a car left at the beach when no one is around. This will include a phone number to call if you are locked in. Don Gassie presented information on the Sheriff's Citizen Law Enforcement Academy. This is a free class that meets on Monday night for eleven weeks. Don also stated Crime Watch wants to put up more cameras on the property. They would like to install a camera that will capture a license plate that they can send to the Sheriff's data base. **Next meeting is September 13th at 7:00 pm.**

RESTORE BAYSHORE: Suzanna Young
Suzanna reported at the last meeting that Neighborhood Services gave a report on sidewalks. They are waiting on federal funds for some of the streets. "Work will start on Georgia and Cornell. Schedules will be in Sept. Banner." Suzanna would like to put maps in the office so the residents can see what streets they will be working

on. **Next meeting will be on September 12th at 6:30 pm.**

MANAGER'S REPORT: Joanne Manse
Joanne stated we had our yearly fire inspection. The only problem was that the emergency light battery in the board room needed to be replaced. The inspector said he wished every place he inspects was as nice and well kept as Bayshore Gardens. Joanne asked that Randy be reimbursed for racks he bought for his truck. The racks will be used to haul larger lumber to the district for repairs that need to be done. This will save between \$50.00 and \$60.00 in delivery fees. Kathy made a motion to reimburse Randy for the racks. Debbie seconded. **Motion passed 7 to 1.** The playground mulch has been installed, and the slide is leaking water. This will be addressed this winter. Pam Ortiz, a resident and realtor, will provide the "for sale and sold houses" for the Banner and will be receiving her business card ad for free. Three fire extinguishers have been stolen from the south marina. Joanne will be researching the cost for putting in new boxes with doors that will have to be broken by the mallet provided. Joanne stated she found someone to rekey the hall doors. This will be done in the near future. The picnic table at the ball field needs to be replaced. Randy has plans to build an ADA picnic table. Beachem Electric will be here Wednesday, August 24th to re-install electric wiring to the pool junction box. We had to purchase a small trailer to haul the garbage cans from the marina and park area to the dumpster. The cost was \$345.00

BUDGET & FINANCE: Kathy Lokos
Kathy stated there was no official budget meeting.

WEB/BANNER: Dan Rawlinson
Dan reported that someone needs to be in charge of the Banner. He stated the manager had this responsibility in the past and did a good job. If there is a problem, you need to have someone you can go to and ask why did this happen. Dan stated as the general manager Joanne is responsible for everything that happens here. Dan stated he will still be the chairman for the Banner. Joanne stated in the past we printed out each article that went into the Banner. Maynard stated Joanne needs to establish a policy that she likes and is familiar with. Dan made a motion that we return control of the Banner and the publishing back to the manager and she will be totally responsible for it. Jonna seconded. **Motion passed. Next meeting will be September 14th at 5:30 pm.**

MARINA: Richard Nelson/Debbie Korell
Debbie passed out copies of an e-mail from Mark Kincaid on the new slip configurations. This will ensure more room for the boats on the north side of the marina. Holly made a motion to accept the proposed marina design for approval by the board.

Richard seconded. **Motion passed.** The reason the number of yards to be dredged increased is because the center pier will be removed and rebuilt. Kathy stated she talked to Trailer Estates, and should we work with them on dredging, we might be able to get the county involved. Debbie made a motion to have Mark prepare the documents that need to be submitted for permitting and send them to us. Vickie seconded. **Motion passed.** Kathy is preparing an article on a referendum to continue the marina project for the September Banner. This project is a capital improvement that will exceed \$25,000.00. Debbie is also preparing a letter for the Banner explaining where we are on this project and the need for a referendum. When we hear from the Supervisor of Elections as to when we can hold the election, the referendum will be sent to our attorney to draft the wording for the ballot. **Next meeting will be Wednesday September 14th, 2016 at 5:30 pm.**

HOUSE & GROUNDS: Maynard Boyce
Maynard stated there was some confusion concerning the salary for the swim lesson instructor. Debbie made a motion that for all private swim classes, the instructor is to be reimbursed 50% of the fees, retroactive to the first swim lesson. This only applies to private lessons by Bayshore Gardens staff; group lessons will be discussed later. Richard seconded. **Motion passed.** Debbie made a motion that all instructors of swim lessons be paid their base salary in addition to their swim class wages. Jonna seconded. **Motion passed.** Maynard asked Holly if she would be willing to be the House and Grounds Committee chair. Holly accepted. **Next meeting will be September 14th at 5:30 pm.**

PERSONNEL & SALARY: Dan Rawlinson
Dan stated they spent twenty-five minutes discussing an issue presented by a staff member at the last committee meeting. The staff member went to the committee meeting without going through the proper channels. Dan suggested every staff member be reminded of the grievance procedures. This policy is to be used for any issues they may have. **Next meeting will be September 14th at 5:30 pm**

OLD BUSINESS: Maynard stated he received a letter from a resident regarding the speed bumps on the driveway to the beach. Maynard will contact Asphalt Maintenance to see if they will be able to lower them.

NEW BUSINESS No new business

Next meeting is September 20, 2016, at 7:00 pm.

Maynard requested a motion to adjourn. Kathy made the motion and Debbie seconded. Meeting adjourned 9:30 pm.

If it's September, it is surely time for the semi-annual slip and trailer space renewals. For those of us with only gate keys it's time for the annual renewal of those. The actual due date is October first. Invoices will be mailed out for the slips and trailer spaces. Invoices are not mailed for the gate keys. The Office will be open September 20th from noon until 6:45p.m. This provides a chance to come in if the normal hours are difficult for you. The Marina Project continues to progress with the formal approval, by the Board of Trustees, of the new slip configuration and the go ahead for Coastal Engineering to prepare the permitting documents required. This will include documents for all phases including the Boat Ramp. We hope to have received these documents for committee level review before the end of August. The committee is also exploring the possibility of partner-

ing with Trailer Estates to convince the appropriate agency or agencies to dredge the Bayshore Gardens / Trailers Estates Channel from Sarasota Bay. Soon the residents of Bayshore Gardens will have an opportunity to further this, their marina project, and the community improvements it contains. Watch for the details in this and future editions of the Bayshore Banner.

Reminders – Please remember to keep your boat registration and insurance documents as well as your parking decal information (vehicle registration and proof of insurance) up to date with the office. Fishing around the piers and boats in the Marina Basin is prohibited. Designated fishing areas are the North and South Seawalls where the channel enters the basin. I hope to have these marked in the near future. Also, fishing is permitted off of the dock at the fish cleaning station and

down at the bay beach and overlook.

Improvements, Repairs and Projects Completed –Several planks were reattached or replaced on the finger piers. A few more center pier planks were reattached or replaced. The rehab of the boat stands continues. Some 4x4s and other posts were replaced.

SIDEWALKS ARE COMING TO STREETS NEAR YOU.

At our meeting August 8, we were given a comprehensive outline of all the updates that will be taking place in the near and foreseeable future. About a dozen or so people were present to hear the sidewalk projects are funded and some set to go. Our Commissioner, Robin DiSabatino participated as well.

Ogden Clark, Neighborhood Services, (email ogden.clark@mymanatee.org) handed out a schedule of projects and gave us a run-down on the ones completed and others yet to be.

In Brief here are the Plans:

Street resurfacing was completed on a number of Bayshore Gardens Streets in May.

Sidewalks on Georgia Ave., Cornell Road (this fall); **Drainage Improvement** in west section of Trailer Estates (part of Force Main Project.) and **Area Traffic Maintenance**; are all funded by South West Tax Increment Funding (SWTIF) FY 2015 - 2016. Traffic Maintenance included: School zone warning flashers at Bayshore Elementary scheduled for November; flashers replaced at Lee Middle; Street sign replacements and street marking maintenance.

Sidewalks on Florida Blvd. 26th St. W. to **34th St. W.**, 34th St. W to Parkway, **Bay, Tulane and Harvard** FY 2016 - 2017.

Sidewalks on Columbia Drive, all of Dartmouth Dr. and Roslyn Ave. are Funded by Community Block Grant (CDBG) and are awaiting Federal approval.

Sidewalks will be on one side of the street. This location is based on the least cost, number of street crossings and ties into existing and future sidewalks. They will be 5 feet wide and built 4 feet back of existing curb. On Georgia, they will be on the east side down to Florida Blvd., then on the west side on down to Bay Drive. On Cornell, they will be on East side. Maps can be seen in the District office.

This will commence mid to late September of this year. Notices will be sent to homes on these streets.

IMPORTANT: Contractors will coordinate with residents to minimize disruptions where landscaping is impacted. Residents who wish to relocate plants and landscaping that exist in the right-of-way should do so before work begins. ADA residents will be notified in advance when their driveway access will be unavailable for the few days concrete needs to harden.

Discussed briefly were flashing cross-walks across Bayshore Parkway near Roslyn and the Bayshore Gardens shopping plaza — which has more than one dangerous intersection — such as one crossing Flamingo (60th Ave.) north of the shopping plaza.

SPEED CALMING WITH SPEED TABLES:

As you know, a speed table is constructed to slow traffic to the actual speed limit — it has a slight incline to a level “table” and then a decline — a “little hill”. If a driver is going the set speed limit, there is no discomfort and danger of hurting a vehicle. If you're speeding, that's another story! They are more unobtrusive than a Stop sign and they do work.

Locations for speed tables were determined by residents in work shops at several of our meetings last spring, however, nothing is set in stone right now. In any case, a speed table can only be possible if 67% of the surrounding residents support it in a petition.

This will be the time to voice your preferences. With more traffic routing through our community, speeding has been a deep safety concern and continuing annoyance in Bayshore Gardens by too many people to ignore. Too often drivers are seen running the stop signs that now exist. The community may at last have another option.

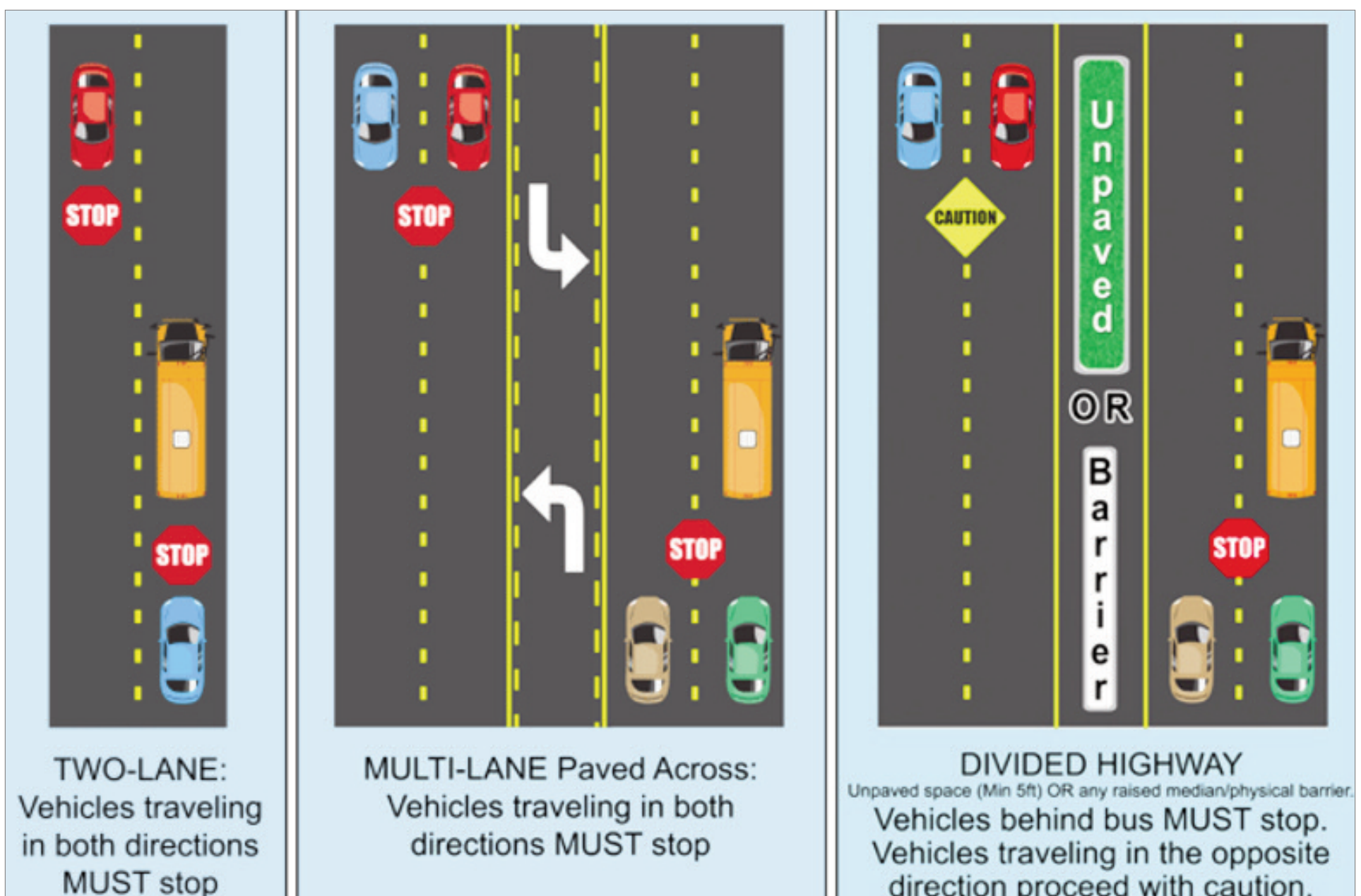
In September, a Survey Letter/form and map will be available to residents. The Banner will also feature the form and a map showing locations. Pick up copies in the office as well.

Marina Referendum

The work needed to bring the marina into specification will require a far greater amount of money than the District is permitted to spend without community approval according to our bylaws. A marina consulting firm has been brought in to assess the marina, consider reconfiguration including slips compliant with the American Disability Act, offer possible designs, and oversee the project.

The District Board will be coming to our Bayshore Gardens community for a referendum covering the capital improvement part of expected expenditures. The cost for dredging and the consultant fees before construction will not be included in the capital improvement estimated figures or as part of the referendum, but will be expensed as maintenance and professional fees in our regular budget, per our auditors.

Coastal Engineering has presented these preliminary estimates:

Center Pier: 3,670 SF x \$65/SF = \$238,550
(Does not include electric and water)

Center Pier Mooring Piles: 68 piles x \$600 = \$40,800

Finger Piers: 2,200 SF x \$65/SF = \$143,000

Finger Pier Mooring Piles: 93 piles x \$600 = \$55,800

Boat Ramp and Boarding Pier: \$105,000

Contractor Mobilization and Existing Structure Demolition: \$50,000

Budget numbers are based on construction of entire project without phasing. Phasing the project could add as much as 10 to 20 percent to each element. Final designs have not been performed. Budget numbers are based on recent bids received for similar projects.

Dredging: 6,000/CY x 43/CY = \$258,000

(Actual cost will depend on disposal site and trucking distance)

We hope to have the referendum election before the end of the year, probably to cover all the capital improvement expenditures even though rebuilding the marina may be phased over a few years. It will be a significant figure, but will **NOT** require a special assessment above and beyond our yearly assessment. The recently increased slip and gate fees will generate sufficient funds to pay for these improvements within a reasonable number of years.

Our marina is one of Bayshore Gardens greatest assets, not only for our boaters, but for all of us in the increased property value of our homes. Please vote yes on the referendum to rehabilitate our marina.

The Marina Project – Part 2

In late May, Mark Kincaid from Coastal Engineering gave his presentation on the review of the marina and boat launch. Since then, a number of Marina Committee meetings have been held. Here are the results.

The Boat Launch. To no one's surprise, the boat launch was found to have multiple problems. It was also discovered that part of the seawall has collapsed, (most likely due to prop wash). There is also a problem with the launching dock. While it appears fine from the top, on the underside there is considerable marine life and water damage. The boat launch will be completely rebuilt, correcting the issue with the steep slope of the ramp. The new launch will be a full 17 feet wide, and an ADA (American Disabilities Act) pier will be added.

The Dredging. There is estimated to be 3900 C.Y. (cubic yards) of material to be removed from the marina. If the center pier is removed, there would be an additional 900 C. Y. It is also recommended we dredge the entry way to the marina and area along the boat launch to prevent materials from entering the marina. This is an additional 1200 C.Y. We are also beginning the process to work with local government to investigate having the canal dredged. We have no additional information at this point. The good news is that the material is very fine; meaning very small particles and the quality is good enough that a landfill would take it as topsoil.

The Marina. The new marina will be ADA compliant. As expected, all the finger piers on the North, South and West walls need replacement. Then we were informed the center pier also has significant issues. The pilings were not correctly installed and are not driven into the hardpan. This has caused the entire center pier and finger piers to 'buckle'. One can look at the center pier and see the issues as it is not level and flat. A number of 'fixes' have been added to the pier over time. The engineer recommends that we not invest more money to try to correct these problems, and recommends the center pier also be planned for replacement.

To that end, we increased the scope of the project to also include a redesign of the center pier. The new design for the marina has 102 slips, varying in width from 10 to 16 feet in width. There is also

room for 2 catamaran slips. The new design includes 2 ADA compliant finger piers for 4 slips. The new finger piers will be 30 inches wide and have pilings that the boats can tie up to. The engineer recommends not tying up to the seawall, as that puts more stress on the seawall. The seawall is only 8 feet deep, 10 including the new cap, and that is not deep enough according to modern design. We have no plans to modify or replace the seawall. Boats along the seawall will continue to have to pull into their berths. We have also moved the center pier in the new design 6 feet south, allowing plenty of room to maneuver on the north slips. We also have an option to include a pier along the north side of the entrance to the marina that multiple boats could tie up to for short periods of time, or even overnight for daily rentals.

At this point, we are preparing the documents necessary to apply for permitting. The permits are valid for 5 years and can be extended for an additional 5 years. We have not yet begun the discussion of which pieces of the project will be completed in what order. We have many options available.

It is now necessary to hold a referendum. The enabling act, the act that was enacted by the Florida State Legislature, says that any capital improvement project over 25,000 must be approved by the district voters. The referendum is not for a tax. It is simply to ask for your approval to proceed with the project. The district has been saving money for this project for some time. The District has no plans to ask for a special assessment to pay for this project. The District has no plans to increase the resident slip rate to pay for this project. We simply need your approval to proceed. Without your approval, the only work we will be able to do will be the dredging. More information about the referendum is in this issue of the Banner and will be in future issues.

We hope you are pleased and satisfied with the progress we have made and the status of the project so far. Your input is always welcome. Thank you to all the people who have worked hard to get us to this point. We hope, given this background, you will vote "Yes" in the referendum so we can replace the boat launch and continue to rebuild the deteriorating parts in the marina to build a beautiful, safe marina. Thanks again for all your support.

FYI: Manatee County Animal Ordinance 12-10

Manatee County Animal Services has a new animal ordinance which took effect May 14, 2012.

We would like to provide the animal owners as well as the citizens of Manatee County a highlight of the ordinance.

Rabies vaccinations are required for all dogs, cats and ferrets.

A Manatee County license tag is required annually for dogs and cats, which they are required to wear.

Dogs and cats are not allowed to run at large.

Your dog or cat must be on a leash no longer than eight (8) feet in length when the dog or cat is off the property of the owner and must be under the

physical control of the owner or custodian.

All dogs and cats must be under the direct control of the owner or custodian while on the property of the owner or custodian. This means the dog or cat must be confined on the property by a fence (the ordinance does recognize invisible fences, provided they are in working order), chain, leash, or cord of sufficient strength to restrain the animal or the animal shall be attended and supervised by a competent person by hand or voice control when on the property of the owner or custodian or property the owner or custodian has the right to use.

The ordinance requires pet owners to remove feces deposited by their animal from any public property or private property of another.

Animals are not allowed to be left in vehicles unat-

tended. The extreme heat could kill your pet.

Animals are also not allowed to be left in the open bed of a pickup truck or similar vehicle without being confined in a carrier or restrained by a minimum of two tethers, each attached to opposite sides of the truck or other vehicle.

If an animal owner is issued a citation, he or she can elect to pay the citation or contest it in court. The person cited is allowed 30 days to make this decision, however, after this time period, if the citation is not paid or contested, they no longer have the right to contest the citation and may end up in jail if the fine is not paid.

Selecting Canopy Trees for Manatee County by Norma Kisida, Master Gardener 2012

Tree canopies provide many benefits such as shade, energy savings, increased air and water quality, increased beauty, and higher property values. However, trees planted in the wrong space can be problematic, resulting in expensive mitigation.

Whether landscaping a new property, changing an existing one, or removing problem trees in a residential area, there are landscape and screening standards to be aware of in Manatee County. The Manatee County ordinance provides guidelines for placement and species of trees which are permitted in residential areas as canopy trees. In addition, some homeowner associations have additional requirements which must be met.

Canopy trees (or "street trees") permitted by Manatee County include live oak, (*Quercus virginiana*), cathedral live oak, highrise live oak, red maple (*Acer rubrum*), and sweetgum (*Liquidambar styraciflua* 'Rotundiloba' seedless). Southern live oaks have traditionally been the

major tree planted in communities. This is a massive tree with a very large canopy when mature and huge root system which can uproot sidewalks and driveways as well as encroach upon utility lines if not given adequate space.

'Highrise' and 'Cathedral' are cultivars of live oak which have a smaller more upright and uniform shape. Although the canopy is smaller, these cultivars have an aggressive root system and still require eight to ten feet between the curb and sidewalk. 'Cathedral' is reported to be wider spreading than 'Highrise'.

Our native red maples are usually found in wet areas and may need irrigation if planted in dry sandy areas. Improved varieties that are suited for Florida and have the best fall color are 'Florida Flame' and 'Summer Red'. Red maples are also large trees (height: 60 to 75 feet, spread: 25 to 35 feet) and can form large surface roots so adequate space is needed.

When I think of sweetgum trees I think of those prickly balls which are so hard to deal with. There

is one cultivar 'Rotundiloba' that is suitable for home landscapes as it is seedless and has no gum-balls to deal with. It matures into a more narrow-pyramidal shape with a height of 50-70 feet and a spread of about 35-45 feet.

'Rotundiloba' is fast growing, deciduous, has good fall color, and is tolerant of soil conditions but also has large aggressive roots so needs plenty of room. For proposed lots with less than 60 feet of frontage, smaller maturing canopy trees or understory trees may be used (see ordinance for list). There is also a procedure for email notification for removal of trees if certain conditions are met.

Other considerations such as water and soil requirements, pest and disease susceptibility, salt tolerance, and sun exposure are addressed in the photo-illustrated "Florida Friendly Landscaping Guide to Plant Selection and Landscape Design," downloadable free:

ZEBRA LONGWINGS

One of the more routine butterfly visitors to Florida gardens and landscapes is the zebra longwing (*Heliconius charitonia*). The zebra longwing is common throughout the state in areas with deep or dappled shade. It is especially frequent in gardens/landscapes that include firebush (*Hamelia patens*) and its host plants, the corky stem passion vine (*Passiflora suberosa*) and purple passion flower (*P. incarnata*.)

The zebra longwing has also been the Florida State Butterfly since 1996! But that is not the only special designation belonging to *H. charitonia*. Zebra longwings, along with the *Heliconius* genus, are unique amongst butterflies for their consumption of pollen as well as nectar.

While feeding on nectar, the butterfly also collects pollen on its proboscis. It then secretes a cocktail of salivary enzymes that breaks the pollen down into a rich protein drink. This process, by nature of

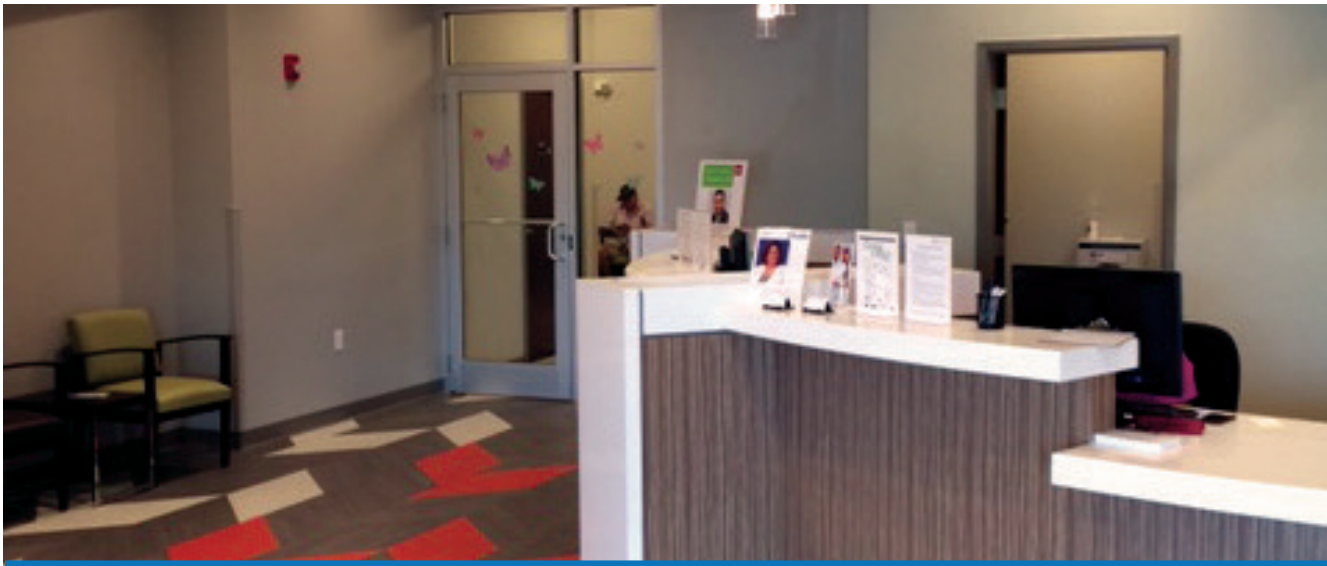
better nutrition, extends the life span of Zebra longwings by several months. Compared to other butterflies, that's a tremendous expansion.

Longwings also exhibit a behavior called "trap-lining." Once a food source is located, the butterfly takes a "mental" note of the plant, pollen content, and nectar value. This information is imprinted, and the zebra longwing adds this food source to its unique daily foraging route.

After a long day of foraging, the butterfly displays another special attribute by roosting communally in the same place every night. These nightly gatherings can range from a small family group of three to a huge community of up to 60 butterflies! The zebra longwing butterfly may be a common sight, but it is most definitely not a typical butterfly.

Fun School Lunchbox Recipes

Pizza Roll Ups

1 loaf frozen bread dough, thawed, 1 lb
 1/4 cup prepared pizza or pasta sauce
 1/2 cup shredded mozzarella, divided
 2 tablespoons finely chopped pepperoni
 1 tablespoon olive oil
 2 tablespoons grated parmesan cheese
 Preheat oven to 450. Generously coat a rimmed baking sheet with cooking spray. Roll dough into a 10 inch square on a floured surface. Spread pizza or pasta sauce over dough. Sprinkle all but 2 tbsp mozzarella over the sauce. Top with pepperoni. Roll up dough jelly-roll style to enclose filling. Cut roll crosswise into 10 slices. Place slices, cut side down on baking sheet. Brush tops with oil. Sprinkle with parmesan and remaining mozzarella cheese. Bake until golden brown, about 15 minutes.

Yogurt Fruit Bars

1 1/2 cups whole wheat flour
 1 teaspoon baking soda
 1/2 teaspoon baking powder
 1 teaspoon cinnamon
 1/2 teaspoon ground ginger
 6 oz mixed dried fruit, coarsely chopped
 1/3 cup chopped walnuts (optional)
 1 cup plain fat-free or low-fat yogurt
 1 large egg
 1/4 cup apple juice concentrate
 2 tablespoons oil
 Preheat oven to 350. In a large bowl, mix all dry ingredients. Add dried fruits and walnuts. In a medium bowl, combine yogurt, egg, apple juice concentrate, and oil. Make a well in the center of the dry ingredients and add the wet ingredients until blended. Coat a 9x13 pan with vegetable spray, spread batter in pan. Bake 45-50 minutes or until done. Cool 10 minutes before slicing. Slice into 8 servings. Freeze in individual portions if desired.

Ham and Cheese Muffins

2 cups self-rising flour
 1/2 teaspoon baking soda
 1 cup milk; 1/2 cup mayonnaise
 1/2 cup finely chopped, fully cooked ham
 1/2 cup shredded cheddar cheese
Note: As a substitute for each cup of self-rising flour, place 1 1/2 tsp baking powder and 1/2 tsp salt in a measuring cup. Add enough all-purpose flour to equal 1 cup.
 In a large bowl, combine flour and baking soda. Combine remaining ingredients; stir into dry ingredients just until moistened. Fill greased or paper-lined muffin cups two-thirds full. Bake at 425 degrees for 16 to 18 minutes or until muffins test done. Sprinkle with shredded cheese while still hot if desired.

Ultimate Lunchbox Muffins

1 cup whole wheat flour
 1 cup white flour
 1 teaspoon cinnamon
 2 teaspoons baking powder
 1 teaspoon baking soda
 2 ripe bananas, peeled
 3 tablespoons molasses or honey
 1/2 cup apple juice
 2 teaspoons apple cider vinegar
 1 1/2 cups grated zucchini or carrots
 1/2 cup walnuts, crushed
 1/2 cup sultana
 Preheat oven to 180 degrees Celcius. Line a muffin tin with paper liners and spray briefly with non-stick spray. Combine flours, cinnamon, baking powder, and baking soda. Set aside. In a blender, blend the bananas, molasses, apple juice and vinegar until smooth. Mix the wet ingredients into the dry ingredients. Fold in the zucchini, walnuts, and sultanas. Divide mixture evenly into the muffin cups and bake for 20 minutes. If freezing, freeze in individual freezer bags to pull out as needed.

Orange Julius Roll-Ups

1 1/2 cups applesauce
 1 small apple, peeled, cored and chopped
 2 teaspoons dried oranges, ground
 1 1/2 teaspoons vanilla
 2 tablespoons corn syrup
 In a blender mix applesauce, apple, dried orange, vanilla and corn sryup until pureed. Pour onto solid fruit leather sheets. Dry at 135 degrees for 4 to 8 hours, or until leathery. Remove from sheets while still warm. Let cool slightly. Roll in plastic wrap and store in dark, dry cool place or in the freezer.

Sweet and Salty Cereal Bars

4 cups Crispix cereal
 2 cups Cheerios toasted oat cereal
 1 1/2 cups lightly salted peanuts
 1 1/2 cups broken pretzels
 1 1/2 cups M&M's plain chocolate candy
 1 cup light corn syrup
 1 cup packed brown sugar
 1/2 cup butter
 1 teaspoon vanilla
 Combine cereals, peanuts, and pretzels in a large bowl.
 Combine corn syrup, brown sugar, and butter in a medium saucepan and bring to a boil over medium heat; boil 3 minutes, stirring constantly. Stir in vanilla. Immediately pour sugar mixture over cereal mixture, and stir well to coat; stir in M&Ms. Using a greased spatula, press mixture tightly into a greased jellyroll pan (approximately 15 x 10 inches) and cool at room temperature. (Spread it as evenly as possible, then cover with a sheet of non-stick aluminum foil and press it out firmly and evenly). Cut into bars when completely cooled.
