## Sydney R. Newman, Bayshore Gardens Founder – a true visionary!

Newman hoped for a 3,200 acre development along the Tamiami Trail. It was to be called Bayshore Gardens – and the land was purchased for some \$1.5 million dollars. It was to be one of Florida's first "planned communities", to be built in response to the post-war migration into the State.

The area was purchased from Melvin Potter and W. E. Lee in the period from 1955 to 1956. Part of the original Whitfield Estates was included – and the vast tract extended all the way west to the now-controversial Long Bar Pointe development

Civil Engineer Freeman Horton platted first two sections of Bayshore Gardens. These included the areas bounded by the Bayshore Gardens Parkway from the Tamiami Trail to 26th Street.

Newman seems to have stayed involved for at least 20 years thereafter. His name appears in a successful application for a drainage ditch easement along the west side of 34th Street in 1978. It is clear that other developers became involved as time went on. They took over portions of the subdivision development for their own projects.

The area commonly known as Bayshore

In his grand scheme for the future, Sydney R. Gardens today includes mostly the area easily identified by the distinctive architecture of the eight home styles offered in the initial development. The folklore suggests that Newman had some difficulty expanding the sub-division beyond his initial plans. Other developers, as noted, became involved and took over the expansion of building homes, often with their own distinctive sets of plans or styles. The best example would be the cluster of homes in the area south of Bayshore Gardens Parkway (Merger Road), adjacent to 34th Street and north of Florida Blvd. This section is easily identified by the homes with the distinctive terra cotta tile roofing.

> Other homes were built by Lawrence Richmond, joined by his wife Ruth in the mid-50s. They were built "on-your-lot" style homes. Personal touches were included, along with a 5 year guarantee that nothing would break - the first home builder in Florida to offer such a warranty. Business flourished through the 1970s when the couple sold the business to Ryan Homes. According to Joyce Fisher, a long-time resident, there is a Richmond home near her own residence on Bryn Mawr Island Drive.


The Banner is now much more than just a collection of club meeting minutes.

The regular meeting of the Board of Trustees of Bayshore Gardens Park and Recreation District was called to order by Chairman Maynard Boyce at 7:00 p.m. and was followed by the Pledge of Allegiance.

Notice of the meeting was posted in the May Bayshore Banner.

Roll: Kathy Lokos, Steve Watkins, Jeannette Sparrow, Don Gassie, Maynard Boyce and Richard Nelson.

A quorum was established.

Present: Joanne Manse, John Woodruff, Suzanna Young, Joseph Gorty, Tom Glancey, Frank Young and Marie Young.

Jeannette made a motion to approve the April Minutes, Steve seconded. Motion Passed. Jeannette made a motion to approve the April Budget Meeting Minutes. Steve seconded. Motion Passed

Jeannette made a motion to approve April Financial Statements. Steve seconded. Motion Passed.

#### **BGNA:** Jeannette Sparrow

## **MANAGERS REPORT:** Joanne Manse

Joanne stated we had to replace the steel door in the breezeway. Joanne reported we received a refund for \$302.00 from the county for the water construction meter we had to prepay prior to filling the pool. The no bounce houses allowed sign is now posted and the stencil for the loading zone in south marina is in. Joanne stated there was a bogus charge on the district credit card. She called the credit card company and they stopped the card immediately and will issue a new card. Joanne asked the Board to look at the balance sheet under the reserve accounts. The pool reserve account shows \$143,750.00 and now that the pool is finished, a motion needs to be made to move

\$71,075.00 from the Pool Reserve to the general fund. The reserve fund for the A/C in the hall shows \$14,892.00. Jeannette made a motion to move \$71,075.00 from the pool reserve account and put in the general fund. Steve seconded. Motion passed. We had to replace the east end A/C unit for a cost of \$9353.00. Joanne asked for a trustee to make a motion to move \$9353.00 from the A/C Reserve account to the general account. Jeannette made a motion to move \$9,353.00 from the A/C Reserve account to the general fund. Steve seconded. Motion passed.

**BUDGET & FINANCE:** Jeannette Sparrow No meeting. No report. Next meeting will be June 11, 2014 at 5:30 pm.

#### WEB: Don Gassie

Don submitted a change to the ad contract. Don added a line for a Banner signature and date. The ad is not good until a Banner person signs. Don made a motion to add the extra line to the contract. Steve seconded. Motion passed. Don reported the committee talked about giving a 15% summer discount to customers who buy a six month ad. The Board is concerned that this should only be for Bayshore residents. After a very lengthy discussion, Don made a motion to table this project until next committee meeting. Steve seconded. Motion passed. Duncan Seawall will provide better information as to the number of homes involved.

## Maynard Boyce for Bob King

Maynard reported the pool slide had to come down due to safety issues. The nuts and bolts holding it together are not stainless steel therefore

they have rusted. This makes the slide unstable. Joanne stated she talked with a company from Plant city that specializes in playgrounds and water features. They said the slide is unsafe as is. She will get a letter from them and will contact the Risk Consultant from our Insurance and see if she can get something in writing from them. If so, we will have solid evidence to go after Summit Pools and try to recuperate our money we paid for the slide. Maynard stated an RFP will be sent to tree contractors to move the oak trees at the north end of the ball field so that a soccer field can be put in. Suzanna Young stated she had conversations with the county on what is needed to go forward with the small boat storage area. This will go back to committee for further review. Don made a motion to budget not more than \$2,500.00 to purchase decorative rope for the park. Jeannette seconded. Motion passed. Don made a motion to give Randy authorization to install a drainage solution in the south end of the park not to exceed \$1,000.00 Jeannette seconded. Motion passed. Don made a motion to purchase 2 AED's that are used by county emergency personnel for \$3,368.00. When the unit arrives the staff will be trained and certified the use of the device. Jeannette seconded. Motion passed. Don made a motion that every effort be made to find any legal opinions the District has that defines our duties and responsibilities. If none are found, contact our attorney for a quote on cost of developing said document. Steve seconded. Motion passed. Don made a motion to add \$20,000.00 to the hall remodel reserve fund to be taken out of the general fund. Steve seconded. Motion passed.



If this is the first of June, it must be.... HURRI-CANE SEASON !!! I'm not trying to be an alarmist but, I do want to mention this start as I have each year. We have had such good luck with storms the past few years I would hate to jinx it just because I didn't tell everyone. It is time to make sure you have a plan, not just for your vessel, but for your home, your pets, and yourself. The county has lots of information available to assist in making these preparations. Usually a guide is published annually in the local newspa-

pers. For those of you with trailerable boats in the Marina the preferred response to the threat of a hurricane is to pull your boats and get them away with larger boats the best you can do is secure your boat as well as possible. Have your plan and the materials to implement before you need them. The NOAA prediction for the 2014 season is for only a 10% chance of higher than normal activity. Their guess is 8-13

named storms, 3-6 hurricanes, and 1-2 major hurricanes. Let's hope they are correct and that none of the storms that do occur come our way.

**Improvements** - The Marina Committee Continues to work the dredging issues. The marking of the south parking area should be completed within the month, weather permitting.

Repairs and Projects Completed – A several loose planks on the finger piers around the marina have been reattached or replaced. 20 some planks on the center pier have been replaced. One of the finger piers had a broken cross brace which was repaired. A leak in the fish dock water supply was fixed. A back flow preventer was replaced.

Call to Order: President Lynn Wellborn

**Minutes:** Lynn Wellborn made an observation that there were not minutes for last month's meeting due to a Banner meeting at the same time, which many CRIME WATCH members attended.

**Treasurer:** Mark Rendezes presents the Board with the updated funds. Gas cards given to patrolling members for the past months. Other purchases included CRIME WATCH phone minutes, printer ink and the tax fees for the CRIME WATCH taxes.

#### **Old Business:**

1. Attic sale funds not completed yet.

#### **New Business:**

1. Lynn Wellborn announces that he is resigning from all participation in CRIME WATCH. He states that he has not been supported by persons outside of CRIME WATCH. This will put Harold in charge of CRIME WATCH. Lynn released several supplies to Thomas Carmichael Smith: gate key, flashlight, 2 round and one square magnetic signs, yellow strobe light, radio, charger. Lynn left at the meeting: instructions, plug in micro-

phone, and other supplies. Lynn gave all keys to the office (3) were given to Harold Donaldson. Harold agreed to turn in all the keys to the BG office. Lynn states he will take his name off of the checking account at the Bank also.

- 2. Banner and Web Committee----Don Gassie would like to know if anyone has placed anything on the website. Seems that no one has participated in updating the website. Discussion about what to include on the on-line Banner. The crime information was retrieved from the Sheriff's website, but someone accused Lynn of inaccuracies. This is part of the reason that Lynn is leaving. He states that he was not supported when the accusation was made against him.
- 3. Discussion about a computer for accessing crime stats and also to monitor the cameras around the district once the cameras are up and running. Don suggests a computer for crime stats, archiving the crime stats, and writing minutes. Don states he can set up a computer system and estimates it would cost about \$600-700. Don states that if interested, he would price computer systems to try to proceed with this idea/goal. Concern expressed about leaving a computer in the CRIME WATCH office dependent upon who has a key. Since only CRIME WATCH officers have a key to the room, other members will not be able to access the room or computer.
- 4. There was a discussion about offering computer classes.
- 5. When it was mentioned that we have computers already in the CRIME WATCH room, Don stated that they are too old to function properly.
- 6. It was mentioned that someone stole mirrors from the bathrooms in the Rec Hall.
- 7. Concerns that information of crimes at the Rec Center are not reported to the CRIME WATCH

committee. Don is going to work on getting a system up to send an email to those interested in receiving the information.

- 8. Email list for CRIME WATCH members to be sent to Don Gassie so crimes in the District of BG can be reported to CRIME WATCH members.
- 9. Don will research costs of computers and send out estimates to members prior to the next meeting.
- 10. The CRIME WATCH room needs to be cleaned out and old stuff discarded.
- 11. Concerns expressed over suspected drug homes. If there is a suspicious home, residents are encouraged to contact the Sheriff's department, who can then investigate it.
- 12. Expressed concern about a car that is left, for days, at the end of Rollins. If noticed, we are encouraged to call the Sherriff's office about a "suspicious" vehicle.
- 13. Use of radio is encouraged to enhance communication.
- 14. Board positions will be discussed at the next meeting.
- 15. Gate schedule for June---Mark will work on it. About 5-6 members are on the gate schedule rotation. Suzanna offered to take shifts if needed.


## **Butterflies in Your Life**

We will meet at 12:30 on Monday, June 2 for our June luncheon at Anna Maria Oyster Bar--what better setting than our favorite local restaurant. This will be our last meeting until September. We hope to see everyone before they leave for the north or on vacation.

Our May meeting gave us an in-depth insight into the life and habits of the butterfly. Master Gardeners from the Manatee County Extension Office, Norma Kiside and Betty Cuthbert shared slides of the four stages of development of butterflies and also brought samples of the four stages from larva to the resulting wonder, a beautiful butterfly. They shared which plants attract various butterflies and how some travel thousands of miles while others stay in certain areas. They suggested that if you have trouble growing a lawn, populate areas with an array of Florida wildflowers, including specific butterfly flowers and of course, along with varieties of milkweed and other "weeds" that butterflies need in order to to reproduce.

Of note, butterflies act as pollen messengers which is proving to be very critical these days with more and more bees disappearing. If you see a caterpillar, let it be, it could be on it's way to something wonderful. We wish you "Butterfly mornings and wild-flower afternoons" ....if you might remember the song from the '60's.



Imagine what a huge development Bayshore would have become if Newman's grandiose scheme had ever come to full fruition! The community would have stretched all the way from Whitfield Estates in Sarasota to the Village of Cortez and as far north as Cortez Road.

Bayshore Sch Bayshore Gardens

The map above shows in pink the areas generally known as Bayshore Gardens and Trailer Estates as we know them in 2014. The original sub-division plans called for a massive development extending well beyond these borders – to the north and to the west. The initial sub-division, comprised of some 1400 homes is identified today as the Bayshore Gardens Park and Recreation District. It is governed under State of Florida legislation, CHAPTER 2002-365, House Bill No. 997 as updated and passed by the State Legislature in 2002.

## As a Planned Community!

What made Newman's vision special was that he saw Bayshore Gardens as a complete community. It was designed to provide for full services and community amenities. Model homes and amenities, including recreation, schools, churches, shopping centers, and medical facilities, were planned from the beginning. Folks who bought the model homes were assured of a recreation center, a park, a marina, a shopping center and schools for their children. Along with a few other key people, the plan unfolded quickly. The developers and builders signed a Declaration for Development in June of 1956. Included was provision for the recreation center that was completed later that very same year.

The house designs, the White Orchid, Camellia, Hibiscus, and Calypso Models were prevalent; and, prices ranged from \$8,500 to \$15,000 including the lot. Various upgrades were available for a few hundred dollars. Fine terrazzo floors were said to be only about \$300 extra.

In August 1957, the County selected Bayshore Gardens to be the site of the Manatee Junior College. 80 acres were purchased by the school board and the college opened

September of 1959. It was a great asset to a quickly growing community.

600 homes were sold by April 1959. October 1959 brought the dedication of a 60' lit pylon entrance sign. A portion of it still stands today as the

entrance sign to the Bayshore Gardens Shopping Center:

One month later the Bayshore Gardens Shopping Center held a grand opening. Stores included Publix, a beauty shop, bakery, barbershop, hardware store, shoe repair, and clothing stores. There was an 8 page spread for Grand Opening Sales in the Sarasota Herald-Tribune to celebrate. Later a theater to seat 1200 persons was added to the center.

The Elementary School opened in the fall of 1960. It was designed by well-known architect Sidney "Sid" Wilkinson.

A set of "Adult-only" Condos opened in May 1964. They are the two and three storey buildings north of Flamingo Blvd. [60th Ave. W.], between 41 and 26th Street.

The pool at Bayshore Gardens Recreation Center

opened in April 1962. The Bayshore Gardens Community Church, originally known as Bayshore Gardens Reformed Church formed in 1959. Renovations and a new sanctuary were completed in 1964. It was designed by Architect, J. Arthur Miller.

The future was looking really bright for this unique, fully planned community. Who would ever guess that homes, ranging in purchase price from \$8,000 to \$12,000 would eventually change hands in the first decade of the 21st Century for a half million dollars each or more!

As we all know the community has had its 'ups' and its 'downs' over the approximate 60 years of its existence. Since the real estate 'bust' following the 2008 banking and market crash, things have been difficult for the community. But there is every sign that things are turning around. Vacant homes are being purchased by new owners. While a few are being re-built to be 'flipped', just as many are being sought out by newcomers looking

for a quiet neighbourhood area with all of the great amenities that Bayshore Gardens has to offer. Long term changes will unfold. And they will be based on input from the community and on the basis of partnerships such as those currently unfolding among the Historic Preservation Program in the College of Design at the University of Florida, Manatee County and representation from the Board of Trustees for Bayshore Gardens Park and Recreation District.

Robin Disabatino, our District 4 representative on the Manatee County Board of Commissioners, confirms that it is her "privilege and honor to be the Commissioner in Bayshore Gardens." She

is pleased to note that, "we are working together to revitalize our unique, historic neighborhoods. Bayshore Gardens offers its residents amenities right on Sarasota Bay such as a world-class Recreational Center, Beach, Marina, Pool, Homes on deep water Canals and a walkable community. I am very excited about our enhanced partnerships and making Bayshore Gardens the best place to live, work and play!" For anyone who wishes to contact the Commissioner, she can be reached at 941-685-5368.

At this time the County is adding Bayshore Gardens to the expanded Southwest Tax Incentive Fund area of Bradenton. There will be several options for assisting the community with re-development support over the next several years under

these plans.



## Don't Kill This Good Guy in Your Garden!

## Biological Control of Air Potato Vine, Dioscorea bulbifera, with, the Air Potato Beetle in Florida

Submitted by: Eric Rohrig, Ph.D., Biological Scientist, from the Master Gardener's Bench

The Florida Department of Agriculture and Consumer Services Division of Plant Industry (FDACS-DPI) have found a natural, biological control for the management of invasive species air

potato Dioscorea bulbifera, considered one of the most aggressive weeds ever introduced into Florida.

Many invasive species wreak havoc on native landscapes because natural enemies are not present to control them. Fortunately, there is a leaf-eating beetle,

Lilioceris cheni, whose sole purpose is to search for and feed on Dioscorea bulbifera. The air potato beetle, which is native to tropical and subtropical Asia, has undergone extensive host range testing and has proven to be host specific, capable of surviving only on D. bulbifera. Both larvae and adults are voracious feeders of air potato leaves. A single individual is capable of eating approximate-

> ly 20 sq. feet of plant material in its lifetime.

> Air potato is an invasive, high climbing vine capable of out-competing native vegetation and displacing other organisms. It forms dense blankets, which smother native trees and understory plant species. It is a rapid climber, capable of more than 8 inches of growth per day. Air potato is listed as a noxious weed by the Florida Department of Agriculture and a Category I invasive plant by the Florida Exotic Pest Plant Council. The vines primary means of spread is through the production of aer-

ial bulbils, known as "air potatoes."

Eric writes, "We are currently only releasing beetles on public lands such as city, county, state, and federal parks, forests, preserves and other types of conservation or environmentally-sensitive lands. After building large populations of beetles on these lands, the insects will disperse into surrounding residential and commercial areas (we are already seeing this). In another year or two, we will begin to conduct direct residential releases statewide to supplement the dispersing beetle populations. When it's time to begin residential releases, we will contact all of the extension services in the state to let them know. Anyone can send in the beetle request form. We add it to our database to



eventually receive beetles. The current wait time is around one month because we receive many requests. We fill requests in the order we receive them. We ship FedEx priority overnight at no charge. The beetles need new vine growth in order to reproduce. Keep in mind we are not currently accepting requests for homeowner's backyards unless they live adjacent to one of the land types mentioned above."

## Identifying Pet Emergencies: When To See A Vet, STAT!

**Trauma:** Any pet that has been hit by a car, fallen out of a window or suffered some other traumatic injury should be seen at once. Even if the animal appears to be fine, he could be suffering from internal injuries or bleeding.

**Difficulty breathing:** This is the most severe and frightening form of pain. If your dog or cat is breathing rapidly, has labored breathing, is straining to breathe or gasping for air, seek veterinary help immediately. Blue or white gums, known as cyanosis, are a sign of oxygen deprivation as well. Causes of breathing difficulty include choking, some types of poisoning and congestive heart failure.

**Severe vomiting:** If your pet vomits repeatedly or forcefully, the vomiting is accompanied by diarrhea, or if the vomit has blood in it, looks and smells like feces, or contains what looks like coffee grounds (actually partially digested blood), it's an emergency.

**Poisoning:** If you know that your pet has ingested something toxic, such as antifreeze, rat poison, raisins or grapes, Easter lilies, dark chocolate or baking chocolate, or a drug such as your blood

pressure medication or ibuprofen, take him to the veterinarian right away.

Unusual behavior: Your pet is just plain acting weird. She's pacing, she's clinging to you or gen-

**Heavy bleeding:** If a wound is spurting bright red blood, it's coming from an artery. Apply pressure to the wound with a clean cloth, and get the animal to a veterinarian immediately.

**Eye injuries:** Emergency situations include dislocated eyeballs, foreign bodies in the eye and chemical burns to the eyes.

## CAN IT WAIT?

Veterinarians never want you to waste your time or money, but we also think that it's better to err on the side of being safe rather than sorry. Some situations aren't necessarily emergencies, like these:

Reverse sneezing: Formally known as a laryngospasm, a reverse sneeze often sounds as if a dog is struggling to draw in air. The good news is that your dog isn't dying, not even close. That loud snorting sound, which can go on for a few minutes, is most likely a temporary spasm of the larynx muscles in response to allergies or post-nasal drip. To help end the attack, stroke your dog's throat to encourage him to swallow.

**Unusual behavior:** Your pet is just plain acting weird. She's pacing, she's clinging to you or generally acting more needy than usual - and she doesn't do those things normally. It's not unusual for people to bring a pet to the ER for atypical behavior, but if no physical signs accompany the strange behavior, the ER veterinarian is probably going to be puzzled by your pet's actions, too.

You can always call your veterinarian to question the symptoms you are seeing. Bayshore Animal Hospital's on-call doctor will call you back after hours up until 10:00 PM.

## Pet Ownership and the Law

(First of a Series on Pets and the Law. Excerpts from the Manatee County Animal Services information booklet)

We all love our pets and think...no, we know, they are the most special little critters on earth, otherwise we wouldn't have them. However, not everyone shares our perception. The following are some tips and some hard facts given in County Ordinances that need to be shared so that we can all live in peace and harmony with each other and each other's pets.

## Laws Pet Owners Need to Know:

Don't let your dogs or cats roam or run loose. No dog or cat shall be "at large" upon any public property, street or sidewalk, or on private property of another Person without the consent of the property owner. Dog Parks are the exception.

Any dog or cat that is "at large" or without the consent of another property owner, can be captured in a humane trap or confined humanely.

Any cat that is outdoors while not under direct control must be sterilized in order to be exempt from the requirements of Sec.2-4-11(d) of the Ordinances. (working Police dogs are exempt as well as trained--sport or working--dogs actually performing their duties under supervision.

"At Large" means any dog or cat on the owner's premises and not in the control of the owner or custodian; or any dog or cat off the premises and not under the physical control of the owner or custodian. Sec.2-4-11. There are fines for Animals at Large: 1st Offense: \$200, 2nd Offense: \$350., 3rd Offense: \$500

License Tags are a Must! Animals must have a collar with a rabies Vaccine tag.

Dogs and cats must have a current rabies vaccination certificate and wear a tag to evidence this.

All dogs must wear a tag when outside. Other types of ID, such as a microchip or tattoo, are encouraged in case of tag loss or pet is not wearing its tag.

All Cats must wear a tag or be micro-shipped. To identify trapped, neutered, and released cats, one ear is slightly nipped.

Of importance is a vaccine for Leptoporosis. This is a highly toxic bacteria from the urine or feces of wild animals. Humans can contract it from their pets.

1 tablespoon chopped fresh parsley

4 tilapia fillets

olive oil

Bake in preheated oven until the fish flakes easily with a fork, 10 to 12 minutes.

8 oz (8 slices) bacon, cut 1-inch-thick crosswise 3 large eggs

3/4 cup(s) grated Parmesan cheese, plus extra 1/2 cup(s) half-and-half

Coarse salt, Freshly ground pepper

Directions

Set a large pot of water to boil (for pasta). In a large skillet, cook bacon over medium heat, stirring occasionally, until crisp, 8 to 12 minutes; transfer to a paper-towel-lined plate. Salt boiling water generously; add pasta and cook until al dente, according to package instructions. Meanwhile, in a large bowl, whisk together eggs, Parmesan, and half-and-half. Set aside. Drain pasta, leaving some water clinging to it. Working quickly, add hot pasta to egg mixture. Add bacon; season with salt and pepper, and toss all to combine (heat from pasta will cook eggs). Serve immediately, sprinkled with additional Parmesan cheese.

#### **Eggs in Clouds**

*Ingredients* 

4 eggs

1/4 cup grated pecorino-romano

1/4 cup chopped chives

1/4 cup crumbled bacon

Pepper

Directions

Separate eggs, putting whites in 1 large bowl and yolks in 4 separate small bowls. Whip whites until stiff peaks form. Fold in cheese, chives and bacon. Spoon into 4 mounds on parchment-lined baking sheet; make a deep well in center of each. Bake at 450 degrees for 3 minutes, then and 1 yolk to each well; season with pepper. Bake until yolks are just set, 2 to 3 minutes.

#### **Tortellini with Peas**

Ingredients

Coarse salt

Ground pepper

1 1/2 pound(s) frozen cheese tortellini

1 package(s) (10-ounce) frozen peas

2 tablespoon(s) butter

1 clove(s) garlic, smashed

1/2 cup(s) shredded Parmesan cheese, plus more for serving (optional)

Directions

In a large pot of boiling salted water, cook tortellini about 2 minutes less than package instructions. Add peas; cook until pasta is al dente and peas are tender, 2 minutes more. Reserving 1 cup pasta water, drain. Set aside pasta and peas.

Melt butter in pasta pot over medium-low heat. Add garlic; cook until fragrant, about 1 minute. Discard garlic.

To pasta pot, add pasta and peas, Parmesan, and 3/4 cup reserved pasta water; season with salt and pepper. Toss to coat. Add more pasta water, if necessary, to thin sauce. Serve, topped with additional Parmesan if desired.

## Crispy Greek-style pie

Ingredients

7 ounces spinach leaves

6 ounces sun-dried tomatoes packed in oil

4 ounces feta cheese, crumbled

2 eggs

5 ounces phyllo pastry

Put the spinach into a large pan. Pour over a couple tbsp water, then cook until just wilted. tip into a sieve, leave to cool a little, then squeeze out any excess water and roughly chop. Roughly chop the tomatoes and put into a bowl along with the spinach, feta and eggs. Mix well. Carefully unroll the phyllo pastry. Cover with some damp sheets of kitchen paper to stop it drying out. take a sheet of pastry and brush liberally with some of the sundried tomato oil.

Drape oil-side down in a 9in loose- bottomed cake tin so that some of the pastry hangs over the side. Brush oil on another piece of pastry and place in the tin, just a little further round. Keep placing the pastry pieces in the tin until you have roughly three layers, then spoon over the filling. Pull the sides into the middle, scrunch up and make sure the filling is covered. Brush with a little more oil. Heat oven to 350°F Cook the pie for 30 mins until the pastry is crisp and golden brown. Remove from the cake tin, slice into wedges and serve with salad.

#### **Lemon Caper Scallops**

10 large scallops

5 tablespoons butter

1 large lemon, peeled, 4 segments chopped and remainder juiced

2 tablespoons capers, drained

2 tablespoons chopped parsley

Directions

Season scallops. In a large skillet, melt 1 tbsp butter over medium-high. Add scallops; cook until golden, 3 minutes. Transfer to plate. Brown remaining butter. Add remaining ingredients; season. Spoon over scallops.
