BOARD MINUTES DECEMBER 18, 2018

Agenda items 1 through 3 Roll Call, Call to Order, Pledge to the Flag. Sharon Denson opened the meeting at 7:00 pm. A roll call was taken. Trustees in attendance were Jim Couey, Don Gassie, Terry Zimmerly, Dan Rawlinson, Sharon Denson, Steve Watkins, Jim Frost, Belle Baxter. A quorum was established. Barbara Susdorf joined the meeting later. Also in attendance were Dockmaster Robert Hindle, Jodie Lawman, Gwen Norris, Suzanna Young, Richard Nelson, John Lamb, Allan Riga, Barbara Greenberg and Debbie Korell.

Guest Attendee; Sharon introduced Mark Kincaid of Coastal Engineering (CEC). He said if they are to be the Engineer of Record for the (boat ramp replacement) project, then they need to have oversight of the project to sign off for the district for Manatee County for Construction Observations, for the DEP and for the Corps of Engineers. At the end of Mark's presentation, Sharon asked that Mark and Robert (Dock Master) talk on the project expectations/requirements. Both left the meeting to discuss the project.

Item 4. Approval of Board Minutes November 20th, Work Session November 12th – Steve moved to accept the minutes from the BOT Meeting of November 20 2018. Terry seconded. Steve moved to accept the minutes from the BOT Special Meeting of December 12, 2018. Jim Frost seconded. Jim Frost moved to accept the minutes from the BOT Work Shop of December 12, 2018. Belle seconded. All motions passed.

Item 5. Treasurer Report. A copy of the financials and Resolution 2018-08 was provided to the Trustees earlier. Steve moved to accept the Treasurer's Report, Jim Couey seconded. Terry stated that Resolution 2018-08 moves security deposit money into a new noninterest bearing account. Jim Frost moved to approve Resolution 2018-08, Steve second, **MOTION PASSED.**

Item 6. Trustee Committee Reports. House and Grounds Committee – Jim Frost said that Olive Branch contract gave a great deal on the landscaping railroad ties to replace the deteriorating ties. He said preparations are being made to convert the concession stand for the Dockmaster's new quarters. Price quotes are being received to repair the fishing pier, renewing the hall ceiling and getting quotes for key fob access for the rec hall and board room doors. Personnel Committee - Sharon said we need to recognize the employees and Christmas Bonuses are not allowed. She talked to the employees and proposed several options. Sharon moved to give a merit raise of \$1.00/hour to full time employees. Don seconded the motion, **MOTION PASSED.** All trustees voted in the affirmative. Personnel Committee - Sharon said employees have to use their vacation time by the end of December or lose it, per the Employee Handbook. Sharon moved to make the deadline for using 2018 vacation time by March 31st of

2019. Belle seconded the motion, **MOTION PASSED.**

Proposed Board Applicant - Sharon introduced John Lamb for a possible seat with the Board to replace Don, now at his last meeting. Jim Frost thanked Don Gassie for his years of service.

A Special Meeting has been scheduled for December 26th for contract issues if required.

Item 7. District Manager Respond to Trustees. The liability insurance issue for Hall Renters was discussed. Jodie said the average cost is about \$127 (for 150 people with alcohol). Sharon asked Jodie to find more companies that offer this insurance.

Old Business

Item 8. Marina contract with Coastal Engineering and Kelly Brothers Contact on the ramp. Jim Frost moved to approve the Kelly Brother's Contract to begin the ramp work. Jim Couey seconded the motion. There was no discussion and a roll call vote was requested. All voted in the affirmative to move forward.

Item 9. Agreement with Dockmaster to oversee Boat Ramp project. Robert Hindle, Dockmaster, stated that he talked with Mark earlier in the meeting. Mark agreed to work with Robert to assist in overseeing the construction.

Item 10. Concession Stand. – Sharon said the concession stand did not make enough money to pay for the product, salary, or Randy's trips to restock it. Jim Frost moved to turn the concession stand into an office for the Dockmaster and add library books from the board room. Jim Couey seconded, **MOTION PASSED WITH ONE NO VOTE.**

Item 11. Cure vote/s taken at emergency meeting on the 12th of December. Don moved to not buy the additional items as previously discussed. Jim Frost seconded, **MOTION PASSED.**

Item 12. Surplus Property, Slide and filing cabinets. Sharon asked Jodie to put the filing cabinets for sale in the Banner. Jim Frost moved to have his company to take the slide down for \$100 and scrap it with proceeds going to the district. Dan seconded, **MOTION PASSED.**

New Business

Picnic tables -Terry made a motion to have six picnic tables made by Randy in maintenance. Don seconded, **MOTION PASSED.**

Item 13. Railroad tie Project bid. Barbara and Steve have viewed the water and erosion at the beach. Jim Frost moved to accept Olive Branch quote to do the railroad tie work. Jim Couey seconded, **MOTION PASSED.**

Item 14. Hall Contract and exhibit 1004 HC and 1004 HR. Sharon moved to accept the new policies 1004 HS and 1004 HR. After some discussion, Jim Couey moved to table the issue, Terry sec-

onded, **MOTION PASSED.**

Item 16. Screen Room Contract and exhibit 1004SR and 1004SR. Sharon has added open flame restriction as #2 of the Rules excluding candles on a birthday or celebration cake. Steve moved to approve the policy. Jim Frost seconded, **MOTION PASSED** with one no vote.

Item 17. Public Hearing Policy and Guest definition 1030PH and 1030G. Sharon moved to accept the Public Hearing Policy and Guest definition, Belle seconded, **MOTION PASSED.**

Item 18. Bidding policy 1008 P. Sharon stated the policy addressed the different methods below and above \$20,000. She moved to accept the policy, Jim Frost seconded, **MOTION PASSED**

Item 19. Set up meeting with county and TE for canal dredging. Sharon said she is working with Trailer Estates (TE). She would like to set up a meeting (Town Hall) here in January or February with the County Commissioners. The TE Board will be invited. The silting issue is due to the runoff from the ditch north of Florida Blvd. into the canal. Sharon stated we are taxed by the county for the dredging.

Woodchoppers Shop - Steve said that he would like the Woodchoppers to be able to place the dust collector in the tractor shed adjacent to the Shop now that the mowing tractor has been sold. This issue will be revisited at the next work session. Steve said we have money for the Shop and wanted to get a larger AC unit. Jim Frost suggested a couple of mini split units (like Mitsubishi) for about \$800/\$900. Steve suggested purchasing units that also provide heat. Both issues will be brought up at the next work session on Jan. 2nd. Gwen said that they have a new door to install in the back of the shop. She said they noticed droppings at the back door of the Shop and the termites might be back. Jodie said the tenting was in 2014. She will ask someone to look at it.

Steve moved to adjourn. Terry seconded the motion. We adjourned at 9:35 pm.

Restore Bayshore met on Monday, December 10 at 6:30 pm at the Rec Center.

Gwen passed out a copy of the treasurer's report. Report, or "minutes" of November were published in November Banner.

There was a short discussion on electing new officers but nothing was decided at this time.

Order of business this meeting was to review the artists' comps of their pamphlet designs, sign letters to the Commissioners as well as Christmas cards and review our study on finding a yard light set-up that residents would find amenable.

Deciding on the best artwork that represented our community took up most of the meeting; it was more difficult than we thought. We did agree each pamphlet had something different to offer—very "adult" work for high school kids. Once we decided on the top one and the next two runners up, we revised some of the copy and a couple of photos.

Holly volunteered to work with the students whose pamphlet cops were selected as first and runner-up on a few changes. The completed artwork will eventually be shown to the Board of Trustees. We needed to make sure some info was included: the Website address, there was easy boat access to the bay and gulf, there is a Jr. Olympic pool, and in so many words, "classic mid-century modern" to describe our homes. Also, top information is a map or chart showing our location and that we are indeed on the bay shore.

In addition to sending cards to our

Commissioners, we included a letter commending them on their deliberations to put a demand traffic light at 26th and Florida Blvd. as the red blinking lights proved to have little effect.

The work on Florida Blvd. while pretty messy, is ahead of schedule.

More information is needed of creating a uniform aesthetic yard light program that is cost effective. We will price solar lights versus electric (LED) automatic switch units.

Meeting was adjourned at 9:00 pm.

2) **Monday, Jan. 7th,** Board Meeting 6:30 pm - At Bill & Terry's home.

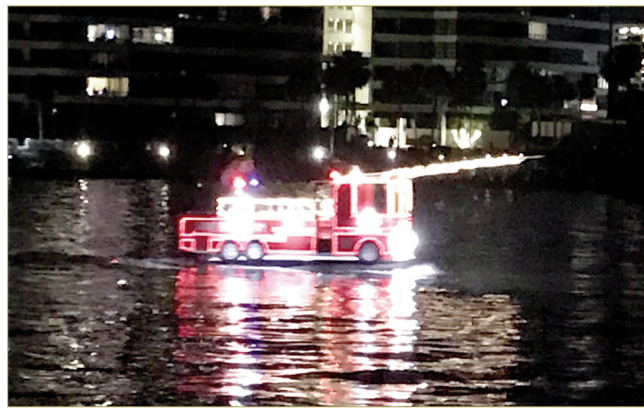

The newest application, which is currently being beta tested while still in development, is a Road Closures application. The tool includes an interactive map and table of current and upcoming

road closures around the county, including information about the reason for the closure, the expected duration and suggested detours. Website visitors are invited to provide feedback on the new application while it is in development.

All three tools are powered by Geographic Information System (GIS) technology.
