The meeting was called to order by Belle Baxter, Chair.

We reviewed the **pool party**. About 25 people attended and everyone had a good time. Some came just to meet new people, not to swim. As there were no lifeguards, swimmers were required to sign a waiver - no one had an issue with this. Some kids showed up and were told this is an adult party, people may be drinking adult beverages and many want to go in the pool, please respect the adult swimmers. A family arrived and were given the same information. Both groups agreed and stayed and did not interfere with partiers.

The success of the party has started the committee thinking about hosting "Happy Hour at the Pool" once a month.

The December 1- **Thanksgiving leftovers** party was confirmed. Residents will be invited to bring a beverage of choice and their Thanksgiving leftovers to the Rec Hall to contribute to a pot luck. The event will run from 4-7 pm.

As the hall is still being renovated the **family pot luck/movie night** has been moved to Sunday, January 19. Families are invited to bring their own dinner or something to share. Dinner will start at 5 and a PG movie will start at 6 pm.

This request, as well as email addresses of all the members was forwarded to me by Sharon Denson from her personal email address. I contacted all the members to advise them I want to discuss this with the rest of the Board. Musicians met three Monday nights every month. Sharon made herself available to open & lock the doors to the Hall. The musicians were allowed to use the Hall for two hours, three Monday nights every month, without being charged. I also asked how many of the group were Bayshore Gardens residents - only 1 person responded with a BSG address.
