Roof Coating Estimate

Scope of work: The entire roof will be cleaned with a degreaser, coated with a silicone base primer coat and a topcoat of 924 Eterna-Sil Premium Silicone Roof Coating

To address the leaks in the building the scope of work will be:

- 1. Clean each line of screws and transition with degreaser and hard brush
- 2. Remove existing loose sealant and tighten or replace any loose screws if possible
