Marina Referendum and Finances

This article further discusses the financial aspects of the proposed marina project and presents the actual verbiage of the referendum. The estimates haven't changed and are as below. Coastal Engineering has presented these preliminary estimates:

- Center Pier: 3,670 SF x \$65/SF = \$238,550 (Does not include electric and water)
- Center Pier Mooring Piles: 68 piles x \$600 = \$40,800
- Finger Piers: 2,200 SF x \$65/SF = \$143,000
- Finger Pier Mooring Piles: 93 piles x \$600 = \$55,800
- Boat Ramp and Boarding Pier: \$105,000
- Contractor Mobilization and Existing Structure Demolition: \$50,000

Budget numbers are based on construction of entire project without phasing. Phasing the project

could add as much as 10 to 20 percent to each element. Final designs have not been performed. Budget numbers are based on recent bids received for similar projects.

Dredging: 6,000 CY x \$43/CY = \$258,000 (Actual cost will depend on disposal site and trucking distance)

The cost for dredging and the consultant fees before construction will not be included in the capital improvement estimated figures or as part of the referendum, but will be expensed as maintenance and professional fees in our regular budget, per our auditors.

The referendum election is slated for Tuesday, December 6, 2016, at the District Recreation Center (Precinct #421) between the hours of 7 am and 7 pm. The language of the referendum is as follows:

The Marina Project – Part 5 The Referendum

The Florida state legislature created the Enabling Act that guides the District. One of the clauses in the Act states that capital improvement projects over \$25,000 must be approved by the voters in the district. The referendum will be held on Tuesday, December 6, and we ask that you come out and vote. Without your approval, the District will not be able to redo the boat launch or improve the marina.

You may ask "What is the purpose of the referendum? Is it to approve a tax or fee?" No. The referendum is simply for you to say "I approve/not approve this project that the District is working on"

You may ask "How does this affect me? I don't have a boat." Improving the boat launch and marina will make your home more desirable and more

marketable should you decide to sell your home. You may ask "How much more is this going to cost me personally?" The answer is nothing. The district has no plans to ask for a special assessment to pay for the project or to increase resident slip fees.

You may have heard rumors about the amount of money the District was going to borrow for this project. Those rumors are greatly exaggerated. Redoing the center pier was not in the original scope of the project. If, and it has not yet been decided, the District wants to rebuild the center pier, along with everything else, a loan or line of credit of at most \$500,000 would be necessary.

Even if this did happen, there would be no special assessments or increases in boat slip fees. The center pier can always be rebuilt at a later date.

(SAMPLE BALLOT)

Bayshore Gardens Park and Recreation District Board to make capital expenditures greater than \$25,000.

Per Section 2(7)(g) of our by-laws, Bayshore Gardens Park and Recreation District Board needs to rebuild and make the marina and ramp ADA compliant, and requires your approval for capital expenditures not to exceed Seven Hundred Fifty Thousand Dollars (\$750,000). Dredging and consulting fees of approximately Two Hundred Eighty Thousand (\$280,000) are not included. This is NOT a request for an additional assessment. Shall the Board make the required capital expenditures for the marina?

Whether all the work will be done sequentially, or whether the work will be phased over more than one year, total capital expenditures of not more than \$750,000 is what you will vote on. It is definitely a significant figure, but will NOT require a special assessment above and beyond our yearly assessment.

I have been approached twice this past month by residents saying they support the marina but are totally against the million-dollar loan. I have NO IDEA where this figure came from. It is wrong. The Board IS discussing borrowing funds for the project for the stark reason that it would be fiscally irresponsible to jeopardize the District's strong financial position. I will be investigating three types of loans: standard, construction, and line of credit. Preliminary queries to our bank indicate that since we are in such a strong position, a standard loan between \$400,000 and \$500,000 would likely come at 4.25% interest. I will further investigate all our options in the next 30 days and keep you advised.

This past fiscal year the marina generated \$162,000. I expect that figure to drop somewhat for this coming year because of the likely interruption of services. At any rate, within a low number years, the marina will pay for all these improvements and the loan, and our whole community will reap the benefits of a safe, ADA compliant, and refurbished marina and boat ramp.

Please remember to vote on December 6th for our marina.

Roll: Dan Rawlinson, Holly Clouse, Kathy Lokos, Debbie Korell, Maynard Boyce, Richard Nelson, Terry Zimmerly and Vickie Ford.

A quorum was established.

Present: Joanne Manse, Suzanna Young, Don Gassie, Rose Woodruff, Marie Young and John Woodruff

Holly made a motion to approve the September minutes. Debbie seconded. **Motion passed.**

Kathy made mention we will only be borrowing \$400,000 to \$500,000, if the referendum passes.

Holly made a motion to approve the September financials. Debbie seconded. **Motion Passed** with 5 yes and 2 no.

BGNA: Rose Woodruff for Dan Rawlinson

Rose reported that the BGNA meeting for October was held at Grill 41 and was great. Rose reported on the conference the board sent her to. DOCKMASTER'S REPORT

Seems hard to believe that we are closing in on yet another year's end. I know that it is two months away but factor in the holidays and time gets short fast. I mention this passing of time as I enter into my 7th year as Dock Master. I believe that we have been working toward the rehabilitation of our Marina at least since I started. Some significant repairs have been accomplished in that span but now after careful evaluation and planning it is time to finish the job. Even with all of the exhaustive research, planning, and cost analysis there is one last thing to accomplish prior to putting hammer to nail. You and I, the residents must give per-

mission to proceed. As a resident of over 30 years and an observer of what has gone into this planning, it is an easy choice. These are the questions that I feel most would want to know.

(1) Is the rehab necessary? Absolutely, not just our opinion, but that of the professionals we hired to evaluate the marina.

(2) Can the District afford it? Yes, and though we have the bulk of the cost on hand, we may secure a loan to make our financial position stronger.

(3) Will this impact my budget as a home owner? No, there are no plans to increase the annual assessment or other fees based on the cost of this project.

There are other articles in this edition of the paper addressing in detail what is going on with the Marina Project and the upcoming required approval vote. Take a look at these for further details on the referendum. To those of you in the community that enjoy boating, the convenience of having the marina or having the use of one of the only launch ramps in the south end of the county, you should support this. To those persons that enjoy the added benefit to their property because of these features we need your support. *Note: Must be a registered voter in the Bayshore Gardens voting precinct.* I really don't wish to sound triv-

ial about how important it is to get out and vote for the referendum but as I outlined above, to me, voting to approve is pretty much a no-brainer.

Reminders – Boat slip and trailer space fees were due the 1st of October. Gate Key annual renewals are also due. Please remember to provide your boat registration and insurance documents as well as your parking decal information (vehicle registration and proof of insurance) up to date with the office.

Improvements, Repairs and Projects Completed – Several planks were reattached or replaced on the finger piers and fish dock. The rehab of the boat stands continues. Some 4x4s and other posts were replaced. An electrical outlet, a water supply line, and a photo-electric sensor were repaired

A survey letter will go out early in 2017 either hand delivered or as a flier in the Banner.

There may be a map attached like the one shown below, or, residents can use the Bayshore Gardens map on the real estate page for reference. See the Sample survey letter in Oct issue.

Suggestions on collecting the surveys were: 1) to include envelopes addressed to the District office, 2) have door hanger bags; 2) teams from

Infrastructure Task Group to go out and personally collect them on given dates, and/or, 3) a key person or Block Captain would canvass their area for any missing surveys.

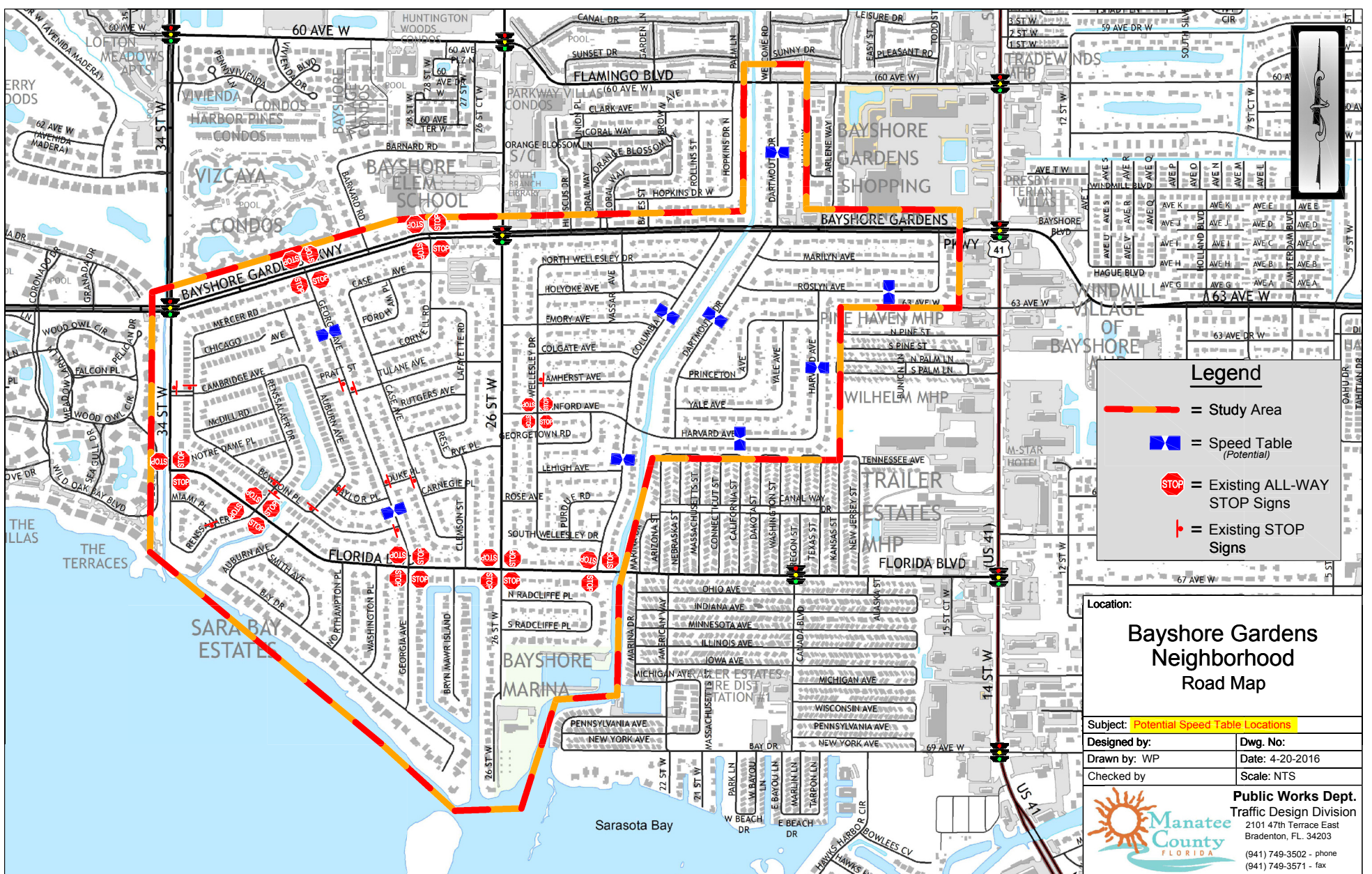

The dogs ignored the cars too and were almost hit, but for the quick response of the driver. The owner finally caught up to dogs so a disaster was averted.

Fences are good but the owners can never take the dog's behavior and size for granted, I witnessed that myself. I was even chased by a Chihuahua once, I was able to go faster than him. He tired out from chasing me and gave up.

Manatee County Animal Ordinance 12-10

Manatee County Animal Services has a new animal ordinance which took effect May 14, 2012.

We would like to provide the animal owners as well as the citizens of Manatee County a highlight of the ordinance.

Rabies vaccinations are required for all dogs, cats and ferrets. Manatee County license tag is required annually for dogs and cats, which they are required to wear. Dogs and cats are not allowed to run at large.

Your dog or cat must be on a leash no longer than eight (8) feet in length when the dog or cat is off the property of the owner and must be under the physical control of the owner or custodian.

All dogs and cats must be under the direct control of the owner or custodian while on the property of the owner or custodian. This means the dog or cat must be confined on the property by a fence (the ordinance does recognize invisible fences, provided they are in working order), chain, leash, or cord of sufficient strength to restrain the animal or the animal shall be attended and supervised by a competent person by hand or voice control when on

the property of the owner or custodian or property the owner or custodian has the right to use.

The ordinance requires pet owners to remove feces deposited by their animal from any public property or private property of another.

Animals are not allowed to be left in vehicles unattended. The extreme heat could kill your pet.

Animals are also not allowed to be left in the open bed of a pickup truck or similar vehicle without being confined in a carrier or restrained by a minimum of two tethers, each attached to opposite sides of the truck or other vehicle.

If an animal owner is issued a citation, he or she can elect to pay the citation or contest it in court. The person cited is allowed 30 days to make this decision, however, after this time period, if the citation is not paid or contested, they no longer have the right to contest the citation and may end up in jail if the fine is not paid.

Any dog can bite...

Even the cuddliest, fuzziest, sweetest pup can bite if provoked. Most people are bitten by their own dog or one they know.

Although media reports and rumors often give the impression that certain breeds of dog are more likely to bite, there is little scientific evidence to support those claims.

What's a dog owner to do?

Make sure your pet is socialized as a young puppy so it feels at ease around people and other animals.

Train your dog. The basic commands "sit," "stay," "no," and "come" can be incorporated into fun activities that build a bond of obedience and trust between pets and people. Avoid highly excitable games like wrestling or tug-of-war.

Keep your dog healthy. Have your dog vaccinated against rabies and preventable infectious diseases. Spay or neuter your pet. The available science suggests neutered dogs may be less likely to bite.

Be a responsible pet owner. License your dog with your community as required. Obey leash laws. If you have a fenced yard, make sure the gates are secure. Spending time with your pet is important. Dogs that are frequently left alone have a greater chance of developing behavioral problems. Walk and exercise your dog regularly.

Be alert. Know your dog. Be alert to signs of illness. Also watch for signs your dog is uncomfortable or behaving aggressively.

Tips that may prevent/stop a dog attack...

Don't run past a dog. Dogs naturally love to chase and catch things. Don't give them a reason to become excited or aggressive.

Never disturb a dog that's caring for puppies, sleeping or eating.

Never reach through or over a fence to pet a dog. Dogs can be protective of their territory, and may interpret your action as a threat.

If a dog approaches to sniff you, stay still. In most cases, the dog will go away when it determines you are not a threat.

If you are threatened by a dog, remain calm. Don't scream or yell. If you say anything, speak calmly and firmly. Avoid eye contact. Try to stay still until the dog leaves, or back away slowly until the dog is out of sight. Don't turn and run.

If you fall or are knocked to the ground, curl into a ball with your hands over your head and neck. Protect your face.

What should I do if my dog bites someone?

Even if the bite can be explained (e.g., someone stepped on your dog's tail), it's important to take responsibility for your dog's actions by taking these steps:

Restrain the dog immediately. Separate the dog from the scene of the attack. Confine the dog. Check on the victim's condition. Wash wounds with soap and water. Unseen damage can occur with bites, and can lead to complications.

Professional medical advice should be sought to evaluate bite wounds and the risk of rabies or other infections. Call 911 if a response by paramedics is required.

Provide important information including your name, address and information about your dog's most recent rabies vaccination. If your dog does not have a current rabies vaccination, it may be necessary to quarantine it or even euthanize it for rabies testing. The person bitten may need to undergo post-exposure prophylaxis.

Comply with local ordinances regarding reporting of dog bites.

If your own dog bit you, confine it immediately and call your veterinarian to check your dog's vaccination records. Consult with your vet about your dog's aggressive action. Your vet can examine your dog to make sure it is healthy, and can help you with info that may prevent more bites.

What if I am bitten?

If someone else's dog bit you, first seek medical treatment for your wound. Next, contact authorities and tell them everything you can about the dog: the owner's name, if you know it; the color and size of the dog; where you encountered the dog; and if, where, and when you've seen it before. In addition, consider asking your physician if post-exposure rabies prophylaxis may be necessary.

Dogs are wonderful companions. By acting responsibly, owners not only reduce dog bite injuries, but also enhance the relationship they have with their dog.

Information from the Florida Mosquito Control Association on Zika Virus

Zika is a virus transmitted by mosquitoes to humans. The virus has recently spread to the Americas. Symptoms of infection are usually mild, but severe complications including serious birth defects and various neurological and autoimmune complications can result from infection with the virus. Currently, there are no vaccines or medications available to prevent infection. Avoiding mosquito bites is the best defense against Zika virus infection.

Where can Zika virus be found?

Until 2007, Zika was a relatively obscure virus, confined to a narrow zone around the equator in Africa and parts of Asia. In Africa, it was known mostly from forest monkeys, but subsequent work indicates that humans were often infected but not diagnosed with the virus. In 2007, a disease outbreak on the Yap Islands in Micronesia, at first believed to be dengue or Chikungunya, turned out to be caused by the Zika virus. Later, outbreaks of Zika occurred in Polynesia, Easter Island, the Cook Islands, and New Caledonia.

In 2015 a large outbreak started in Bahia, Brazil and spread throughout South and Central America and the Caribbean. Large outbreaks of the disease have been reported from many countries in the area including Brazil, Colombia, El Salvador, and probably others that have not yet reported accurate statistics. In the continental United States, travel-related cases of the disease have been reported from several states, including Florida.

How is the virus transmitted?

Zika is an arthropod borne virus (arbovirus) principally transmitted by mosquitoes of the genus *Aedes*. In the Americas, the principal vector is the yellow fever mosquito, *Ae. aegypti*, but the Asian Tiger Mosquito *Ae. albopictus*, is a potential vector as well. These mosquitoes live in close association with humans, and occur in numerous types of water-holding containers such as buckets, plastic containers, discarded tires and other items often

found around human dwellings.. They do not live in ditches, marshes, or other large bodies of water. The Zika virus can be frequently transmitted from mother to fetus, and there is one documented case of the virus being transmitted sexually.

What are the symptoms of Zika virus?

About 1 in 5 persons infected with the virus develops symptoms, which are considered "mild". Primary symptoms include headaches, skin rash, fever, pink eye, general malaise, and muscle/joint pain. Little is known about potential long-term neurological effects of infection with Zika. Symptoms develop from two to 10 days after exposure and last approximately from 2 days to a week.

The fact that a large proportion of those infected are asymptomatic means that the daily routine of these infective persons will not be interrupted by the infection, potentially exposing them to mosquito bites and serving as a source for mosquito infection that can further spread the virus. The virus is usually present in the blood of an infected person for a few days during which a mosquito may acquire the infection by bite.

There is more unknown than known about complications resulting from Zika virus infection. For this reason alone, infection with the virus should be taken very seriously, and appropriate precautions should be taken to avoid infection. Zika virus infection in pregnant women can result in serious, even lethal consequences for the fetus. During the current Zika pandemic, a very high incidence of babies born with abnormally small heads and significant brain damage, a condition known as microcephaly, is being documented in mothers that were infected with the virus during pregnancy. Various health organizations, including the U.S. Centers for Disease Control and Prevention, recommend that pregnant women avoid travel to destinations where Zika is found. As with other viral infections, there also appears to be a connec-

tion between Zika infection and development of Guillain—Barré syndrome, a condition where the body's immune system attacks the peripheral nervous system.

What is the treatment?

There is no specific treatment for Zika virus infection. Given that the primary symptoms, if any, are usually mild, only supportive treatment (rest, fluids, and medications such as acetaminophen for fever and pain) are recommended. Patients should not take aspirin or other non-steroidal anti-inflammatory drugs until dengue has been ruled out because these drugs may aggravate bleeding associated with some forms of dengue.

How can I avoid infection with Zika virus?

As with other mosquito-transmitted pathogens, prevention involves limiting exposure to mosquito bites. The most important preventive action is personal protection, which means using protective clothing (e.g., long pants and sleeves) and an approved mosquito repellent, preferably one containing DEET. Because the mosquitoes that transmit the virus can reproduce in a variety of water holding containers, eliminating such potential mosquito developmental sites from the home is also important.

While the Florida Mosquito Control Association is not a response agency, our members include professionals in mosquito control, public health, academia, industry, and government who work with mosquitoes and the pathogens they transmit. We will share information provided from our members as new information comes to light.

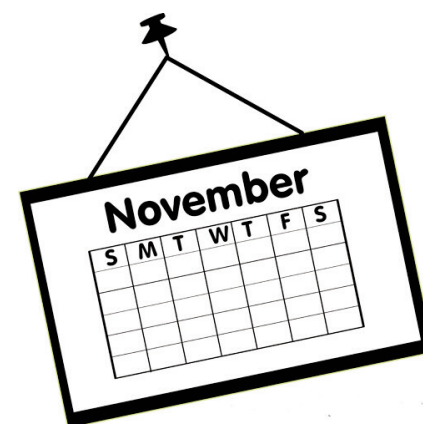

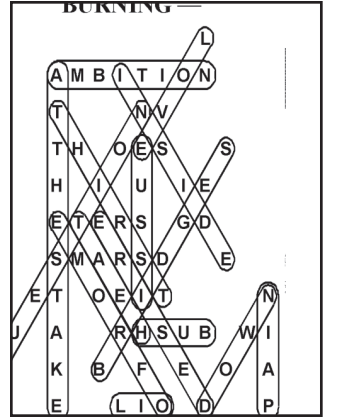

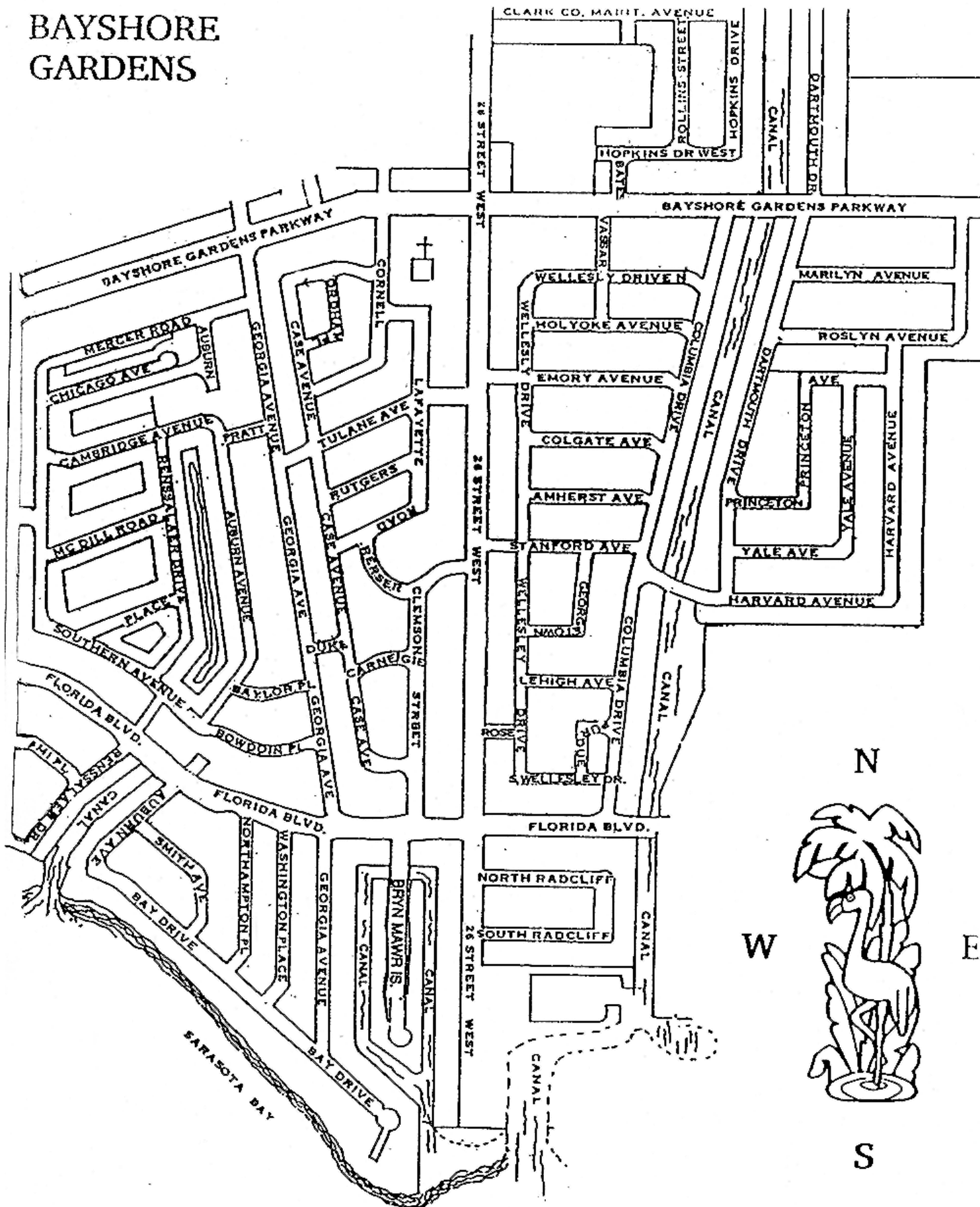

Shrimp Recipes

Shrimp Gumbo

4 oz vegetable oil; 1/2 cup diced celery
 4 oz AP flour; 1/4 tsp cayenne pepper
 1.5 lbs raw, whole, head-on medium shrimp
 2 quarts water; 1 cup diced onion
 1/2 cup diced green peppers
 2 tbsp minced garlic; 1 tbsp file powder
 1/2 cup peeled, seeded and chopped tomato
 1 tbsp kosher salt; 2 bay leaves
 1/2 tsp freshly ground black pepper
 1 tsp fresh thyme, chopped
 1/2 lb andouille sausage pieces, browned
 Preheat oven to 350. Place vegetable oil and flour into a 5- 6 qt cast iron Dutch oven and whisk together. Place on middle shelf of oven, uncovered, and bake for 1.5 hours, whisking 2-3 times during cooking. Dehead, peel and devein shrimp, place in bowl in fridge. Place heads and shells in a 4 qt saucepan along with 2 qts of water, set over hi heat and bring to a boil. Decrease heat to low and simmer for 1 hour. Remove from heat, strain liquid into container, discarding solids. Once roux is done, carefully remove from oven and set over med-hi heat. Gently add onions, celery, green peppers and garlic and cook, moving constantly for 7-8 mins or until onions begin to turn translucent. Add tomatoes, salt, pepper, thyme, cayenne pepper, and bay leaves and stir. Gradually add shrimp broth while whisking continually. Turn heat to low, cover, cook for 35 mins. Turn off heat, add shrimp and sausage and stir. Add file powder while stirring constantly. Cover and sit for 10 mins before serving.

Grilled Shrimp

16 jumbo shrimp, deveined in shell, raw
 1/2 cup Extra-virgin olive oil
 Coarse salt; black pepper; 2 lemons, halved
 Preheat griddle or grill pan over high heat. Butterfly shrimp, but leave shell on shrimp. Brush shrimps with oil, season with salt and pepper and grill 2 minutes on each side, until shells are hot pink and shrimp is opaque. Place lemons on grill the last minute. Squeeze grilled lemon to serve.

Baked Shrimp Scampi

2 lbs shrimp in the shell
 3 tbsp good olive oil; 2 tbsp dry white wine
 Kosher salt and freshly ground black pepper
 12 tbsp unsalted butter, at room temperature
 4 tsp minced garlic (4 cloves)
 1/4 cup minced shallots
 3 tbsp minced fresh parsley leaves
 1 tsp minced fresh rosemary leaves
 1/4 tsp crushed red pepper flakes
 1 tsp grated lemon zest
 2 tbsp freshly squeezed lemon juice
 1 extra-large egg yolk; 2/3 cup panko
 Lemon wedges, for serving
 Preheat the oven to 425. Peel, devein, and butterfly shrimp, leaving tails on. Place shrimp in a mixing bowl and toss gently with olive oil, wine, 2 tsp salt, and 1 tsp pepper. Allow to sit at room temp. In a small bowl, mash softened butter with garlic, shallots, parsley, rosemary, red pepper flakes, lemon zest, lemon juice, egg yolk, panko, 1/2 tsp salt, and 1/4 tsp of pepper until combined. Start from outer edge of a 14" oval gratin dish, arrange shrimp in a single layer cut side down with tails curling up and towards the center. Pour remaining marinade over shrimp. Spread butter mixture evenly over shrimp. Bake for 10-12 mins. To brown the top, place under a broiler for 1 minute. Serve with lemon wedges.

Easy Fried Shrimp

1 lb uncooked jumbo shrimp, peeled and deveined, tails left intact
 1/3 cup flour; 3/4 teaspoon salt
 1/2 tsp black pepper; 3 large eggs
 1 1/2 cups Kikkoman Panko Bread Crumbs
 Beat eggs until frothy. Mix flour, salt and pepper in another medium bowl. Dredge shrimp in flour, shake off excess. Dip shrimp into eggs, then press shrimp into Panko; turn shrimp over and press into Panko again to coat both sides. Fill pot with 2" of oil; heat to 350. Work in batches, add shrimp to hot oil; deep-fry about 1 minute. Using tongs transfer shrimp to paper towels

Shrimp and Grits

Grits: 4 cups chicken broth
 1/2 cup whipping cream
 1 cup quick cooking grits
 Salt and ground black pepper; 1 tbsp butter
 1/4 cup Parmesan
Shrimp: 2 cloves garlic, minced
 2 tbsp butter; 1/2 medium onion, chopped
 1 green bell pepper, chopped
 1/2 lb smoked kielbasa sausage, sliced
 2 lbs raw large shrimp, peeled, deveined
 1/4 cup dry white wine; chopped chives
 1 14.5oz can diced tomatoes
 In a heavy-bottomed saucepan, bring chicken stock and whipping cream up to a low simmer. While simmering whisk in the grits and a pinch of salt. Stir constantly and return to a low simmer. Cook until thickened, stirring often, about 5 minutes. Stir in the butter and cheese. Season, to taste, with salt and pepper. Heat a large saute pan over medium-heat. Melt butter and saute onion, garlic, and green bell pepper. Saute until tender and translucent, and add the sausage. When sausage has cooked, add shrimp and saute for about 2 minutes. Add white wine and diced tomatoes. Bring to a boil. Season with salt and pepper. Serve over Parmesan cheese grits. Garnish with chopped chives.

Shrimp Ceviche

1 lb raw shrimp, peeled, deveined, tail removed, cut into thin pieces
 1 cup freshly squeezed lime juice
 1 cup peeled, seeded, chopped cucumber
 1 cup seeded and finely chopped tomato
 1/2 cup chopped fresh cilantro
 1/2 cup finely chopped red onion
 1 serrano pepper, deveined, seeded, minced
To serve: Saltine crackers; Bottled hot sauce
 Place shrimp in a large mixing bowl. Add 1/2 cup lime juice and let stand for 15 minutes. In a large mixing bowl, mix remaining 1/2 cup lime juice, cucumbers, tomatoes, cilantro, red onions and serrano. Transfer vegetables into shrimp bowl, mix, salt to taste. Serve with crackers and hot sauce.
