Board of Trustees Meeting

Wednesday December 16, 2020 @ 7 pm

1-3. The Meeting was called to Order at 7:05 pm by John Lindsey. **Trustees Attending:** Barbara Greenberg, Melanie Woodruff, Terry Zimmerly, Barbara Susdorf, John Lindsey, Dan Rawlinson and Morris Raymer Absent: Steve Watkins and Lorna Pierce. A quorum was established. Pledge of Allegiance was conducted.

4. **Approval of Minutes** - Dan Rawlinson made a motion to accept the November 18th Board of Trustee Meeting Minutes. Terry Zimmerly seconded. **Passed Unanimously**

5. **Treasurer's Report** - Barbara Susdorf made a motion to accept the financials. Melanie Woodruff seconded. **Passed Unanimously**

6. **District Office Manager's Report** - Gia reported roof in the alcove appears to be leaking again. It was fixed back in August by Sarasota Roofing Co. they have been called, but we are still waiting for them to come back out and access the issue. Gia advised there is another issue with the pool that has nothing to do with the leak. The electrical panel and switches need to be replaced. We have only been able to get one quote so far as everyone that has come out states that it is too big of a project for them to take on. Right now, the pool is not running, and this will need to be fix as soon as possible.

Terry made a motion to not exceed \$4,000 to fix the pool electrical panel box with a stainless-steel box. Morris Raymer seconded. **Passed Unanimously**

Gia also wanted to let everyone know that Manatee County dropped off 2,000 adult disposable masks and 600 children disposable masks along with new 2021 calendars for our residents and they can be picked up in the District Office. Gia also advised that when she received the Manatee County Utility bill the bill for the rec. center was really high. Randy

discovered a leak in the men and women's bathroom in the breezeway and in the men's bathroom in the pool area. The leaks have been stopped for now. Terry said that it's just another indication that the plumbing is getting very bad over there and that is going to be the next big project that we will have to take care of.

7. **Trustee Committee Reports:**

• **House Committee Report** - Morris said that as you can see and hear the acoustic panels have been put up and they make a big difference in here. He would like to thank everyone who came and help put them up. Morris stated that he finally received three bids for the screen room and the cheapest one is \$49,221. Morris said the \$40,000 referendum is not enough for the scope of work that is required. Terry suggested that we possible talk to the contractor and ask them how big they can make the screen room and staying within our budget. Morris said that FPL is finally here getting the conduit in for the new electrical in the Marina.

• **Policy and Procedure Committee** - Melanie stated that she will have a meeting on December 23, 2020 at 7 pm to discuss the Marina Contract.

8. **Motion** - Signage and Park Hours - John Lindsey said that a motion was made a few months back to have the beach gate set from 7:00am to 8:30pm, but that is when it was getting dark later. John said those hours work great in the summer, but not after daylight savings. John said the other issue is that we do not have any signs that state when the park closes, and we have kids that are being very disruptive hanging out back in the park area and in the screen room. Barbara Susdorf said that the police have been down there a half dozen times in last two weeks. Susdorf said that she spoke to the Police one of the times they were here, and they said we need to get signs up as to when the park closes. Susdorf said she has also been looking into some cameras. She spoke to a few places and is still waiting on some quotes, but Big Fish quoted us

11. Agenda Motion Form - Banner Status - Melanie said that we need a Banner Committee. Dan volunteered to chair the Banner Committee. Lindsey appointed Dan Rawlinson.

12. Motion - Towing Contract - John Lindsey said that the towing contract that we currently have with CommTow references the same Florida Statue that Elmer's our old towing company did. CommTow is set up to only come in and tow someone when they are called and asked to.

13. Motion - 2021 Meeting Schedule - Melanie said that the dates have been moved around a bit and there are two different days now for committee meetings. Barbara Susdorf made a motion to accept the new 2021 meeting calendar. Terry Zimmerly seconded. **Passed Unanimously**

14. Agenda Motion Form - Resignation of Trustee - John Lindsey said that he is putting in his resignation effective immediately. Vacant seat will be posted on the District Website and in the Bayshore Banner.

15. Additional Agenda Items As Needed - No additional business discussed.

16. Adjournment - Morris made a motion to adjourn at 8:45 pm. Barbara Susdorf seconded. **Passed Unanimously**

He built and owned several boats including a Seafarer 24, Wavelength 35 "Morning Glory", Cal 25 and Stiletto 30. He collected many trophies over the years competing in events along the Gulf Coast, much of it with his kids. In more recent years, he enjoyed taking friends, family and even people he just met sailing on his Stiletto 30. Nothing made him happier than the love of his family and dogs, good friends, the perfect rum drink and a great day on the water.

Manatee Matters with Commissioner Misty Servia

We've got the power.

"In every community, there is work to be done. In every nation, there are wounds to heal. In every heart, there is the power to do it." – *Marianne Williamson*

I am re-reading [A Return to Love](#), by Marianne Williamson. I enjoy her writing, as she often talks about the power of individuals to transform the things around them - our relationships, our lives, our homes, our communities.

As your District 4 county commissioner, I believe my role is to help transform our corner of the universe to improve the lives of our residents and businesses now and for generations to come. And, as Williamson writes, we all have the power to do it.

I met with some of the largest landlords last week in south county and asked for their partnership to clean up some of the neighborhoods. Some neighborhoods are tired and in decline. One of the things I asked of the landlords is to have the residents park their cars in the driveway or on the street, but not in the front yard on the grass blocking the view of the home or across the sidewalks. Everyone around the table agreed that this would be nice and most even had standards in their rental agreement stating such, but most also threw up their hands in defeat, saying they have no control over the people they rent to.

Some homes in my district don't even have a driveway, so for them there is no choice. I offered my time and labor to help install driveways, but I don't think there is an interest to do so. In defense of the landlords, they explained that they face a constant cycle of repairing and rehabilitating a unit in order to rent it, only to have tenants tear it up again. They explain the people they rent to are too busy taking care of basic needs to care about where to park their cars. I get that.

So what do we do? We partner together and look for ways to help our district. How do we tackle the parking problem and other issues? One small step at a time. What if we can't find an answer? Then we keep looking.



We are all in agreement that it would help our neighborhoods if we can help one homeowner at a time solve the parking problem. We have many problems like this example that will take perseverance, understanding, education, and creativity to solve. And, as each one is solved, our neighborhoods become stronger. Lifting up each area helps with larger issues too, like crime reduction, increased public safety for our children, and increased property values for the landlords.

This week I will go on a tour of rental properties in two communities with landlords. We will be working together and I appreciate the collaboration. We can all benefit by helping each other, our community's families, and our neighborhoods; and we have the power to do it. We just need the will and drive to continue forward when faced with problems that are hard to solve.
