From Scott Rudacille - "...they have been paying BG assessments for at least 20 years. Assuming the Board has no strong feelings one way or the other, the path of least resistance here is probably to reach out to the two property owners and simply ask if they want to continue to be part of the District or not. If they do, then the District can pursue a charter amendment to include one or both of them. If not, then there is nothing needed to be done, as they are currently out of the District."

WE THE PEOPLE

We are an organization/discussion group of Bayshore Gardens Park and Recreation District residents who meet periodically in person, and via email, to discuss current community issues. All residents are welcome. There is no membership list and no membership requirement. There are no officers, only a group facilitator.

The most recent meeting/discussion was held in June, prior to the vote on Board's request for a \$20.00 increase in our assessment. Topics discussed were:

1.The fact that the residents were not informed of the amount of money currently available (just shy of \$900,000.00). Some of that money needs to be spent on expenses for the remainder of the fiscal year, but there was enough excess to pay for their pool project in addition to having between \$200,000.00 and \$300,000.00 left at the end of the year. This fact was presented as a result of a resident who examined the District financial records.

2.The fact that the pool project was not planned, was not in the budget for this year and was not even mentioned as a proposed expense until the wheels were already in motion to spend the money with no community input.

3.The fact that, despite repeatedly asking for \$3,000.00 (\$2.00 per household of the assessment money) by a member of the Long-Term Planning Committee, to spend on a community assessment in the form of a community survey it was rejected

in the new budget. This means that the community will have no input into the decisions of the Board of Trustees concerning how the assessment money will be prioritized to be spent.

It was the consensus of those present at the meeting that; given the amount of money already accumulated, given the fact that the Board of Trustees gave no rationale for asking for the additional \$20.00 raise in the assessment (how the additional money was to be spent), and given the lack of Board interest in community input, members felt that a raise in the assessment was warranted.

It was also brought up that our smaller children's summer play/cooling needs were not being met with the pool project, and since we had excess funds (that we were unaware had been accumulated), we should be looking at earmarking money for the needs of our children.

Any Bayshore Gardens Park and Recreation District resident is welcome to join our discussion group. If you would like to be part of our group, just send an email with your email address and you will be added to the email list.
