# The Marina Project Has Begun

At the resident assessment meeting, it was requested that the Board keep you updated about the status of projects the Board has in process. We thought it was appropriate we provide an update on the Marina project.

First, some background. The marina committee consists of both residents and board members. A team of people worked very hard to secure a contract with a marine engineer. This team consisted of Vicky Ford, Howard Taylor, Adam Hange, Don Gassie, Steve Watkins, John Woodruff (Dockmaster), Debbie Korell and Marina Chair Richard Nelson. The first step was to draft a RFP, a Request for Proposal. Special credit must be given to Vicky Ford for the countless hours she spent researching quality marine engineering firms to submit the RFP to. After the RFP was completed, it was submitted to the Board for approval and sent to a list of firms. After receiving some responses, four firms were requested to make presentations to the committee. (All of these meetings were public meetings that anyone could attend) After these presentations, three firms were asked to submit detailed proposals based upon the specifications of the RFP. These proposals were then reviewed in detail and the firms were asked to make modifications. This was to make sure we were receiving proposals that requested the same work from each firm.

After the modified proposals had all been received, the committee was ready to make its recommendation to the Board. The committee recommended Coastal Engineering, based on their experience, the number of projects completed in Manatee County, and the fact they had completed previous projects for other firms in our canals. The Board has never used Coastal Engineering in the past.

The Board received all of the proposals and the recommendation of the committee and there was discussion. The Board had some revisions to the contract and the contract was sent to the District lawyer for review. The lawyer approved the contract, added some documents to protect the district and the contract was returned to Costal Engineering for their approval. Coastal Engineering approved the contract and we are ready to begin the project.

It was decided that a project liaison was needed, during discussion by the Board. The role of the liaison is to have one central communication point between the Board and Coastal Engineering. The purpose is to foster and ease communications. The liaison has no decision-making capabilities. Debbie Korell was appointed Liaison by the Chairman of the Board. This work took over six months. As you can see, the Board was very careful about choosing the right marine engineer when setting up this very large project to help ensure that we have a successful project.

Where are we now? Coastal Engineering is doing fieldwork for our marina. These tasks are all specified in the contract and are as follows:

- 1. Review existing permits and related documents pertaining to previous construction to determine permit status and future permitting requirements.
- 2. Inspect the center pier and provide a concise report summarizing the inspection observations, engineering assessment and recommendations.
- 3. Probe the seawall panels to determine the depth of penetration and panel length.
- 4. Inspect the boat ramp and provide a letter report summarizing the inspection observation, engineering assessment and recommendations.
- 5. Conduct a jet probe survey to determine the presence of rock within the boat basin. Prepare an exhibit and table presenting the results of the survey.
- 6. Establish temporary survey control and conduct a bathymetric survey of the boat basin
- 7. Review the existing sediment sample report and if necessary take new sediment samples.

What happens next? After Coastal Engineering has completed their fieldwork, a meeting will be scheduled to review their findings. We then move on the next task, which is to begin the predesign alternatives for marina design, slip design, finger pier replacement (including width of finger piers), dredging, and boat ramp.

We know that the American Disabilities Act (ADA) will impact our project. Two finger piers, (for four slips); will meet all current ADA standards. This fact alone will impact the layout of the marina. We also know by studying the history of the dock masters report that there has been a waiting list for large slips and an abundance of small slips. One of our goals is to rectify this problem and design a marina more fitting to boaters in the 21st century. *Continued on page 3*

# Restore Bayshore Reports

#### It's in the Works!

Monday, May 9, 6:30 pm, meeting of the Infrastructure Task Group started off at a lively pace. With us to report from the County were Cheri Coryea, Director, and Ivan Groom, Redevelopment Coordinator of Neighborhood Services. Commissioner, Robin DiSabatino joined us as well as 17 tuned-in residents.

What is in the works is the information we provided to the County on 1) side walk priorities, and 2) Speeding problems throughout Bayshore, noting particular problem streets and risky pedestrian areas. Utmost concern is our pedestrians are at risk when walking on any street without a sidewalk.

All our new street paving was already in the County works and they look great.

Here are the basic updates given by Ivan and Cheri:



# Article of May

Mr. Taylor's letter to the editor in May's starts out with some accurate observations of current marina conditions and repair needs, but then slides into a mire of misinformation and some long tall tales. He throws false accusations

and insults around with no consideration of good people. Also, since I was a target (per his many emails) last Oct 2015, when the marina rates were raised, and since these emails contained outright fabrications about me, I need to finally stand up for myself and clear the deck.

Apparently, Richard Nelson and I were named as culprits in the marina slip fee increases last October. I was charged as having "sway with the Board" and that I (along with Maynard), "hoodwinked the Board" into raising the rates. However...

\*Marina rates were a Board decision—more to do with budgeting to finish the much needed renovations—not any one person's opinion.

\*It is a fact I was not even a Board member. I had

\*Neither did I have "sway with the Board" as charged. Truthfully, I had No influence on the slip fee issue whatsoever.

\*No one "hoodwinked" the Board; that Board did not "hoodwink" easily. Neither does the one now. Maynard Boyce was/is the Board Chair, he can only vote to break a tie.

In Mr. Taylor's complaints about the "blunders" made, it is interesting that some of the incidents, like in 2015, reflect back on back on him:

The 1998 Center pier rebuild was overseen by a resident engineer. After completion, serious problems were found that cost time and money. Also, an opportunity was ignored (2002-3) that for \$10,000 we could get 20 poles sunk into the hardpan to anchor the pier. The then marina committee did not consider this as an advantage. Boat owners did not make a fuss. No one was paying attention?

One reason seawall caps were wrapped 18" down was to cover and protect the tie-back bolts. Our former marine engineer had seen a big problem: the bolts and plates connecting the former tie-backs to the seawall helped accelerate tie-back deterioration because simple maintenance of keeping the plates covered from the elements

In Reference to Howard Taylor's Opinion with marine tar was not done. No one was paying attention.

> The (big) expense of updating and re-installing the marina utilities he keeps complaining about did not have to happen. At a Board meeting Sept. 2010—five years, 8 months ago, the Marina Chairman, (Suzanna Young), presented several items: 1) A \$2.00-per-foot slip charge, 2) An estimate on the cost of laying in new utilities before the last seawall cap phase even began; 3) Estimates of new finger pier construction and, 4) a guesstimate on the cost of dredging 5 years down the road—around 2015.. All this was from competent companies.

> This information was on hand-outs. Mr. Taylor was against any slip fee changes so he had to have known about the other items. But what happened to this information?

> Fall of 2015, I was abruptly dismissed as Marina Chair.(Mr. Taylor, may know more about that than anyone.) But why did not he or anyone ON the Marina committee utilize that information in a timely manner? It sure could have saved us all that money he complains about.

> He is now charging that in the process of reconfiguring slip spaces, they will not match placement of the cleats anchored in the seawall. Nothing was supposed to be imbedded in the seawall caps. This was a strong recommendation by the (qualified) marine engineer in the 2nd phase of marina renovation. New seawall builds showed concrete or dock poles sunk behind the seawalls (quite secure) so the caps retain their integrity for a longer period.

Mr. Taylor demanded the Board of Trustees install Suzanna Young

cleats in the seawall caps.

Now, our current engineers will have to deal with that as new, safer pier design and new codes will change pier placements to some degree.

Reduced boat slips? A few. It is a known fact some small boat slips consistently sit vacant but could boost income if converted for mid or larger boats after dredging. After dredging, a few slips will become usable as well.

Currently, the District has engaged a qualified Marine engineering firm who is engineering the job of re-building deteriorating finger piers, boat ramp repair and long over-due dredging. Board and the Marina Committee are being cautious that money is spent carefully.

No, we don't want to make more blunders and the prudent path is having a qualified company that will be accountable rather than individuals who might be out of the picture in the future ...which seems to happen all too frequently!

We don't have "a dog in the fight"? I beg to differ, while we don't have a boat in the marina, this I do know: this marina is a huge asset to every home in this community. However, it deserves proper care, not Band-Aids. Count the communities who have their own waterfront facilities that you can afford. (Are there any?!) The District is compelled to do the right thing.

Marine contractors and engineers tell us we have a class marina; surely it should be something of great value to our boaters and residents alike.

Participants who complete the training and internship portion of the program are certified as "FLORIDA MASTER GARDENERS" by the University of Florida Cooperative Extension Service. Working with the Urban Horticulture Extension Agent, Master Gardeners provide volunteer service by disseminating horticultural information to the public in Manatee County. This consists of such things as answering gardening questions, conducting plant diagnostic clinics, working in the Extension's Educational Demonstration Garden, and other activities to promote Florida-Friendly, scientific-based horticultural practices. Each year, a minimum number of volunteer hours and continued education units are required in order to maintain status as a Florida Master Gardener.

Manatee County is one of the three original counties in Florida to hold Master Gardener training; the program has been in place since 1979 and has provided training to hundreds of quality volunteers. This year's class topics include basic botany, entomology, vegetable gardening, wildlife, diagnosing plant problems, plant identification, citrus care, plant propagation, turf selection and care, and many other subjects. Prior gardening experience is not required.

# Sizzling Summer Vegetables, By Nancy Hammer, Master Gardener 2014, May 2016 - Volume 51 – Issue 5

If you are from up north, you know spring is when • Yard long beans: Plant throughout the summer. vegetable gardeners joyfully plant tomato seedlings and look forward to juicy slicing tomatoes as summer unfolds. Experienced Florida veggie gardeners know otherwise. Many take a break in the summer months and enjoy the pool, beach, and A/C. However, with correct plant selection, summer vegetable gardening in Florida can be very, well, fruitful!

Here are some vegetables that can thrive in our heat and humidity.

- Okra: Recommended varieties include Clemson Spineless, Emerald, Annie Oakley II, and Cajun Delights. Plant through the summer until September.
- Sweet Potato: Centennial, Beauregard, Vardaman, and Jewel. Plant through summer until September.
- Southern peas (field peas, cow peas, crowder peas); California Blackeye No. 5, Pinkeye Purple Hull, and Texas Cream. Plant through the summer until October.

- Luffa (Luffa spp.): Plant until September.
- Seminole Pumpkin (Curcurbita muschata): Plant until September.
- Malabar spinach (Basella rubra)
- Okinawa spinach (Gynura crepioides)

If you currently have cherry tomatoes, peppers, or eggplant, and they are still healthy, they may continue to produce fruit into the summer months.

Should you want to explore other options, consider trying varieties from Southeast Asia and Caribbean countries, Israeli varieties, and Southern heirlooms.

Sources for seeds include Southern Exposure Seed Exchange, Seed Savers Exchange and other online suppliers. Detailed information on Florida vegetable gardening, including a table of planting dates can be found online at UF/IFAS Florida Vegetable Gardening Guide.

If you and your vegetable garden prefer to have a

break during the summer, take advantage of the heat by solarizing the soil to kill harmful nematodes, other insect pests, and weed seeds. Look online at UF/IFAS Gardening Solutions, Soil Solarization for how-to info.

Alternatively, consider cover crops for the summer, which will prevent erosion during heavy summer rains, discourage weed growth, add nutrients and organic matter, improve soil texture, and interrupt insect and disease cycles.

More information, including suggested cover crop plants, can be found online at UF/IFAS Gardening Solutions, Cover Crops.

Finally, we invite you to tour our educational gardens at the Manatee County Extension office. We have examples of how to successfully grow vegetables and herbs in raised beds, a variety of containers, and salad tables. The okra is spectacular in the summer!

# Be Safe Out There Joy Derksen, Master Gardener 2004

Gardening is healthy for us. We get beautiful surroundings, yummy vegetables, free exercise and vitamin D. But there are also many ways that summer gardening can be dangerous in Florida. We have climate, wildlife, and insects working against us.

Happily, experienced Floridians also know ways to keep gardening in good health. "Mad dogs and Englishman go out in the midday sun," is a lyric from an old song by Noel Coward. Obviously, he didn't know many Florida gardeners! Probably the biggest danger to Floridians is heat and the health risks that come with too much sun exposure. How can we keep ourselves safe from heat while gardening?

Gardening early and gardening late before 10 am and after 5 pm is one way to stay a little bit cooler and to avoid those direct and hotter rays. Wear a hat, wear sunscreen, and stay hydrated. Consider a long-sleeved sport shirt that has vents in the back. Drink a glass of water before you go out and stop for frequent water breaks. Check your medications for those that cause you to be more sensitive to the sun.

Heat exhaustion and heat stroke are illnesses from too much sun. Don't let it get that far. If you are dizzy, thirsty, having headaches, are nauseated, and/or having muscle cramps you've overdone it. Get cool immediately and drink more water.

If you've conquered the heat, remember our wildlife. Any wild animal around humans during the day is not normal. Remove yourself from the area and call wildlife control. Become familiar with our local snakes. Most of them are your friends!

A good online publication by the University of Florida helps identify Florida snakes: http://edis.ifas.ufl.edu/uw258. Wear gloves and closed toe shoes, as even a nice snake hiding under a bush or in a gardening pot will feel obliged to bite a hand or foot that has accidentally smacked it. We do have a few venomous snakes in the area. In my yard I have a corn snake (non-venomous) that seems to live in the coconut palm and a black snake or two (also non-venomous) that roam under the landscape hedges, but I have run into a pygmy rattlesnake crossing the back lawn.

troublesome than the animals. Keep fire ants under control in your garden. Practice good mosquito avoidance as they carry many unpleasant diseases for you and your pets. "Florida Resident's Guide to Mosquito Control" is available at the Extension office or online at http://edis.ifas.ufl.edu/pdffiles/in/in104500.pdf and includes a guide about what mosquito repellants work and for how long. Wear a mosquito repellant.

# Healthy(ish) Party Appetizers

#### **Roasted Tomato Hummus**

- 3 tbsp extra-virgin olive oil, divided
- 2 cups cherry or grape tomatoes
- 1 can garbanzo beans, drained and rinsed
- 1/4 cup tahini
- 2 tbsp lemon juice 1 tsp smoked paprika
- 1 tsp fresh thyme leaves
- 2 min along a source sold
- 2 pinches coarse salt
- 2 pinches freshly ground pepper
- 3 cloves garlic

Preheat oven to 400°F. On a rimmed baking sheet, toss the tomatoes with 1 tablespoon oil, garlic cloves, the paprika, thyme and a pinch of salt and pepper. Roast 15-20 minutes, until tomatoes have wilted. Remove from oven. Transfer the tomatoes and garlic to a large food processor. Add the garbanzo beans and pulse a few times. Add the tahini, lemon juice, remaining oil (only if it's too thick) and another pinch of salt and pepper. Blitz until smooth, 5 - 10 seconds. Serve inside a carved-out tomato, or bowl. Have pita bread and veggies on the side for dipping.

#### **Cheesy Buffalo Cauliflower Tater Tots**

- 3 cups shredded cauliflower
- 4 oz sharp cheddar cheese
- 1 large egg; 1/2 cup all-purpose flour
- 2 tbsp Buffalo hot sauce, + more for serving Pinch of salt

Preheat oven to 400°. In food processor, pulse cauliflower until it's finely shredded. In a medium bowl, stir together shredded cauliflower with grated cheese, egg, flour, hot sauce andpinch of salt. If the mixture is very wet and doesn't hold its shape, add more flour by the tbsp until desired consistency. Lightly oil a baking sheet and measure out heaping spoonful-sized balls onto the sheet. Don't worry too much about shaping them, but do leave some space between each ball. You should get 20-25 tots. Bake the tots for 15 minutes until lightly crispy on the bottom. Then flip and bake for another 15-20 minutes until very crispy. Remove tots and serve with extra hot sauce!

#### **Baked Portabella Fries**

1/2 cup all-purpose flour

2 eggs

1 cup Italian style bread crumbs

1/4 cup shredded Italian cheese blend

1 tsp Montreal steak grill seasoning

2 portabella mushroom caps, cut into 1/4-inch slices

Cooking spray

1 tbsp shredded Italian cheese blend

1/2 cup organic tomato ketchup (or any ketchup you prefer)

Heat oven to 425°F. Line large cookie sheet with foil or cooking parchment paper. In shallow dish, place flour. In another dish, beat eggs slightly with fork. In third dish, mix bread crumbs, 1/4 cup cheese and the grill seasoning. Coat mushroom slices with flour, then dip in eggs and coat with bread crumb mixture. Place mushrooms on cookie sheet; spray mushrooms lightly with cooking spray. Bake 8 to 10 minutes, turning once, until golden brown and crispy. Sprinkle fries with 1 tbsp cheese. Serve hot with ketchup.

#### **Spring Garden Bites**

4 oz. whipped cream cheese, softened

2 tbsp carrot, finely grated

2 tbsp fresh dill, finely chopped

1/2 tsp celery salt

1/2 tsp garlic powder; 1/2 tsp onion powder

1/2 tsp fresh ground pepper

24 snap peas

6 radishes, thinly sliced

Fresh dill

In a small bowl stir together cream cheese, carrot, dill, celery salt, garlic powder, onion powder and pepper. Transfer to a plastic icing bag. Snip a small portion from the top of the bag. With a small, sharp knife, place snap peas on their side and gently cut along the top edge of the pea to open it up. Pipe a small amount of cream cheese mixture into the bottom of each pea, press 2-3 radish slices into each pea pod. Garnish with a small sprig of dill. Place on a serving platter and enjoy.

#### **Hummus Cups with Zucchini & Tomato**

1 13.8 oz roll refrigerated artisan pizza crust

with whole grain

1/2 cup hummus

1/2 cup zucchini, diced

16 grape tomatoes, halved

Heat oven to 400°F. Lightly spray 20 mini muffin cups with cooking spray. Use a rolling pin to roll pizza dough into a 14 x 12 rectangle, approximately. Use a 2 1/2" round cookie cutter to cut out 20 circles of dough. Press each circle of dough into the bottom of the muffin cups. Then use a fork to pierce the bottom of each pizza cup 3-4 times. (This will help prevent the bottoms of the pizza cups from rising). Bake pizza cups 8 to 10 minutes or until edges are light golden brown. Transfer cups to a cooling rack then cool completely. Spoon a teaspoon of hummus into the bottom of each cup. Then top with two tomato halves and a few zucchini pieces. Serve immediately.

## **Roasted Garlic-White Bean Dip**

1 head garlic

Olive oil and sea salt, for roasting

2 15 oz cans cannellini beans

1/2 tsp Italian seasoning

1/2 tsp paprika

1/4 tsp cumin

1 tbsp balsamic vinegar

Salt and pepper, to taste

Chips and veggies, for dipping

Heat oven to 425°F. Slice off the top third of a head of garlic, then drizzle with olive oil and sprinkle with sea salt. Cover with foil and bake 50 minutes to 1 hour until soft and golden brown. Drain cannellini beans, reserving 1/2 cup of the liquid. Rinse beans, then transfer to the bowl of a food processor. Add roasted garlic pulp, Italian seasoning, paprika, cumin and balsamic vinegar. Pulse, slowly adding in liquid, until mixture is thick and smooth. Stir in salt and pepper to taste. Serve dip with frozen edamame pods, cooked, and tortilla chips.




