# The Marina Project, Part 3. All about the Boat Launch and Referendum

For quite a period of time, the District has received comments about the status and condition of the boat launch and the need for repairs. Since the beginning of 2016, the District has been working with a marine engineer to create a plan and the necessary work for the District to be able to improve the conditions at the marina.

We have completed the design work and are ready to apply for permitting. The first project scheduled for completion is a complete rebuild of the boat launch. The new boat launch will be a full 17 feet wide. The slope that vehicles back down to launch will be made less steep. (This is an existing complaint: the existing slope is too steep). At a point below the waterline, the slope will become more steep, making it easier to launch your boat. There will also be a new pier, meeting all American Disability Act (ADA) requirements. The narrow pier running within the launch will be removed. There will also be a new docking pier. This pier will have pilings along the canal side of the pier, making it easier and safer for you to be able to board.

However, because of the Enabling Act, (the piece of legislation approved by the Florida State Government that created the District), the District is not allowed to spend over \$25,000 on a capital improvement project without the approval of the members of the District. We are required to hold a referendum so that the voters in the District can

vote to support or not support the project.

The referendum is tentatively scheduled to be held on December 8, 2016. If you are a registered voter in Bayshore Gardens, precinct 426, you come to the Rec Center on that day and vote yes or no. The process is just like voting in any other type of election.

If you want the district to be able to correct the problems with the boat launch, we need to have approval of the referendum. We are asking you to come out and vote. Without the referendum being passed, the improvements to the boat launch and marina will not be possible. The District currently has no plans to ask for a special assessment to pay for the project or to increase current marina fees.

The purpose of the referendum is to gain your approval for the project to proceed. It is not a request for funding.

There will be an open meeting on November 9th that will feature a presentation on the project and a question and answer session. The new designs will also be available for you to see.

Thank you for your support and we hope to see you on November 9th and, tentatively, December 8th.

## Marina Referendum

The work needed to bring the marina into specification will require a far greater amount of money than the District is permitted to spend without community approval according to our bylaws. A marine consulting firm has been brought in to assess the marina, consider reconfiguration including slips compliant with the American Disability Act, offer possible designs, and oversee the project.

The District Board will be coming to our Bayshore Gardens community for a referendum covering the capital improvement part of expected expenditures. The cost for dredging and the consultant fees before construction will not be included in the capital improvement estimated figures or as part of the referendum, but will be expensed as maintenance and professional fees in our regular budget, per our auditors.

Coastal Engineering has presented these preliminary estimates:

Center Pier: 3,670 SF x \$65/SF = \$238,550 (Does not include electric and water)

Center Pier Mooring Piles: 68 piles x \$600 = \$40,800

Finger Piers: 2,200 SF x \$65/SF = \$143,000

Finger Pier Mooring Piles: 93 piles x \$600 = \$55,800

### Fall Festival of Music

Boat Ramp and Boarding Pier: \$105,000  
Contractor Mobilization and Existing Structure Demolition: \$50,000

Budget numbers are based on construction of entire project without phasing. Phasing the project could add as much as 10 to 20 percent to each element. Final designs have not been performed. Budget numbers are based on recent bids received for similar projects.

Dredging: 6,000 CY x \$43/CY = \$258,000 (Actual cost will depend on disposal site and trucking distance)

We hope to have the referendum election before the end of the year, probably to cover all the capital improvement expenditures even though rebuilding the marina may be phased over a few years. It will be a significant figure, but will NOT require a special assessment above and beyond our yearly assessment. The recently increased slip and gate fees will generate sufficient funds to pay for these improvements within a reasonable number of years.

Our marina is one of Bayshore Gardens greatest assets, not only for our boaters, but for all of us in the increased property value of our homes. Please vote yes on the referendum to rehabilitate our marina.

## A new way to pay for local roads, parks and public safety

This fall Manatee voters will vote on a half-cent sales tax for infrastructure. The half-cent would raise an estimated \$30 million a year, \$5 million of which would be distributed to Manatee County's six municipalities. Manatee County Government would use proceeds for major road upgrades to improve traffic throughout Manatee. Other would go toward public safety, law enforcement, parks and preserves.

Manatee County Commissioners have held our property tax rate flat since 2006 -- throughout the Great Recession. Property tax revenues today remain 18 percent lower than in 2007 and the County's workforce has been reduced by 300 positions. Since that time more than 50,000 residents have moved to Manatee County putting a huge strain on local resources.

During the storm the center pier was under water a few times and the finger piers more than that. The county had a failure of the sewer lift station, located by the boat ramp, which forced the running of large tankers around the clock for three or so days. Only minor damage to the marina occurred. A few planks floated away with the high water and a tree fell over by the fish dock.

Other than that things in the marina are moving along with the paper work for permitting complete and ready for submittal and preparations for the marina project referendum under way. You will

see articles elsewhere in this edition of the paper addressing in detail what is going on with the marina project and the upcoming required approval vote. # Restore Bayshore Reports

## OPTIONS FOR SPEED CALMING ARE OFFERED AS A POSSIBILITY IN BAYSHORE GARDENS!!

Meeting opened 6:35 pm, Monday, Sept 12 with a small crowd of 7 but a big discussion followed.

At the August meeting, Anthony Russo, Project Manager for Public Works, presented speed-calming methods, a long, loud and prevalent complaint in this community.

Suzanna explained that a survey letter (shown in this issue) might go out to all residents possibly via the Bayshore Banner or hand delivered. This would help find out: 1) who wants a speed table, and 2) where they would like them located.

Locations for dangerous or risky crosswalks, speed problem areas, dangerous roadways for pedestrians and bicyclists were pinpointed at previous Infrastructure workshops. The County has mapped these preferences but nothing is cast in bronze.

To install signs, crosswalk signs, speed tables, etc, 67% approval from surrounding residents is needed. Questions came up: How big an area would comprise of a "surrounding area"? Suzanna will pose this question and others to the public works and have them explain at the next meeting.

Jeannette and Mike Taylor reported on their interactions with Traffic Management and results with the electronic speed signs you have seen on 26<sup>th</sup> Street. While they were effective, they are not permanent and have to be rotated around the county. She will look into the cost of a permanent electronic speed sign and double blinking lights on speed limit signs.

Resident "slow down" signs are reappearing in yards. Please keep them on your set-back or property side of sidewalk.

Most all the speeding citations handed out are not Bayshore Gardens residents. However, our side-street residents report that speeders are local. They discovered that the sign "To US 41" at 26<sup>th</sup> and Florida Blvd. was not positioned on 26<sup>th</sup> at the Parkway, 57<sup>th</sup> or 53<sup>rd</sup>! She made the County aware of that and one was installed at the Parkway right away. Good going Jeannette and Mike.

The bicycle lanes have not proven too effective in calming speeders. Mike suggested we ask the County for specific neighborhood caution type signs. Pedestrian Crossing being a priority, as well as 'children playing, wheelchairs; bicyclists, etc. Meanwhile, we will continue with plans to generate our own signs as shown in previous Banner issues.

Meeting was adjourned at 8:35 pm. **Next meeting is Monday, October 10, at 6:30 pm.** Bayshore residents are urged to participate in making plans for the community's future.

## What do you know about your Crime Watch? *Suzanna Young (edited by Steve Watkins)*

Bayshore can still be defined as a community; not just a neighborhood. People seem to notice, or are merely aware that we do have boundaries or a perimeter and that we support the Bayshore Gardens District Recreation Center.

Bayshore Gardens also has an organized volunteer Crime Watch (CW) which is based in a small office at the recreation center. They have been organized and have helped keep the subdivision safer since mid 1977 and are a well-equipped group that gets little or no notice but works quietly in and around the area. CW by any definition, watches for signs of suspicious and criminal activity. They cannot make arrests or collar perpetrators, but if they see something wrong they call in the (paid) law-enforcement. Still, people need to understand, community Crime Watch members are not allowed to touch perpetrators.

For years now, CW has been securing the beach gate at the Park & Recreation Center so residents can still take their cars to the beach park and playground area until sunset. At sunset CW volunteers drive down to the beach every evening and ask the patrons to move their cars to the main parking lot in front of the recreation hall, letting them know they can still remain in the park until 10 p.m. CW is also responsible for opening the gate in the morning for all holidays.

On behalf of Bayshore residents, the District compensates CW for this with gas money.

Crime Watch members, excepting a few retirees, have regular jobs so understand they can't be out around the clock as most do need to sleep, but they volunteer their leisure time to watch for the neighborhood. These people take this duty seriously and with a professional attitude. CW's motivation?

The pride they have in their community and their part — large or small — to make your neighborhood safer.

To maintain equipment and operating money, fundraising is necessary. CW conducts successful Attic Sales to buy the equipment they need for making rounds and communicating and occasional donations to other causes in the community.

Another bonus for you as property owners: an active Crime Watch is a plus to any community from a buyers point of view.

You may not think they're around, but they are touring the subdivision by vehicle — some even cruise on a bicycle— and some monitor their street on foot, but they are out there, watching out for you.

511 is the number provided by FDOT to call to give or receive information of closed roads. Text messaging usually works when cell phones won't get through. Another valuable tool is to register for the Code Red Service@mymanatee.org/emergency. It will send warnings to your phone when a disaster is near.

Another item of interest: Jeannette Taylor reported that the flashing speed limit warning signs on 26th street have been removed by Manatee County. 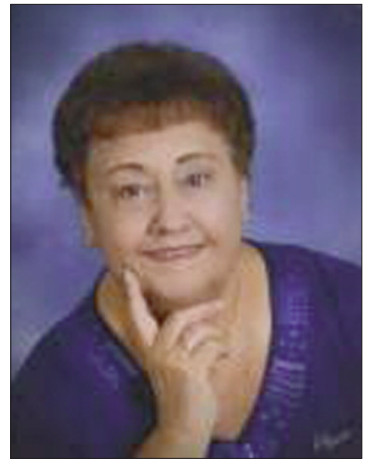

## If You Operate One of These on the Streets in Bayshore Gardens, Be Legal!

Several golf carts have been seen recently motoring around the neighborhood and at the recreation center area. Most have been seen after dark. Some do have the required lights, some with "no lights" and one with a "yellow blinking" light on the roof.

The sheriff's office has recently issued a 2 page FAQ document outlining the requirements for driving golf carts in Manatee County and the ordinances governing their operation.

## Golf Cart FAQ



#### What is the legal definition of a "golf cart"?

A motor vehicle designed and manufactured for operation on a golf course for sporting or recreational purposes that is not capable of exceeding speeds of 20 miles per hour.

#### Am I allowed to operate my golf cart within my "self-contained" retirement community?

Yes, as long as it is not prohibited by the County Commission, a City Commission or the Florida Department of Transportation (FDOT).

#### Am I allowed to operate my golf cart on a public road?

Florida Statutes authorize golf carts to be operated upon state and county roads that have been designated by the FDOT or County Commission for use by golf carts. The FDOT or the County shall post appropriate signs to indicate such operation is allowed. Also, section 2-22-9 of the Manatee County Code of Ordinances contains a list of designated roads for golf carts.

#### What about if I only want to cross a public road that has not been designated for golf cart use?

You must use the crossing area designated for golf carts which will include any traffic control devices needed for safety purposes.

#### Am I allowed to operate my golf cart on the sidewalk?

No, Florida law prohibits driving "any vehicle other than by human power" upon a sidewalk or sidewalk area. This includes golf carts.

#### Am I allowed to operate my golf cart at night?

You are only able to operate it between sunrise and sunset unless your golf cart is equipped with headlights, brake lights, turn signals and a windshield.

#### How can I make my golf cart "street legal"?

It must be equipped with head lamps, stop lamps, turn signals, tail lamps, reflex reflectors, parking brakes, an exterior mirror on the driver's side, rearview mirrors, windshields, seatbelts and a VIN number. The top speed must be greater than 20 miles per hour but not greater than 25 miles per hour. Additionally, it must be registered, insured and the operator must have a valid driver's license.



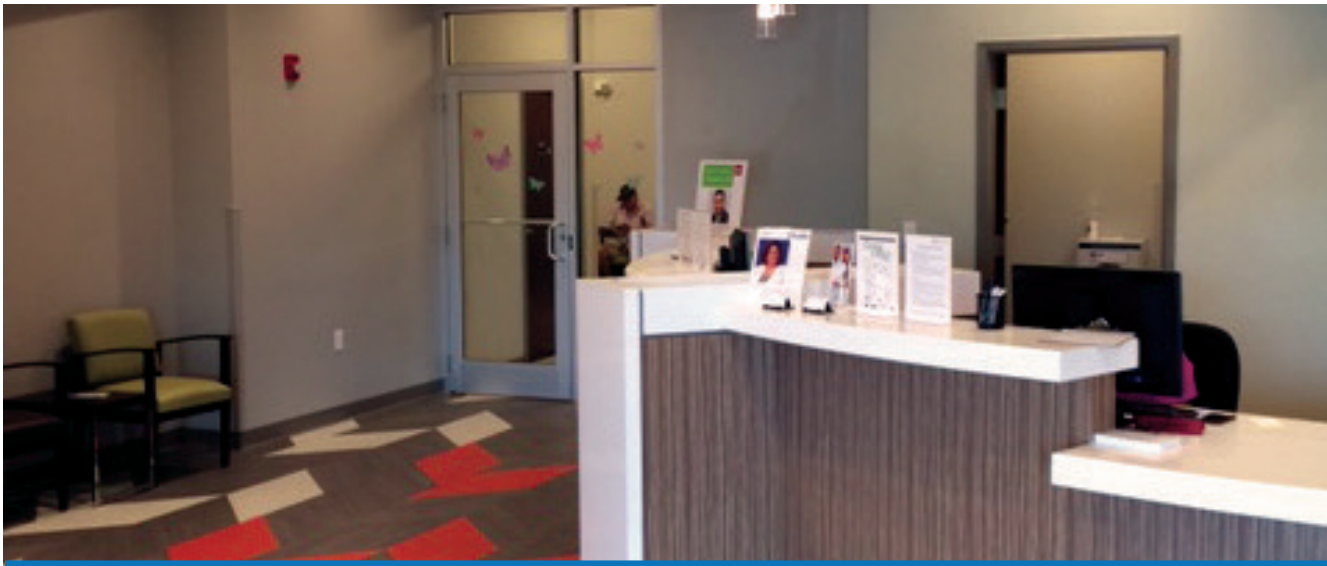

## Golf Cart FAQ Continued...

### If my golf cart is street legal, how does that change the restrictions?

It may be operated on streets where the posted speed limit is 35 miles per hour or less.

### Can I be issued a traffic citation for improperly operating a golf cart?

Yes, the golf cart operator can be issued a traffic infraction citation for a moving violation, with an associated fine of \$166.00 plus 3 points.

# Tasty Pumpkin Recipes

## Pumpkin Cookies With Chocolate

2½ cups all-purpose flour  
 ½ cup natural cocoa powder  
 1 tsp baking soda; 1 tsp ground cloves  
 1 tsp ground cinnamon  
 ½ tsp ground black pepper  
 ½ tsp fine salt; ½ cup molasses  
 ½ cup pure pumpkin puree  
 ½ cup unsalted butter, at room temp  
 1 tbsp turbinado sugar  
 1 cup granulated sugar; 1 large egg  
 1 cup chopped walnuts; 1 cup chopped dates  
 Heat oven to 350° F. Line two baking sheets with parchment. Whisk together flour, cocoa, baking soda, cloves, cinnamon, pepper, and salt in a medium bowl. In a separate bowl whisk together molasses and pumpkin puree. Beat the butter and sugar in a large bowl with an electric mixer on med-high until light and fluffy. Beat in egg, scraping down the sides of the bowl as necessary. Reduce mixer speed to low and add the dry and wet ingredients alternately, beginning and ending with dry ingredients and mixing well between additions. Mix until just combined. Fold in walnuts and dates. Drop mounds of the dough 1 inch apart onto the baking sheets. Sprinkle with turbinado sugar, dividing evenly. Bake, rotating sheets halfway through, until firm around the edges. Let cool slightly on baking sheets, then transfer to a wire rack to cool completely.

## Sweet and Salty Pumpkin Seeds

2 cups fresh pumpkin seeds, rinsed and dry  
 2 tbsp unsalted butter, melted  
 2 tbsp granulated sugar; ½ tsp kosher salt  
 ¼ tsp ground cinnamon  
 Heat oven to 300°. Spread seeds on a rimmed baking sheet and bake until dry, 50 to 60 minutes. Increase oven temp to 350°. In a large bowl, toss seeds with butter, sugar, salt, and cinnamon. Return seeds to the baking sheet and toast, tossing occasionally, until golden brown, 10 to 15 minutes.

## Pumpkin With White Beans and Bacon

4 slices bacon  
 1 small sugar pumpkin —peeled, seeded, and cut into 1-inch pieces  
 1 cup low-sodium chicken broth  
 1 tbsp chopped fresh oregano leaves  
 kosher salt and black pepper  
 1 15.5-ounce can cannellini beans, rinsed  
 1 tbsp red wine vinegar  
 Cook the bacon over medium heat until crisp, 6 to 8 minutes. Transfer to a plate with a slotted spoon; let cool, then break into pieces. Reserve the skillet. Add the pumpkin to the drippings in the skillet; cook, stirring occasionally, until browned, 5 to 7 minutes. Add the broth, oregano, ½ tsp salt, and ¼ tsp pepper. Cover and cook, stirring occasionally, until the pumpkin is tender, 6 to 8 minutes more. Add the beans and vinegar and heat through, 2 minutes. Top with the bacon.

## Mexican Pumpkin Punch

2 cups packed dark brown sugar  
 4 cinnamon sticks, preferably Mexican  
 1 29 -ounce can pure pumpkin  
 2 limes; Splash of rum (optional)  
 Pineapple chunks and/or pecans, for serving (optional)  
 Combine 12 cups water, brown sugar and cinnamon sticks in a large pot and bring to a boil over med-high heat, stirring until sugar dissolves. Stir in pumpkin and return to a simmer. Meanwhile, remove zest from limes in wide strips using a vegetable peeler; add zest to the pot and simmer 15 minutes. Let cool, then refrigerate until the liquid is cold and pumpkin pulp settles to bottom, 2 to 3 hours. Working in batches, ladle the liquid into a fine-mesh strainer set over a pitcher (repeat if necessary to strain out all the pumpkin pulp). Discard the pulp and lime zest. Return the cinnamon sticks to the punch and refrigerate until ready to serve. Pour the punch into ice-filled glasses. Add rum, pineapple and/or pecans, if desired. Serve with the cinnamon sticks.

## Pumpkin Seed Brittle

1 tsp vegetable oil, additional for coating  
 7 oz hulled pumpkin seeds ; 12 oz water  
 1/2 tsp cayenne pepper; 1/2 tsp kosher salt  
 1/2 tsp ground cinnamon  
 1 lb, 6 oz granulated sugar  
 Place oil and seeds into a 10" saute pan and set over med-hi heat. Toast seeds while constantly moving the pan, 4 to 5 minutes. Transfer seeds to a small mixing bowl, add cayenne, cinnamon and salt, stir to combine. Line a half sheet pan with a silicone baking mat. Place a 3-quart saucier inside a large cast iron skillet. Add sugar and water to saucepan, and cook over high heat, stirring occasionally with a wooden spoon, until it comes to a boil. Stop stirring, cover and cook for 3 minutes. Uncover, reduce heat to medium, and cook until sugar is a light amber color, approx. 25 minutes. Remove from heat and stir in pumpkin seed mixture. This will greatly reduce the temperature of the sugar, so work quickly. Once evenly mixed, pour mixture onto prepared half sheet pan. Using an oiled spatula, spread thin. You will have to work quickly when pouring out, spreading mixture in pan. Cool completely, approx. 30 minutes, then break into pieces.

## Pumpkin Spice Latté Milkshake

2 c. coffee ice cream; 1/2 c. milk  
 1/4 c. pumpkin purée;  
 1/2 tsp. pumpkin spice  
 1/2 tsp. vanilla extract  
 Caramel sauce, for serving  
 Whipped cream, for serving  
 Cinnamon stick, for garnish (optional)  
 Combine ice cream, milk, pumpkin puree, pumpkin spice, and vanilla in a blender. Blend until smooth. Drizzle the inside of a pint glass (or another tall glass) with caramel sauce. Fill the glass with the milkshake, top with whipped cream and more caramel sauce. Garnish with a cinnamon stick, if desired.
