- 1.) A current Photo I.D. For resident rates, a Bayshore address must appear on the ID If the ID does not reflect a Bayshore address, a current lease or deed must be provided. No exceptions
- 2.) Valid boat insurance with a \$100,000 liability minimum (Bayshore Gardens MUST be listed as an additional insured on the boat policy and proof provided)
- 3.) Current boat registration (All parties on the boat registration MUST sign the contract)
- 4.) Name & phone number of an emergency contact.
- 5.) Residents will need to pay a \$250 security deposit upon contract signing. (One time fee)
- 6.) Non-residents will need to pay a \$500 security deposit upon contract signing. (One time fee)

Documents needed for Ramp (Residents Only)

- 1.) A current Photo I.D. Bayshore address must appear on the ID If the ID does not reflect a Bayshore address, a current lease or deed must be provided. No exceptions
- 2.) Valid Boat, trailer and towing vehicle(s) registration cards.
- 3.) Valid insurance for the towing vehicle(s)

Bayshore Gardens Park & Recreation District Board of Trustees Meeting Wednesday July 22, 2020 @ 7:00 PM

The Meeting was called to order at 7:00 pm by Chair Jim Frost. Roll call established there was a quorum.

The Pledge of Allegiance was recited by all.

Trustees Attending were Jim Frost, Chairman; Barbara Susdorf, 2nd Chair; Katey Dolan, Treasurer; Belle Baxter, Steve Watkins and Terry Zimmerly. Secretary Sandy McCarthy was absent.

Minutes from June 11 – motion to approve by Dolan, seconded by Susdorf – **Approved unanimously**

Minutes from June 17 – motion to approve by Watkins, seconded by Dolan – **Approved unanimously**

Minutes from June 24 – motion to approve by Watkins, seconded by Susdorf – **Approved unanimously**

Minutes from July 8 – motion to approve by Watkins, seconded by Dolan – **Approved unanimously** with changes

Treasurer's Report – motion to approve by Watkins, seconded by Susdorf - **Approved unanimously**

6.A – Resolution 2020-03 to adopt the 2020-2021 budget; motion to accept by Dolan, seconded by Zimmerly - **Approved unanimously**

6.B – Resolution 2020-04 to impose assessment as determined by the budget - motion to accept by Zimmerly, seconded by Baxter - **Approved unanimously**

7 – Zimmerly made the motion to appoint Jose Alicea as Dock Master. Baxter seconded- **Approved unanimously**

8 – Zimmerly made the motion to raise Pool Attendants' minimum wage from \$8.50 to \$8.56/hour to comply with State rate. Susdorf seconded - **Approved unanimously**

9 – Frost reported that an automatic lift gate has been installed at the entrance to the Beach Road.

The gate is on a timer to open in the morning and close at night. If a car is at the beach after dark, there is a trip plate that will open the gate from the beach side. In a side note it was noted that research revealed the area south of the screen room to the Bay and between the pool and 26th Street is open to the public in perpetuity. Our insurance adequately covers this area. Stricter signs were recommended.

10 – Zimmerly made the motion to approve Folk Asphalt to repair asphalt in the Marina using county-approved materials. Dolan seconded – Approved unanimously. Money to pay for this is available in reserves

11 – There was discussion about who would seed the ball field – an outside source or our maintenance. Zimmerly made the motion to have maintenance grade & seed the ball field. Watkins seconded with a budget of \$1,500. - **Approved unanimously**

12 – Zimmerly made the motion to add July4 and remove Presidents Day for the Employee Manual. Dolan seconded -**Approved unanimously**

13 – Zimmerly made the motion to add Temporary District Office Manager job description to Employee Manual and give Gia Cruz a \$.50/hour raise. Baxter seconded - **Approved unanimously**

14 – Gia Cruz reported 2 new grills are needed in the park, they cost \$130 each. Also, new life rings are needed in the marina. US Coast Guard-approved life rings cost \$65 each and Gia suggested that covers, costing \$25 each would extend the life of the rings. It was decided the cost of these items are within the office's monthly budget and Gia should use her best judgment to make these purchases.

There was also discussion about more pool hours.

Terry made the motion to open the pool on Monday, Tuesday and Wednesday from 4 pm – 7 pm starting July 27. Watkins seconded- **Approved unanimously**

15 – Zimmerly made the motion to change sections 5 & 6 and add the Interim District Office Manager job description to the employee handbook. Susdorf seconded - **Approved unanimously**

16 – Zimmerly made the motion to reinstate committees. Watkins seconded - **Approved unanimously**

17 & 24 – Zimmerly has been looking at replacements for the sign at the entrance to the parking field. The previous quote of \$360 was for materials that would not hold up outside. The new quote is \$510. The motion was tabled and will go to a workshop for further discussion.

18 – An RFP will be going out for bids to repair the roof.

19 – Baxter made a motion to dispose of non-working golf cart & pressure washer. Dolan seconded - **Approved unanimously**

20 – Frost announced the District is still on FPL's list and there has been a reduction in price to move the pole necessary to support the electricity in the marina. The District only has to pay for the meter which will cost \$1,500.

21 – Hall Acoustics – Dan Smith presented his son's opinion – the system is great, but something needs to be done to deaden the sound. A committee will be created to look into options.

22 – Watkins made a motion to replace the tires on the John Deere and for a tarp to cover the tractor. Zimmerly seconded - **Approved unanimously**

23 – Watkins had a plumber check the water collection areas and was told the water collection on the south side of the marina is OK, the one on north side needs

work. Dock master Robert Hindle has said he's had no problems with either area.

25 – Watkins made a motion to have electricity installed in the storage room on the south side of the workshop. Motion was tabled, will go to workshop for more discussion with Woodchoppers.

26 – Watkins was advised the plaques mounted outside of the Rec Hall are under lock & key. Also, the drawings he was interested in are prints, not originals.

27 – Watkins made a motion that Crime Watch be reimbursed for the bulletin board that Neighborhood Watch donated to the district. There was discussion about Crime Watch vs. NBH Watch which and which group owns items cleaned out from the Crime Watch room. Still to be resolved as there was no second to the motion.

28 – Watkins made the motion to rescind the Sergeant at Arms section of the Meeting Decorum Policy. Zimmerly seconded- **Approved unanimously**

29 – Watkins made the motion to remove all No Parking signs. Zimmerly seconded. Watkins & Zimmerly – Yes. Baxter, Dolan, Frost & Susdorf – No. This will go to a committee.

Frost noted that there had been a complaint filed against Watkins by one of the maintenance men. Two mothers then added they were displeased with Watkins for ordering their daughters, who work in the District, to do jobs outside of their job descriptions.

30 – The following board members submitted letters of resignation – Jim Frost, Belle Baxter, Katey Dolan and Sandy McCarthy.

Terry made a motion to add Dan Smith & Dan Rawlinson to the Board, Katey Chmiel-Dolan second **Approved unanimously**

CERT - (Community Emergency Response Team)

VOLUNTEERS NEEDED

Our CERT program in Bayshore is new to us and growing and we welcome new CERT members that have been certified by taking the Manatee County FEMA training. You are trained to keep yourself safe while you complete search and rescue, light firefighting, first aid/CPR and damage assessment.

Hurricane Irma has taught all of us a lot about being prepared. We will be working much closer with Cedar Hammock Fire and Rescue and Manatee County Sheriff's Dept. to insure the safety of our CERT members and our community. Manatee County is the sponsor of the County wide CERT program and is charged by FEMA with training our CERT members. Emergency Management and the Fire Departments have realized the importance of those extra trained hands in an emergency and the CERT training classes are filling up within 24 hours of posting notice of the class, leaving our

new volunteers out of the classes.

Your CERT members are kept informed of the progress of setting class schedules and the registration process and can assist you in registration and acceptance into the class. Email originaltr@cs.com or call 941-752-7421 for more information.

The time commitment to CERT is minimal once trained. We meet once a month, with a short training FEMA film and a business meeting. Drills are held for training purposes. We also offer First Aid and CPR classes for our members. These classes are optional.

Our CERT program is working with the County to establish the CERT Coalition of Manatee County. This effort will put the Teams, Sheriff's Dept, and Fire Depts. together to serve the total community where and when needed. This is a real win for those of us who live close to the water.

WE THE PEOPLE: September 2020

Residents have been meeting to discuss relevant issues for the District. With the recent shake-up on the Board, it is difficult right now to discern what the relevant issues will be going forward.

In this light, the group has decided to suspend meetings until there is forward movement and focus by the new Board. The group will continue to connect and communicate via email.

Any resident is welcome in the group. We have no agenda, other than what members bring forward. We have no set point of view. There are members with varying opinions on every topic. That makes for really thoughtful discussions. The group can take positions on issues if the majority supports the position, such as communicating with County officials regarding the Accessory Dwelling Units proposed for the County.

Bayshore Gardens is one of the few communities in the County to be affected by the imposition of the new regulations permitting a second dwelling on a residential single family zoned lot.

Arguments have been put forth to exempt Bayshore Gardens from the new regulations, due to charter language. Our biggest concern is that the District could double in homes but not receive any additional funds (assessments) to fund the District. It is still unclear if this has been a convincing argument. Our Board has not taken a position, and has not given input.

The Attorney for the District has not been engaged to advance a legal argument to exempt the District. There are a few residences in Bayshore Gardens that already have "Guest Houses", which can now be converted to Accessory Dwelling Units (addition of kitchen facilities) or can remain as Guest Houses, The County intent is for units to become rental property to ease the strain on the low income housing available in the County. With additional residents using the facilities without paying additional assessment, our District suffers.

Both Guest houses and Accessible Dwelling Units will be recognized in the County proposal. There is another Public Hearing (the final one) later this fall. Members will be kept abreast of developments. Whitfield has an exemption due to the fact that they have deed restrictions that conflict with the new regulations. We have a very strong argument due to our charter language, but it is only a few residents advancing that argument.

Anyone desiring to be part of this resident group may attend all meetings and if email contact is desired, all members will get the emails. An email address is all a residents needs to be a member.

Why Local Elections Matter

All too often, people think that voting is something we do once every 4-years. It's the Presidential campaign season and the spotlight is focused every day on which candidate will make the best choice to oversee the most powerful country in the world. But what about the races further down the ballot? The county commission and school board races may not be as sexy as the ones in the national spotlight, but I am writing this to convince you that they are way more important to your quality of life than deciding who will sit in the White House.

I'm writing this the day after the primary election, which has been an emotionally charged time. Candidates were working hard and people were lining up behind those they felt deserve to represent our community in various seats. But the thing that amazes me is that only about 28% of the registered voters showed up to decide who will run our local and state government. I am always sad that voters don't realize that our local elections have a profound impact on their quality of life.

I didn't get involved in campaigning for our local candidates and I don't feel it is my role to convince our citizens how to vote. I believe I was elected to make District 4 a better place for our residents, and businesses, for generations to come; and that is where I choose to use my energy.

My days are busy and consumed with a variety of issues. The number one complaint I hear about is traffic. I regularly fight for roadway and safety improvements, and serve on the MPO with a focus on regional roadways. I also work with business owners who have an access that may be impacted by FDOT planned improvements and look for a win/win solution.

South county was the first to develop in Manatee, and therefore it seems we are always



in need of upgrading our utilities and infrastructure. Water quality problems are county-wide and I'm dealing with air and noise pollution problems in south county from industries that don't follow the rules.

I really enjoy working with the older neighborhoods to protect and enhance their historic value. Bayshore Gardens is one of those. They finally have sidewalks and are deserving of other upgrades. Whitfield-Ballentine is another neighborhood that remains strong due in part to the Whitfield-Residential Overlay, so maintaining it remains one of my priorities. Working on ways to allow accessory dwelling units to enhance our neighborhoods and not drag down our district has been a recent topic that has my attention too.

Growth is an ongoing challenge and not one that I see slowing anytime soon, which is why I created the District 4 Citizens Coalition on Growth (CCOG). I want to hear ideas from the people who live and do business in south county. The group will soon review the new FEMA maps to understand how the flood zones will change. Flooding is a major challenge in District 4 and hurricane season puts us on extra high alert.

When I get a break in my schedule, I hop in a ride-along with the deputies to see the challenges from the street level, which gives me a close-up picture of our district's homeless problems.

The county budget may be our most important task, and I don't have to tell you that everything District 4 needs has a price tag. One of my big pushes this year is for more Code Enforcement officers, because code issues are high in District 4, and addressing them is how we help our neighborhoods remain strong.

Let's not forget about Corona virus, which has added another layer of difficulty. The pandemic has been hard and sad. The bright side, if there is

one, is that I have enjoyed getting supplies to people in need, and I think it has been revolutionary for many business practices. Our county (and the world) will be different on the other side of this disaster.

Listening. Listening to constituents who have a problem or are unhappy is a constant in my daily work. I may not always find the perfect solution, but I can promise you my attention and the time and effort it will take to look for answers.

There has been a lot of noise and drama in this election cycle already, and we should prepare for it to get worse. The thing is, Washington, DC is nearly 1,000 miles away from our homes but our schools are right down the street. If patterns hold true, an extraordinarily small percentage of people will again decide in November how your local tax dollars will be spent. Yes, the presidential and congressional races are important, but if you really want to affect your lifestyle, research the issues and vote in your local elections.

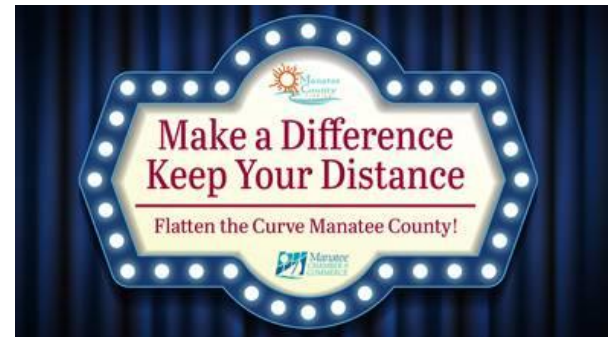
