- Plumbing under our 60-year-old pool may break at any time costing us over \$300,000 to repair
- Insurance cost and taxes are increasing exponentially
- Cost of living increases our salaries and cost of materials have increased to maintain the District

NOTICE

Dear Bayshore Gardens Property Owner.

Re: Annual Assessment

This Notice is provided pursuant to section 197.3632, Florida Statutes, and provides you with information about the Bayshore Gardens Park & Recreation District ("District"), its assessments and upcoming annual meeting. The District is an independent special taxing district of local government located in Manatee County, Florida, which provides park and recreational amenities within its District boundaries.

Upcoming Public Hearing

The District will hold a public hearing for residents to vote on the proposed Budget on Tuesday, June 14, 2022, at 7 p.m. in the Recreation Hall located at 6919 26th Street West, Manatee County, Florida. The purpose of the annual meeting will be to consider the adoption of the District's budgets and levy of annual assessments. All owners who reside within the District and whose names are recorded on the deed are eligible to vote in person. (Please bring photo I.D.)

The District imposes a special assessment ("Assessment") on your property on an annual basis, the purpose of which is to fund the District's general operating budget. Each improved residential parcel within the District constitutes a unit for purposes of the Assessment, and each unit is assigned an equal share of the total Assessment. The District is required by Florida law to notify each owner by mail of an intended increase in the Assessment amount over prior years. The District has proposed a per unit increase of \$20.00 over prior year assessments, for a total proposed Assessment of \$397.00 per unit. The increase has become necessary due to expenses associated with obligations needed to fund the operation of the District and contribute to reserve accounts of the District infrastructure. The District's budget is adopted each year after consideration by the Board and after a public hearing. The District collects the Assessment on the Manatee County Tax Bill. All benefited lands within the District pay the Assessment.

By operation of law, the District's assessments each year constitute a lien against your property located within the District just as do each year's property taxes. It is important to pay your assessments since failure to do so will cause a tax certificate to be issued against the property which may result in loss of title.

You have the right to appear at this public hearing and express any objections, suggestions, or comments you may have. You may also file written objections within twenty days of the date of this Notice at the office of the District, 6919 26th Street West, Bradenton, Florida 34207, Attention: Board of Trustees. If anyone chooses to appeal any decision of the Board with respect to any matter considered at the public hearing, such person will need a record of the proceedings and should accordingly ensure that a verbatim record of the proceedings is made, which includes the testimony and evidence upon which such appeal is based.

In accordance with the provisions of the Americans with Disabilities Act, any person requiring special accommodations at this hearing because of a disability or physical impairment should contact the District Manager at least five (5) days prior to the date of the hearing.

Be Prepared!

Preparing for a Hurricane from the CDC

Make a Plan.

Hurricane season starts on June 1 in the Atlantic and the Caribbean. It ends on November 30. Before hurricane season each year, make sure you and your family are prepared by planning ahead.

- Write down emergency phone numbers and keep them on the refrigerator or near every phone in your house. Program them into your cell phone too.
- Prepare an emergency supply kit.
- Locate the nearest shelter and different routes you can take to get there from your home. If shelter locations in your area have not been identified, learn how to find them in the event of a storm.
- Pet owners: Pre-identify shelters, a pet-friendly hotel, or an out-of-town friend or relative where you can take your pets in an evacuation. Local animal shelters may be able to offer advice on what to do with your pets if you are asked to evacuate your home.

Gather emergency supplies.

During and after a hurricane, you may need supplies to keep your family safe and healthy. Remember that a hurricane could cut off your power and water supply. You also may not be able to drive because of damage to your car. Roads may be flooded or blocked.

That's why it's best to be prepared—stock up on everything you might need now. Be sure to prepare the following:

- An emergency food and water supply.
- An emergency medicine supply.
- Emergency power sources such as flashlights (don't forget extra batteries).
- Safety and personal items.
- Important documents, including medical documents, wills, passports, and personal identification.

- A fire extinguisher. Make sure your family knows where to find it and how to use it! Read the National Fire Protection Association's tips for using fire extinguishers.

Know the difference between a hurricane "watch" and "warning."

Listen for National Weather Service alerts on TV or radio or check for them online. There are two kinds of alerts:

- · A hurricane watch means hurricane conditions (sustained winds of 74 miles per hour [mph] or higher) are possible in a stated area. Experts announce hurricane watches 48 hours before they expect tropical-storm-force winds (sustained winds of 39 to 73 mph) to start.
- · A hurricane warning is more serious. It means hurricane-force winds are expected in a stated area. Experts issue these warnings 36 hours before tropical-storm-force winds are expected in the area to give people enough time to prepare for the storm.

For more information about hurricane watches and warnings, check out the National Weather Service's Hurricane Center. If you hear that there is a hurricane watch or warning in your area, you can take steps to get ready.

Get your car ready.

Make sure your car is ready before the storm hits.

- · Fill your car's gas tank.
- · Move cars and trucks into your garage or under cover.
- · Always keep an emergency kit in your car.
- · Visit Ready.gov for information on how to prepare your car and what to include in your kit.

If you don't own a car, consider making plans with friends or family or call authorities to get a ride if you need to evacuate.

Get your family and pets ready.

· Go over your emergency plan with your family.

- · Keep checking for updates about the storm. Watch TV, listen to the radio, or check online.
- · Call the hospital, public health department, or the police about special needs. If you or a loved one is older or disabled and won't be able to leave quickly, get advice on what to do.
- · Put pets and farm animals in a safe place. Read more about pet safety during an emergency.

Get your home ready.

- Clear your yard. Make sure there's nothing that could blow around during the storm and damage your home. Move bikes, lawn furniture, grills, propane tanks, and building material inside or under shelter.
- Cover up windows and doors. Use storm shutters or nail pieces of plywood to the outside window frames to protect your windows. This can help keep you safe from pieces of shattered glass.
- Be ready to turn off your power. If you see flooding, downed power lines, or you have to leave your home, switch your power off.
- Fill clean water containers with drinking water. You'll want to do this in case you lose your water supply during the storm. You can also fill up your sinks and bathtubs with water for washing.
- Check your carbon monoxide (CO) detector's battery to prevent CO poisoning

Be ready to evacuate or stay at home.

Always listen to authorities regarding whether you should evacuate or stay at home.

If a hurricane is coming, you may hear an order from authorities to evacuate (leave your home). Never ignore an order to evacuate. Even sturdy, well-built houses may not hold up against a hurricane. Staying home to protect your property is not worth risking your health and safety.

You may hear an order to stay at home. If driving conditions are dangerous, staying at home might be safer than leaving.

If you need to evacuate:

- · Grab your emergency supply kit and only take what you really need with you (cell phone, chargers, medicines, identification like a passport or license, and cash).
- · Unplug your appliances. If you have time, turn off the gas, electricity, and water.
- · Follow the roads that emergency workers recommend even if there's traffic. Other routes might be blocked or flooded. Never drive through flooded areas—cars and other vehicles can be swept away or may stall in just 6 inches of moving water.
- · Contact your local emergency management office and ask if they offer accommodations for owners and their pets.

If you need to stay home:

- \cdot Keep your emergency supply kit in a place you can easily access.
- · Listen to the radio or TV for updates on the hurricane.
- · Stay inside. Even if it looks calm, don't go outside. Wait until you hear or see an official message that the hurricane is over. Sometimes, weather gets calm in the middle of a storm but then quickly gets bad again.
- · Stay away from windows—you could get hurt by pieces of broken glass or flying debris during a storm. Stay in a room with no windows, or go inside a closet.
- · Be ready to leave. If emergency authorities order you to leave or if your home is damaged, you may need to go to a shelter or a neighbor's house.

MANATEE MATTERS WITH COMMISSIONER MISTY SERVIA

Mental Health Awareness Month

May is "Mental Health Awareness Month," and as it comes to a close, I wanted to write about the importance of mental health for our community.

Our daughter is a mental health counselor, and I enjoy the way her mind works to help others who are struggling. But, even before her career started, I enjoyed reading about life skills and coping mechanisms to deal with everyday life.

As a county commissioner, I feel that I have a ring-side seat to both good and bad examples of mental health. Here are some nuggets that I hold close:

Nurture good relationships. Relationships are the foundation of our world. Nothing is more important than our family and friends, so put them at the top of your priority list, and work to grow your network and deepen the relationships. Human connection is important and building a strong support system of good people helps us to be solid and happy, no matter the struggle of the moment.

Helping others. They say that altruism is hardwired into the human brain, and we get a shot of dopamine when we give willingly of our time or resources. Maybe that's it, but it also gives purpose to our lives. When we come across people who are struggling with sadness or depression, suggest that they get out and find a way to help someone else. There is always someone who needs help and pitching in to help them through a struggle has a magical way of helping ourselves at the same time. It's like a BOGO sale!

Self-Awareness: This is one of my favorites, and we all have blind spots in this category. When we know who we are and can see ourselves as others see us, we have the ability to build stronger relationships, communicate more effectively, and relate to others. Seeking feed-back and having empathy for others broadens our capacity to process information and make better decisions. And good self-awareness gives us the vision to be more effective leaders and less likely to lean on white lies and twisted perceptions to reach conclusions.

It made me stronger in the face of chaos and sadness, realizing that there is always something to be grateful for.

Take a walk. I can't remember one time after a walk that I was upset that I took the time to do it. It helps me to process the moments of the day, boost energy, and even sleep better. The best walks are through one of our preserves, where I will skip the headphones and take in the sounds of nature and the beauty of silence. But even a short walk through the neighborhood allows me to catch up on a book on audible and put aside the daily demands and pressures.

Finally, seek help from a Professional. There is no shame in asking for help from a professional. In honor of Mental Health Awareness Month, let's all work together to remove the stigma of mental health challenges and silence the shame by acknowledging that life is hard and it's okay to reach out for help during those hard moments.
