October 1st is the renewal date for boat slips, trailer spaces and marina ramp FOBs. Please remember to bring the following documents for renewal:

Documents needed for Boat Slip

- 1.) A current Photo I.D. For resident rates, a Bayshore address must appear on the ID If the ID does not reflect a Bayshore address, a current lease or deed must be provided. No exceptions
- 2.) Valid boat insurance with a \$100,000 liability minimum (Bayshore Gardens MUST be listed as an additional insured on the boat policy and proof provided)
- 3.) Current boat registration (All parties on the boat registration MUST sign the contract)
- 4.) Name & phone number of an emergency contact.
- 5.) Residents will need to pay a \$250 security deposit upon contract signing. (One time fee)
- 6.) Non-residents will need to pay a \$500 security deposit upon contract signing. (One time fee)

Documents needed for Ramp (Residents Only)

- 1.) A current Photo I.D. Bayshore address must appear on the ID If the ID does not reflect a Bayshore address, a current lease or deed must be provided. No exceptions
- 2.) Valid Boat, trailer and towing vehicle(s) registration cards.
- 3.) Valid insurance for the towing vehicle(s)

Documents needed for Trailer Storage (Residents and Non-Resident Slip holders)

Bayshore Gardens Park & Recreation District Board of Trustees Meeting Wednesday August 19, 2020 @ 7:00 PM

1 - 4 - The Meeting was called to order at 7:05 PM by Terry Zimmerly who was asked to speak by 2nd Vice Chair; Barbara Susdorf as she did not want to take her mask off, and people are unable to clearly hear her.

Trustees Attending were Barbara Susdorf, Terry Zimmerly, Dan Rawlinson, John Lindsey, Morris Raymer and Melanie Woodruff. Trustee, Steve Watkins was absent.

- Minutes from July 22nd Board Meeting – Motion to approve by Woodruff, seconded by Rawlinson –

Approved unanimously

- Minutes from August 5th Special Meeting – Motion to approve by Woodruff, seconded by Lindsey – **Approved unanimously**

- Minutes from August 5th Work Session – Motion to approve by Lindsey, seconded by Susdorf – **Approved unanimously**

5 - Treasurer's Report – Sharon Denson stated there were several discrepancies with the monthly financials. Terry said that until we can confirm with the accountant to hold off on approving them. (Terry verified with Natalie on August 20th that the financials are correct no errors found)

6 - Committee Report – Terry stated that the only Committee we had was the Acoustics Committee and Dan Smith was the chair for that, but he resigned from the Board.

7 - District Office Manager Report – Gia stated since school started the hours of the pool will be changing again. Monday through Friday 8 am to 11 am is for the lap swimmers, Monday through Friday 4 pm to 7 pm with lifeguards and Saturday and Sunday 11 AM to 7 PM with lifeguards. Gia stated she received a call from Trailer Estates Volunteer Fire Department asking if they could use our pool for training.

Lindsey made a motion to allow Trailer Estate's Volunteer Fire Dept. to use our pool for training as long as they can provide a copy of their liability insurance with Bayshore Gardens listed on the policy. Raymer seconded – **Approved unanimously**

Gia advised she received a call from The American Legion asking if they could start using our hall again for their meetings the first Saturday of every month from 9 am to 11:30 am. - Terry said she would like to move this to Workshop for more discussion.

Beach Area – Gia advised that she called Manatee County and Mote Marine and they both advised they are not aware of any issues currently in the Bay. Per DEP if we want to put up no swimming signs, we can do that, but it would be at the District's expense. – Moved to Workshop for more discussion.

Gia advised that the awnings that were on the hall windows are still sitting behind the maintenance building and takes up a lot of space – Moved to House Committee for more discussion. Gia updated the Board on the Ballfield; she spoke with Randy in maintenance and the only reason he has not started on it is due to the amount of rain we have had; the seed and hay would wash away.

8 - Potential Board candidates that were present introduced themselves to fill two vacant seats. The candidates were Kelly Page, Maureen Herrick, Lorna Pierce and Barbara Greenberg. Zimmerly asked that the remaining candidates go to the board room so that the Board could discuss who they would like to fill the other two (2) vacant seats.

Rawlinson made a motion to nominate Lorna Pierce to the Board to replace Katey Chmiel-Dolan in seat number one (1). Lindsey seconded. - **Passed Unanimously**

Rawlinson made a motion to nominate Barbara Greenberg to the Board to replace Dan Smith in seat number nine (9). Lindsey seconded. - **Passed Unanimously**

9 - Replace Board Officers – Dan Rawlinson made a motion to nominate John Lindsey as Chairman. Barbara Susdorf seconded - **Passed Unanimously and Lindsey Accepted**

Morris Raymer made a motion to nominate Terry Zimmerly as Treasurer, Barbara Susdorf seconded - **Passed Unanimously and Zimmerly Accepted**

John Lindsey newly elected Chairman took over the meeting. Lindsey stated the Board would select a new Secretary at the next Board Meeting when everyone is officially seated on the board.

10 - Zimmerly made a motion to rescind the motion from the February 19th Board Meeting to dissolve committees. Seconded by Woodruff - **Approved unanimously**

Lindsey advised we need a Marina Committee - Chaired by Trustee Morris Raymer - signup sheet provided to residents.

Lindsey advised we need a Finance Committee - Chaired by Trustee Terry Zimmerly - signup sheet provided to residents.

Lindsey advised we need a Recreation Committee - Chaired by Trustee Melanie Woodruff - signup sheet provided to residents.

Lindsey advised we need a Grounds Committee - Chaired by Trustee Barbara Susdorf - signup sheet provided to residents.

Lindsey advised we need a Personnel and Salaries Committee - Chaired by Trustee Terry Zimmerly - signup sheet provided to residents.

Lindsey advised we need a House Committee - Chaired by Trustee Morris Raymer - signup sheet provided to residents.

11 - Acoustics Committee - Tabled until next Work Session after House Committee can further discuss the issues.

12 - Hall Renovation Contract - Tabled until next Work Session after House Committee can further discuss the remaining work to be done.

13 - Boat Ramp FOB - Raymer made a motion starting October 1, 2020 the last four (4) months for the boat ramp FOB fee to cost \$10 per month plus sales tax instead of the full amount of \$80 plus sales tax for the year. Example: If ramp FOB purchased in June, the cost would cost \$40 plus tax. If ramp FOB

purchased in July, the cost would be \$30 plus tax and so on until renewals on October 1st. Woodruff seconded - **Approved unanimously**

14 - Asphalt for The Marina - Terry made a motion to approve the original bid from Folk Asphalt & Seal Coating for \$4,485. Raymer seconded - **Approved unanimously**

15 - Boat Lifts - Moved to Marina Committee for more research and discussion.

16 - Move Money - Five different motions to move funds within the reserve accounts.

- Terry made a motion to move funds in the amount of \$4,252.09 from Landscaping Reserve Account 1026 to Marina Reserve Account 1032. Raymer seconded - **Approved unanimously**

- Terry made a motion to move funds in the amount of \$5,267.19 from Parking Lot Reserve Account 1027 to Marina Reserve Account 1032. Raymer seconded - **Approved unanimously**

- Terry made a motion to move funds in the amount of \$2,000 from Roofing Reserve Account 1021 to Marina Reserve Account 1032. Raymer seconded - **Approved unanimously**

- Terry made a motion to cure the funds moved on April 2, 2020 in the amount of \$6,000 from Roofing Reserve Account 1021 to Hall Reserve Account 1022. Raymer seconded - **Approved unanimously**

- Terry made a motion to cure the funds moved on April 2, 2020 in the amount of \$14,000 from Roofing Reserve Account 1021 to Marina Reserve Account 1032. Raymer seconded - **Approved unanimously**

During a disaster, the capacity of emergency services is often pushed to the limit. People must rely on each other for help in order to meet immediate life-saving and life-sustaining needs. By putting a Community Emergency Response Team (CERT) in place as an extension of first responder services, direct help can be offered to victims until professional services arrive. CERT training builds life-saving competencies with emphasis on decision-making skills, rescuer safety, and doing the greatest good for the greatest number. This practice excerpts material from the Federal Emergency Management Agency (FEMA) Citizen Corps website.

CERTs are formed by people who wish to be better prepared for the hazards that threaten their communities, and the programs require a partnership between community members and local government emergency management and response agencies. FEMA supports CERT programs by conducting or sponsoring train-the-trainer (TTT) sessions for members of the fire, medical, and emergency management community. The objectives of the TTT are to prepare attendees to promote this training in their community; conduct TTTs at their location; conduct training sessions for neighborhood, business and industry, and government groups; and organize teams with which first responders can interface following a major disaster.

WE THE PEOPLE: October 2020

Our resident group meets to discuss community issues. All residents are welcome.

One of our members, Sharon Denson serves on a volunteer Manatee County Coalition Group, headed by our County Commissioner, Misty Servia. She takes our community issues to the group and receives information from Ms. Servia about County issues that affect us.

At the last meeting Ms. Servia brought forward information about plans to change the flood zone map for the County. The new map that has been drawn up, reduces the flood area in Bayshore Gardens. This should mean lower insurance rates for the homeowners removed from the designated flood zone, as well as lifting many restrictions on building permits in the current flood zone. This is a directive of FEMA for Manatee County. For further information and a copy of the new map, you can access it on the internet at Flood@MyManatee.org. It will be approximately a year before it takes effect.

Our group has been active in the Accessory Dwelling Unit proposal put forth by Manatee County, to allow a second structure to be erected on our residential lots. Members have spoken to Commissioners at meetings and have put forth a position paper opposing the plan and asking for an exemption from the proposal for Bayshore Gardens Park and Recreation District, based on our charter language and the potential financial hardship for the us if the plan is enacted in our community. The group has requested that the Board of Trustees submit a position paper to the Board of County Commissioners, opposing the proposal for the same reasons. There will be two more public hearings before a final decision is made. public hearing on the issue next month.

Manatee Matters with Commissioner Misty Servia

Focus on the ways we are alike and listen to the differences.

Lately I'm sad to hear some Americans pointing out qualities they hate about others, name calling, and shutting out any opinion that doesn't align with their own or their political party. Every topic is so divided and there is no question that being just weeks from the presidential election is fueling these fires with gas. It feels like the constant bickering is weakening our community, and our national democracy is facing challenges not seen in decades. But it is my hope that we can get back to intellectual debate, learning from each other, and knowing that disagreements are healthy and almost always result in better decisions.

Why does this seem so difficult in 2020? It's true that people with different opinions create conflict, and that can be uncomfortable, but the creative friction that results is how we innovate and grow. This growth is accomplished by listening and building on each other's ideas and even changing our minds when we learn more. Leaders aren't good because they are always right. They are good because they are always listening, learning, and shifting. And we all know there is a distinction between hearing and listening, and there is no question that listening takes a deliberate effort. It is hard.

I always enjoyed debating, much to the chagrin of my parents, old boyfriends, my husband, and even my children. Through that experience I've learned that productive disagreements begin by finding common ground, even if it's as thin as a whisper. Look for it! And as Americans, we actually have a lot in common. Think about it!



We believe we should be free to make our own decisions, as long as we don't hurt others. We believe in an equal opportunity for all to achieve great things through hard work, and that all children are entitled to an education. We are patriotic and hold our freedom in the highest regard. We believe in the constitutional framework of checks and balances, and can all agree that cheating to get ahead is never okay.

Voting by mail is convenient, saves time, and allows you to research candidates at your leisure. A request for a vote-by-mail ballot (or for more information on voting in Manatee county) may be made in one of the following ways:

- In writing (e.g., by email, fax, mail) to Supervisor of Elections
- In person at Supervisor of Elections

If you would like to have a vote-by-mail ballot mailed to you, all requests must be received by 5 pm on the tenth day before an election. (The Saturday before a Tuesday election – October 24, 2020) A voter does not have to be absent from the county of residence or have an excuse in order to vote-by-mail.

Marked ballots must be received at the Office of the Supervisor of Elections, 600 301 Boulevard West, Suite 108, Bradenton, not later than 7 pm on the day of the election. Do not return your voted vote-by-mail ballot to a polling place.

If you do not bring proper ID, you can still vote a provisional ballot. As long as you are eligible and voted in the proper precinct, your provisional ballot will count provided the signature on your provisional ballot matches the signature in your registration record.

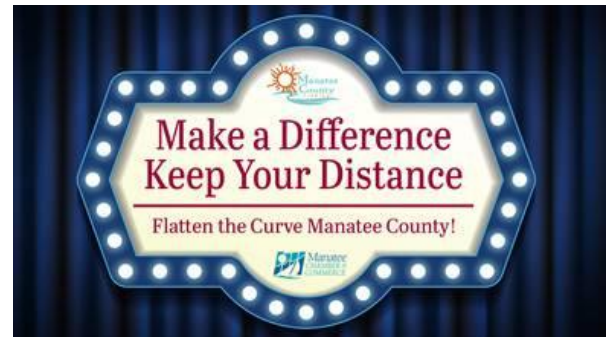
