BAYSHORE GARDENS PARK AND RECREATION DISTRICT BOARD OF TRUSTEES

MINUTES OF MEETING February 20, 2018

The regular meeting of the Board of Trustees of Bayshore Gardens Park and Recreation District was called to order by the Chairman Maynard Boyce at 7:00 p.m. and was followed by the Pledge of Allegiance.

Notice of the meeting was posted in the January Bayshore Banner.

Roll Call: Barbara Susdorf, Sharon Denson, Steve Watkins, Dan Rawlinson, Maynard Boyce, Debbie Korell, Terry Zimmerly and Jim Couey.

A quorum was established.

Present: Jodie Lawman, Don Gassie, Suzanna Young, Richard Nelson, Lenny Cichewicz, Allan Riga, Barbara Greenberg.

Maynard made a motion to approve the January 2018 minutes, Jim seconded, **MOTION CARRIES**

Jim made a MOTION to approve the January 2018 financials, Terry seconded. **MOTION PASSED.**

The Ringling School of Art was requested to take part in a design challenge for redecorating our recreation hall. Three (3) presentations were given with various designs by the student teams. The designs will now be voted upon by Bayshore residents with the winner receiving a \$500 gift check.

Trey Scott of Mauldin & Jenkins, Certified Public Accountants who do our annual audit was present to review the 2017 audit of the District and share the findings. No irregularities or misstatements were found nor were any significant audit findings noted. The audit was done in accordance with Government Auditing Standards which requires the issue of a report on consideration of internal control over financial, contracts and grant agreements and other matters. Such a report was issued by Mauldin & Jenkins.

Mark Kincaid of Coastal Engineering advised the Board that market conditions are not ideal at this time to proceed with the boat ramp due to elevated prices as a result of hurricane Irma. Mark proceeded with examples of jobs that his firm had estimated per the project and requested real number bids from contractors. The bids were two to three times the engineering estimate due to product cost. He recommends that we postpone the ramp project for another two to three months until contractor prices level off. Material costs post hurricane Irma are still elevated due to demand. The District may want to consider dredging the marina which may be more cost effective at this time.

TREASURER: Terry Zimmerly
Terry presented the Budget for the next fiscal year and has proposed a \$10 increase in the assessment for the coming year. Terry made a MOTION to approve the budget increase, Debbie seconded,

MOTION CARRIES. The Budget can go to print.

MANGERS REPORT: Jodie Lawman
Jodie reported that Quick Books has been set up to generate payroll taxes and submitted electronically. Discrepancies noted in Quick Books have been corrected with accounts credited properly. Prior office policy was to charge fees and back out the tax. This an uncommon practice and should be the item plus tax. The Board has recommended we begin charging the fee plus tax going forward. Duplicate coverage was noted on insurance policies with one policy cancelled. The office has been upgraded with Office 365 and the computers networked for more efficiency. Two residents have requested ongoing hall rentals for weekly events with consideration on monthly pricing. These rentals will be discussed at the committee meeting. The pool repairs were discussed and two estimates presented. A third estimate from Waterclub was not forwarded as of this date after several phone requests. The underlying delamination needs to be repaired before tiles are replaced or this cracking will continue. The marina chair, dockmaster and I met and discussed marina matters. We have proposed an open-ended contract for boat slip holders which may be terminated upon a thirty (30) day notice by either party. It will be the slip holder's responsibility to keep updated insurance and registration with the office. Credits have been issued to some trailer holders for double billing. Trailer stickers are now used for parking in the coordinating spaces. We will now be using Fifth Third Bank.

HOA: Dan Rawlinson
The first meeting was a potato supper that went well. We had the "Breakfast of Champions" with the Board of Trustees with approximately 30 attendees. Eight (8) new associates have signed up. Next meeting we will have a soup potluck and that is the second Thursday of the month, March 8th. Next breakfast will be pancakes and sausage and that is on the second Saturday, March 10th. Dan suggested that we send Holly a thank you letter for all her hard work putting together the Ringling Design challenge. The Board agreed we need to express our gratitude. **Next meeting will be March 8th, 2017 at 7:00 pm.**

CRIME WATCH: Steve Watkins
The next attic sale is coming up on March 24th. Tables are selling fast and there are still some spaces left for outside. Sellers can get into the hall on Friday March 23rd for set-up between 5:00 p.m. and 8:00 p.m. Sale hours on Saturday are 8:00 a.m. to 2:00 p.m. **Next meeting will be March 13th, 2017 at 7:00 pm.**

RESTORE BAYSHORE: Suzanna Young
The meeting was cancelled this past month due to Suzanna unable to attend. The Town Hall meeting was well attended. She is in the process of working on the question and answer to be printed in the Banner this month and next. Suzanna requested storage room for Restore Bayshore to store their

items for the attic sale. The County is working on getting bids for sidewalks in our neighborhood. We are waiting on notice as to the progress and dates. **Next Meeting will be March 12th, 2018 at 5:30 pm.**

BUDGET & FINANCE: Terry Zimmerly
Terry stated that there is nothing new to report this month. **Next meeting will be March 28th, 2018 at 7:00 p.m.**

WEB/BANNER: Jim Couey
Jim reports nothing new this month. Lenny and Steve have been actively selling ads for the Banner using Lenny's 5 page Sales Blitz customer handout and have done well. Lenny has offered his services in moving forward with activities and new functions for the residents of Bayshore. Debbie suggested we bring Lenny's ideas regarding the Banner to a committee meeting. **Next meeting will be March 28th, 2018 at 7:00 p.m.**

MARINA: Debbie Korell
Debbie stated that there is no new business for the marina. **Next meeting will be March 14th, 2018 at 7:00 pm.**

HOUSE & GROUNDS: Steve Watkins
Steve suggested that we put the Design Challenge posters up, have the community vote on them and a winner will be selected. **Next meeting will be March 28th, 2018 at 7:00 pm.**

Nothing new to report. The reviews of maintenance personal and raises were already discussed in the mangers report. **Next meeting will be March 28th, 2018 at 7:00 pm.**

January Town Hall: Questions from Our Community

February meeting was cancelled but pursuant to our promise at the January Town Hall we will report issues brought to the meeting

Robin DiSabatino took a list of unanswered questions to pursue with relevant County departments. We will publish these as they are addressed. (Please remember you can call phone numbers listed in Critical Connections for help and advice.) Robin's number is there too.

Anytime you have an issue and report it, follow up, follow up, follow up. This was advice given us by a Sheriff's Dept. officer at a previous Town Hall.

Q At times after heavy rains, the pump station at our marina has to be pumped and hauled out by trucks roaring and lumbering day after day through our community. Trailer Estates has no problem. Why can't the lift station in our marina be fixed? Isn't this (trucking) route more expensive?

A Robin will send info to Utilities Department. There was a Florida (State) /FEMA flood meeting held last week and tomorrow looking at these high water problems. There are no extra funds for storm water. The county is looking at a tax for this issue.

Q The crossing on the Parkway at Roslyn and shopping center drive, is in a congested and traffic-confusing intersection and fairly close to US 41. Why not move the crosswalk away from US-41 and to the Target area?

A Pedestrians cross at Roslyn. Now a bus stop is there. A study found that a crossing at the Target drive will be more expensive to construct. (Restore Bayshore Comment: So it's cheaper to let an intersection remain dangerous for both drivers and pedestrians.)

Q. What is the county code for fences? Height and condition?

A. Up to 8' high from house front to back. 4' high from front of house towards street. Fences in flood zones need permitting. Structures must be in good repair; no restrictions on style, color, etc.

Q. What is the noise ordinance in Bayshore Gardens? (It would be County wide)

A. Decibel level is 68 or 70 maximum. Call the Sheriff Dept. first, they and Code Enforcement have a device to measure noise. Also, call John Howard, our C.E. officer to come and investigate.

Q. Can Bayshore Gardens update standards/code? What can we do to get cleaned up and updated? How can we get more teeth on landlord's properties to help code enforcing?

A. To establish restrictions would be through Deed Restrictions. County Code Enforcement enforces the County Codes only. The community would have to enforce their own enhanced restrictions. First a 67% vote would be needed to establish a deeded community.

Robin asks residents to send email and photos of the problem and she will forward it. She stated in 2000 BG tried to get restrictions added but it failed as some residents don't like restrictions. However, restrictions protect communities. Use county App for complete restrictions.

On cleaning up the neighborhood she said it 'starts one block at a time'. (Restore Bayshore agrees)

David Breakfield, from Information Services Librarian Central/Neighborhood Services, was introduced and said a few words about the Bayshore Gardens 1955-2018 exhibit at the South County Library. David was involved in helping organize this exhibit about the history of our area which will go to other libraries. David is very interested in Bayshore's place in today's world. david.breakfield@mymanatee.org

Linda Noyce, Branch Manager at South County Library announced their after school activities for kids funded by Friends of the South County Library Tuesday through Friday until 4:00 pm. They do activities science experiments, crafts, etc. Contact: linda.noyce@mymanatee.org

Doug Wright was also introduced by Robin. He is associated with the farm 1.5 miles north of the Recreation Center on 26th Street. They have 3.5 acres and offer a community garden and park.

They designed walking trail, fruit farm, meditation area, and urban farm. They take seeds to seedlings with their partner at a Mayaka greenhouse. They are promoting Farm to Table. The programs are 2-3 months long. All farm workers are volunteers. He invited us to drive through. The farm is open. The food is free to those who need it and to the Food Bank. 941-758-3965.

Q. Can we have a prototype speed table placed at the park or on 26th so residents can see how they work?

A. Robin will send question to Public Works

Q. Can a 4-way stop be placed at Harvard /Stanford and Columbia?

A. Robin will send this to Public Works

Q. Can elevated intersections be placed at Bayshore Gardens Parkway and Cornell since the Stop signs are ignored all too frequently. The same happens on 4 Florida Blvd. stop signs

A This will be sent to Public Works. (Restore Bayshore comment: How would a slightly raised slope at an intersection negatively impact traffic if drivers are supposed to be slowing for a Stop anyway?!)

Q. Drainage and canal fill? There are storm sewers feeding the bay without catch basins. Some years ago the situation filled the channel and it was ineffectively cleaned; it helped very little. Does the state have funds to fix the problem? Bryn Mawr canal was ineffectively cleaned.

A. Please send details to Robin with photos and they will be forwarded to appropriate department. (Suggestion: Use something very visible to show depth)

Q. Older communities not having the sidewalks, street lights, etc., have to petition and fight to get them and new communities get them. Why?

A. Current codes mandate that developers provide these amenities in new developments and planned communities. They are Not an expense to county as the developer pays for them. (Comment: Our community did not have these codes in the 50's so we now have to take actions ourselves to get those amenities.)

Crime Watch Minutes

Date: 13 February 2018

Place: Bayshore Gardens Recreation Center Board Room.

Attendance: Steve Watkins, Dan Rawlinson, Jim Couey, Allan Riga.

Call to Order: 7:00 pm by Steve Watkins followed by the Pledge of Allegiance.

Guest: Deputy Chris Ralston from Crime Prevention. There is a new sheriff’s department app available for download. Go to manateesherriff.com and click on Sheriff’s Mobile App. Deputy Ralston reviewed the crime statistics for the period Jan 12 to Feb 10. He stressed the importance of the Homeland Security initiative of “See Something, Say Something”. 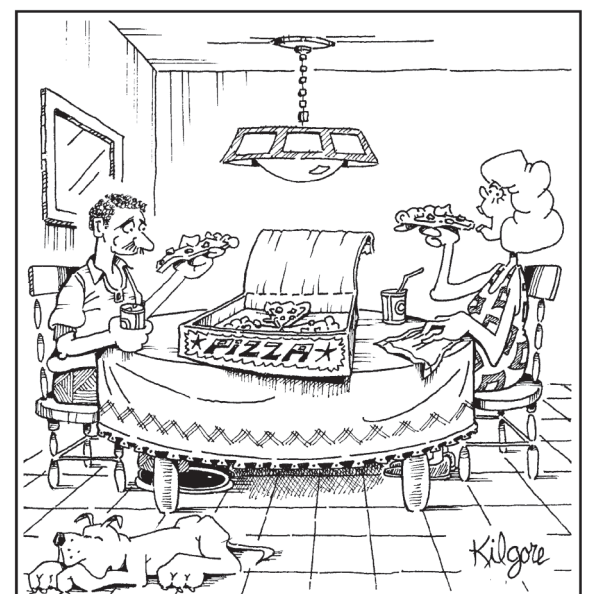

Free Help for a Beautiful, Low Maintenance Landscape: The Florida-Friendly Landscaping Assistance Program

By Susan Griffith, Florida-Friendly Landscaping Program Coordinator

Applying just a few principles from the scientifically-based Florida-Friendly Landscaping Assistance Program (LAP) will help you save money, enhance your landscape, reduce maintenance, and increase your enjoyment of your outdoor spaces.

The LAP brings you together with experienced Master Gardener volunteers and me, the Florida-Friendly Landscaping Coordinator.

We provide advice on plant choices, irrigation, fertilization, pest control, mulching, control of storm water runoff, attracting wildlife, protecting the waterfront, and recycling of yard waste.

Here's how it works:

First, get a soil sample tested at our Extension Service office (1303 17th St. W, Palmetto, FL 34221.) The fee is only \$3 for pH. It costs \$5 if you'd like to include soluble salts; salts are important if you're on a well or near the coast.

How to take these samples? Dig down 6" - 8" in a proposed landscape bed and extract a scoop of soil. Take scoops from approximately five spots in the area and combine them into one sample (only bring a 1-2 cup sample from the composite samples).

If you want to test multiple areas of the yard, do the same for each location and individually identify the samples. Soil samples should be as dry as

possible before testing. Bring in your sample two weeks prior to your consultation (reminder the Extension Master Gardeners' Plant Diagnostic Clinic is closed on Wednesdays.).

Once you have soil test results, call me at (941) 722-4524 Ext. 1825, to schedule your LAP consultation. We will set a day and time convenient for you to come in and sit down with us for an hour and a half. It is useful to bring site plans, photos, ideas of plant preferences, a few technical details about your irrigation system, and any other pertinent details about your yard.

We look forward to meeting you and creating a Florida-friendly yard at your home!

Did You Know ? The March Edition

The Anglo-Saxons called the month Hlyd monath which means Stormy month, or Hraed monath which means Rugged month.

The word 'March' comes from the Roman 'Martius'. This was originally the first month of the Roman calendar and was named after Mars, the god of war. March was the beginning of our calendar year. We changed to the 'New Style' or 'Gregorian calendar' in 1752, and it is only since then when we the year began on 1st January.

The Jewish Passover usually falls on the first full moon after the Northern Hemisphere vernal equinox, although occasionally (7 times every 19 years) it will occur on the second full moon. The Christian churches calculate Easter as the first Sunday after the first full moon on or after the March equinox. The official church definition for the equinox is March 21; however, as the Eastern Orthodox Churches use the older Julian calendar, while the Western Churches use the Gregorian cal-

endar, both of which designate March 21 as the equinox, the actual date of Easter differs. The earliest possible Easter date in any year is therefore March 22 on each calendar. The latest possible Easter date in any year is April 25.

March has two full Moons this year! The first full Moon, the Full Worm Moon, occurs on the 1st at 7:51 pm.. The second, the Full Sap Moon (also a Blue Moon), occurs on the 31st at 8:37 am.

Daylight Saving Time begins on Sunday, March 11, at 2:00 am. Don't forget to set your clocks forward!

St. Patrick's Day is March 17. It falls on a Saturday this year.

The Ides of March falls on March 15, and has long been considered an ill-fated day. Beware the Ides of March!

The vernal equinox, also called the Spring Equinox, marking the beginning of spring in the Northern Hemisphere, occurs on Tuesday, March 20 at 12:15 pm. . On this day, the Sun rises due east and sets due west. In the Southern Hemisphere, this date marks the autumnal equinox. Read more about the First Day of Spring!

According to lore, the last three days of March have a reputation for being stormy. Read about the Borrowing Days.

According to folklore, wear a sprig of rosemary in your hair to improve your memory!

March brings rain and mud! Sprinkle salt on carpets to dry out muddy footprints before vacuuming.

The phrase 'mad as a March hare' comes from the view that a hare will behave oddly during the breeding season, which is in March.

March Madness Munchies

Three Point Popcorn

3 packages (lightly buttered) microwave popcorn
1 1/2 sticks butter, divided
1/4 cup hot sauce
Juice of 1 lime
1/2 teaspoon chili flakes
1/2 cup grated Parmesan
1/2 teaspoon black pepper
Cook popcorn according to package directions. Meanwhile, divide butter into three different microwave-safe containers (1/2 stick in each) and melt. Combine one of the melted butters with the hot sauce and mix well. Pour sauce into the open end of one of the hot popcorn bags, close and shake well. With another melted butter, mix in the lime juice and chili flakes and pour into another bag of hot popcorn. Close and shake well. With the remaining butter, mix with the Parmesan and black pepper, and pour over the popcorn in the last bag. Close and shake well. Serve immediately.

Homemade Seasoned Pita Chips

4 pitas rounds, cut into triangles
3 tablespoon olive oil
1/2 teaspoon kosher salt
1/2 teaspoon ground black pepper
1/4 teaspoon garlic powder
1/4 teaspoon paprika powder
Preheat oven to 400 degrees Fahrenheit and line a baking sheet with parchment paper or silicone baking mats. Arrange pita triangles on the baking sheet. In a small bowl, whisk together the rest of the ingredients. Using a pastry brush, generously brush the tops of the pitas with the oil mixture. Bake for 15 minutes, or until the pita chips are golden brown. Remove and let sit for 5 minutes before serving. Store remaining pita chips in an airtight container.

Seven Layer Dip

1 1/2 pounds ground beef
1 (16 ounce) can refried beans
4 cups shredded Cheddar-Monterey Jack cheese blend
1 (8 ounce) container sour cream
1 cup guacamole
1 cup salsa
1 (2.25 ounce) can black olives, chopped
1/2 cup chopped tomatoes
1/2 cup chopped green onions
In a large skillet, brown ground beef. Set aside to drain and cool to room temperature. Spread the beans into the bottom of a 9x13 inch serving tray that is about 1 1/2 inches deep. Sprinkle 2 cups of shredded cheese on top of beans. Sprinkle beef on top of cheese. Spread sour cream very slowly on top of beef. Spread guacamole on top of sour cream. Pour salsa over guacamole and spread evenly. Sprinkle remaining shredded cheese. Sprinkle black olives, tomatoes, and green onions on top. You can serve this dish immediately, or refrigerate it over night and serve cold. Tastes great at room temperature.

Easy Cheesy Meatball Slammers

36 frozen Italian style meatballs, thawed
1 – 24 oz. jar marinara sauce
6 oz. Provolone cheese, shredded
12 dinner rolls, halved
Preheat oven to 350°F.
In a shallow baking dish, arrange meatballs in one even layer and pour sauce over, coating all the meatballs. Cover with aluminum foil and put in the oven, baking until heated through. Arrange the bottoms of rolls on a baking sheet. When the meatballs are hot, place three meatballs on the bottom of each roll with a spoonful of sauce and top with Provolone cheese. Put back in the oven so the cheese melts. Replace tops and serve.

Bacon Cheese Fries

1/2 package frozen, store-bought french fries (I used Ore Ida)
1/2 cup grated Pepper Jack cheese
1/2 cup grated Colby Jack cheese
2 strips bacon
Green onions, for garnish (optional)
In a frying pan or skillet, cook bacon strips until crispy. Allow to drain on paper towels, then crumble or chop into small pieces. Set aside. Cook frozen french fries according to the package instructions. Scoop fries onto an oven-safe plate. Layer grated cheese and bacon bits over the top of your cooked fries. Set oven to low broil. Stick cheese/bacon-covered fries back in the oven for about 1 minute, or until cheese is completely melted. Garnish with some chopped green onion. Enjoy immediately, with lots of ketchup and blue cheese dressing.

Easy Spinach Artichoke Dip

1 (14 oz.) can artichoke hearts, chopped and drained
1/2 (10 oz) package of frozen chopped spinach, thawed (I used the whole package)
1/2 cup sour cream
1/4 cup mayo
1/4 cup cream cheese
1/4 cup grated romano (can also use packages of Italian cheeses)
1 teaspoon minced garlic
Preheat oven to 375 degrees F. In a small baking dish, mix ingredients. Cover and bake until heated through and bubbly. (About 25 to 30 minutes). Add a bit of lemon juice before serving with pita chips, bagel chips, or crusty bread.
